Questions were asked in regard to the following issues and Councillors advised as to the way forward:

- * Road surfacing in Upbridge and top of Victoria Street which is in a poor state; Councillors explained it was planned for next summer.
- * Concerns from residents regarding road safety in Hepworth and Hepworth Bridge. Road Safety Group is asking Committee to support speed restrictions and signage 'welcoming careful drivers'. Councillors explained that 20 miles per hour zones had been very effective in the past, but was costly; Councillors agreed to discuss this at a future Highways ward meeting.
- * Concerns regarding closure of attended public toilet in Holmfirth. Councillors explained that the considerable budget constraints resulted in cut of public provisions; however alternatives needed to be explored.
