1 Welcomes and Introductions

Committee members introduced themselves. Thanks were recorded to Robert Bamforth for his contribution as a co-opted member of the committee.

2 Minutes of previous meeting

RESOLVED – That the minutes of the meeting of the Committee held on 26 November 2015 be approved as a correct record.

3 Interests

Councillor G Turner declared an other interest in item 8, grant application regarding Skelmanthorpe Library building by Denby Dale Parish Council, as a member of the Parish Council, and remained in the meeting.

Parish Council representative R Brook declared an other interest in item 8, grant application regarding Skelmanthorpe Library building by Denby Dale Parish Council, as a member of the Parish Council, and remained in the meeting.

Parish Council representative M Blanshard declared an other interest in item 8, grant application regarding Skelmanthorpe Library building by Denby Dale Parish Council, as a member of the Parish Council, and remained in the meeting.

5 Deputations / Petitions

No deputations or petitions were received.

6 Neighbourhood Policing Team Update

Sergeant Hayley Marsland and Police Constable Sally Baines gave an update on crime and safety initiatives in the Kirklees Rural area.

Police Officers in the rural team were designated to specific wards. Police Constable Baines gave an update for the Dearne Valley (Denby Dale and Kirkburton). There were some incidents of youths hanging around in different areas. Police Constable Baines undertook to investigate illegal parking on the pavement in Flockton and to carry out speed enforcement checks at the Sovereign Cross Roads.

RESOLVED – That Sergeant Marsland and Police Constable Baines be thanked for their update.

7 Greenspace Service Standards - Rural District

The Committee considered a report by Nigel Hancock, Streetscene and Housing Service which informed of the service standards to be applied to maintenance of parks greenspaces in 2016.

Following a trial of revised standards in 2015 Councillors were consulted on their own wards in the district area. As a result changes have been made. Volunteer groups will be encouraged to work with the Council and there will be a further review of standards in September/ October 2016. Kirklees Natural Wildlife Trust would be working with the Council to ensure that natural areas are clear for people to use, there would be a rigorous maintenance regime.

A ward level breakdown will be sent to Councillors for information. A catalogue will be available of sites where work will be delayed at the start of the season due to the wet weather and risk of damage to machinery.

Where a gold, silver or bronze area is adjacent to a natural area, if it is by properties or facilities the boundary will be mown but if by woodland the boundary will not be mown.

Nigel undertook to look into cutting of brambles on the bank at Shelley Green Meadow and the cutting of hedges in the field at Coal Pit Lane, New Mill (by the Scout Hut).

RESOLVED – That the outcome of the consultation on service standards which will be implemented in April 2016 be noted.

RESOLVED :-

- (1) That the following applications be approved as follows:
 - (a) £30k (revenue £4,661.43 and capital £25,339.57) for streetscene improvement in Holme Valley North Ward, the work done to be reported to the Committee.
 - (b) £19,800 (New Homes Bonus) grant to Denby Dale Parish Council for new doors and windows at Skelmanthorpe Library building.
 - (c) £19,000 (New Homes Bonus) to resurface footpath off Wessenden Head Road, Meltham.
 - (d) £2,500 grant to Kirklees Dementia Alliance to raise awareness of dementia with local communities across the Kirklees Rural district.
 - (e) £2,000 to resurface a section of footpath off Wood Lane, Thunderbridge.
 - (f) £900 grant to Aspire Co-operative Learning Trust for a mobile exhibition for the Life of Wilson project.
 - (g) £800 for speed indicator devices in the Holme Valley North Ward in 2015 – 2016.
 - (h) £350 for Heroes are Welcome stickers for display in shops and organisations in the Denby Dale Ward.
 - (i) £300 for a litter bin on River Street, Milnsbridge.
- (2) That the following decisions be noted:
 - (a) £500 discretionary grant to Marsden Football Club.
 - (b) £500 discretionary grant to Holme Residents Association towards transfer of public toilets.
 - (c) £414 underspend to return to committee budget regarding Marsden Walkers are Welcome project approved on 30 July 2013.

9 Estates and Environmental Works Budget

The Committee considered schemes put forward from the area forum meeting held on 16th December 2015.

RESOLVED - That the following schemes be approved, and noted that the schemes without costings will be put forward to a future committee meeting for decision:

- (a) £14,672 for metal fencing to communal boundaries at Burhouse Court, Honley.
- (b) £4,050 for replacement surface to footpath Lime Grove, Golcar.
- (c) £6,000 for environmental works at Deacon Close, Meltham.
- (d) £7,640 for improvements to fencing at Beech Avenue, Golcar.
- (e) £5,000 to create a green walkway on the Woods Estate, Marsden.
- (f) £8,600 for re-surfacing of lane to rear of Barnsley Road, Flockton.

10 Calderdale and Huddersfield Hospital Proposals for Service Changes

The Chair explained that the Committee's Health Portfolio Group had felt it important that the rural district should have the opportunity to put forward views on how hospital service changes will affect local residents and local communities.

Technically there were not yet any proposals in the public domain as the public consultation has not yet been announced.

Councillor Andrew Marchington provided information on the forthcoming public consultation process, the role of scrutiny and how people could put their views forward. Both Councillors Marchington and Robert Barraclough are members of the Joint Calderdale and Kirklees Health Scrutiny Panel which will look at and comment on the proposals put forward by the Greater Huddersfield Clinical Commissioning Group (CCG). If the Scrutiny Panel does not agree with the proposal it can refer them to an independent adjudicator for final decision.

As part of the consultation process the Clinical Commissioning Group would be holding local roadshows to answer questions and concerns from the public including Shepley, Skelmanthorpe, Emley, Clayton West, Holmfirth, Honley, Meltham and Milnsbridge. Email addresses would be provided to feed in views. The Scrutiny Panel would be holding six meetings in public to look at specific themes as well as two meetings to receive deputations from the public.

There are issues of particular concern to the rural area. Scrutiny has asked the Clinical Commissioning Group for a detailed travel analysis from specific locations and villages to services for users and their families. The impact on neighbouring local authorities will be looked at. The work by Scrutiny will be evidence based. Any views submitted to the consultation should include how the proposals impact on use of services or examples of experiences.

District Committee - Kirklees Rural - 25 February 2016

Points and questions made at the meeting were:

- (a) Will the travel analysis be about clinical impact only or include a broader impact on the local economy and whether more transport resources will be needed. The Ambulance Service will be consulted and asked how they will deliver to rural areas.
- (b) If there are more car journeys to services will the impact on congestion and air pollution be taken into account.
- (c) How will the “golden hour” in which to treat people be met from parts of the rural area like Denby Dale and Kirkburton if it is rush hour traffic.
- (d) Strokes cannot be treated in ambulances, people need to get to hospital to get the right drugs and time is important.
- (e) Similar questions had been asked of maternity services a few years ago, people were now going to Barnsley and Wakefield instead. In Kirkburton residents travel to Dewsbury, what is the impact there. The Joint Dewsbury and Wakefield scrutiny panel is looking at that.
- (f) Will ambulance service bases change so that travel works across the region and there needs to be consideration of Kirklees as a unit.
- (g) The parking of ambulances at Calderdale Hospital is a concern .
- (h) Bad weather or an accident on the M62 causes widespread grid lock, how will emergencies at these times be dealt with.
- (i) What will be the impact on elective surgery.
- (j) Ambulance response times to Holmfirth have not managed to meet the eight minute time limit for a number of years, how will they manage with the extra distances.

It was noted that the full Council meeting will discuss the proposal on 16th March 2016.

RESOLVED – That local residents be encouraged to feed their issues directly into the public consultation with evidence, that the issues raised in the meeting be forwarded to Scrutiny and that a representative from the Greater Huddersfield Clinical Commissioning Group be invited to the next meeting.

11 Public Question Time

The Committee was asked whether it has a view on the location of the proposed skate park in Highburton. Councillor Taylor gave a response.

The Committee was asked whether it monitored local lighting issues. Councillor Taylor responded that he is monitoring the issue raised in Highburton.

12 Date of Next Meeting

The date of the next meeting of the Committee on 24th March 2016 at 7pm was noted.

1. Purpose of report

To advise councillors of the funding arrangements for these proposals. For the District Committee to consider funding from District Committee budgets.

2. Key points

- Kirkburton Ward Councillors, residents, and businesses have raised their concerns about carriageway conditions on a number of streets in the ward.

- Officers from Streetscene and Housing have visited various sites, consulted with Ward Councillors and will reassess these sites after the winter period.
- To maintain a greater degree of flexibility and to be able to address these sites in a logical and deliverable way we will need to discuss further with Ward Councillors the other planned programmes of works for the ward.
- Councillors Bill Armer, Robert Barraclough and John Taylor have asked that officers prepare a quotation for these works.
- Officers propose that the necessary works can be carried out using available district committee funding of £12,380 capital and £3,000 revenue and that these works be carried out after the end of the winter period.
- The works will be funded from the Kirkburton Ward allocation of District Committee budgets
- Kirkburton Ward Councillors previously agreed for similar works to be funded from their devolved area committee and ward budgets.

1. Purpose of report

To consider an extension to the Citizens Advice Bureau (CAB) outreach service in the Denby Dale ward for a 12 month period, 1st April 2016 to 31st March 2017.

2. Key points

2.0 In addition to the current Advice Contract funded by Kirklees Council the district committee has funded outreach sessions in the Denby Dale ward for the last 5 years. The Council's contract provides for an advice service across Kirklees via the telephone advice line and for face to face appointments in Dewsbury and Huddersfield centres.

2.1 An outreach service in Denby Dale ward provides for an adviser being available once a fortnight, on Wednesdays 10 am to 1 pm for appointments with clients at Skelmanthorpe library.

2.2 Clients contact the telephone advice line service and receive an initial assessment. If an appointment is required and the client is based in the Denby Dale area they are offered the next appointment at the library. Clients usually have a 45 minute appointment slot although double appointments can be booked for form filling etc.

2.3 Quarterly reports on progress are made to the Denby Dale ward councillors on the numbers using the service and outcomes.

2.4 Monitoring information 2015/16

For the period April to December 2015:-

- 19 outreach sessions have been delivered
- 41 people have been helped

The main enquiry area tends to be benefits but other issues CAB has offered advice on include; housing, debt, consumer, employment and health.

From April 2013 to February 2016 (just less than 3 years) CAB has helped over 126 clients in the Denby Dale area at a cost of £11,188. This amounts to £89 per clients. The amount of income gains for those clients averages at £683 per client per annum.

2.5 Costs

One session per fortnight held at Skelmanthorpe Library will cost £4,475 in 2016/17. This is the same cost as 2015/16.

3. Implications for the Council

The proposal meets the Council priority of social action, supporting people to take actions for themselves. There is inequality of access to advice for people living in the Denby Dale ward compared to the average across Kirklees.

4. Consultees and their opinions

The Denby Dale ward councillors are proposing to continue funding this provision in 2016/17 on the same basis as in previous years.

Kirklees Revenues and Benefits Service has been informed of the proposals.

1. Purpose of report

To consider a grant application for £2,250 from Shepley Spring Festival Ltd towards its audience development project for the 2016 Festival.

2. Key points

2.0 The Shepley Spring Festival is an annual event of traditional music, song and dance which attracts over 3,000 people. Since its inception in 2007 the numbers of local people involved with the event has continued to increase.

2.1 This year the audience development project aims to appeal to a broad audience to engage local visitors who otherwise might not attend the festival in particular older people and teenage/ young adults. Four acts are being invited aimed at these groups as well as planning advertising to these groups and selling tickets at a low price. The project will offer local residents social events to participate in within easy reach at reasonable cost. Tickets will cost from £5 each. Concession tickets are available to disadvantaged adults and all accompanied under 16s go free.

2.2 The acts are A Day's Work, a folk opera commemorating the centenary of the Battle of the Somme in 1916, Skelmanthorpe Brass Band, Elephant Sessions and the Sam Kelly Band (Sam was a finalist on Britain's Got Talent).

2.3 Local people are involved in the festival's community choir, take responsibility for litter collection, organise fund raising stalls, help as volunteer stewards, host festival artists, advertise the event, sell tickets and make refreshments. Parents of younger children are involved in children's activities. The Festival Committee is working with a number of other groups in the area to increase their involvement and ownership of the event.

2.4 The audience development project will be advertised locally in particular in villages in the Denby Dale and Kirkburton area.

2.5 Timescales

The festival will start on Friday, 20th May and run for 3 days.

2.7 Benefits

The event generates extra income for local businesses over the week-end including campsites and B&Bs, shops and pubs. Local suppliers provide £20k of goods and services including marquees, showers, toilets, fencing, skips, sound and lighting. Previous evaluations of the festival have shown that some visitors use the event as a base for an extended holiday in the area. Links to local attractions are provided at the festival and via the festival website. Local businesses advertise the souvenir programme and several home based businesses bring stalls to the Craft Fayre.

3. Implications for the Council

The group is registered with the Council's Grant Access Point. The application meets the Council's priority of supporting communities to do more for themselves and each other and has a positive impact on the local economy.

The district committee/ former area committee has funded elements of the festival in previous years 2013, 2011 and 2010. The festival is also funded by the Council's Creative Economy Team community events grants. The festival is monitored by the Team which carried out an evaluation of the 2015 event.

4. Consultees and their opinions

The festival is held in a marquee on land off Marsh Lane, Shepley. The permission of the landowner and Shepley Church has been given.

The Council's Creative Economy Team has commented that, for an audience development project, they would expect to see some specifics on how the target audiences will be reached, has any work been done with these audiences? Programming a range of acts does not necessarily lead to future sustainability. The applicants have provided a plan of development work which will be done with local communities.

Councillor John Taylor is supportive, "the festival has grown over the 10 years it has been going and is well established both locally and nationally and there is a wonderful atmosphere when the festival is here".

Historically the hanging baskets have been supplied by Kirklees Bradley Nurseries and due to a market testing and best value exercise that has been undertaken, First Impressions will be supplying and maintaining the baskets in 2016.

Kirklees community groups, Parish Councils and District Committees can purchase baskets from First Impressions under the same framework of providing for the green space Gold standard requirements.

The baskets are £60 each which includes the planted basket, delivery, installation, maintenance, watering throughout the season and taking down. Watering will be carried out at a minimum of weekly intervals and additional watering may be required during periods of hot dry weather. The hanging basket containers hold a reservoir of water and the compost also contains a water retaining medium to reduce the risk of drying out.

In this economic climate it is important to retain the floral decorations that help to create welcoming and colourful Kirklees towns and villages which builds the confidence of businesses as well as continuing to attract visitors and shoppers.

1. Purpose of report

To consider a grant application from the Friends of Churchfield for £1,000 revenue towards rebuilding a section of a stone wall at the corner of Barnsley Road and Bank Lane, Denby Dale.

2. Key points

2.1 The Friends of Churchfield is a group of volunteers who work with the Denby Dale Parish Council Countryside project to maintain a hectare of scenic open space in Denby Dale. The group has a Heritage Lottery Fund grant to improve the habitat for native species of birds, animals and plants, and to make the space accessible for community use. A corner section of the perimeter wall on to Barnsley Road has collapsed.

2.2 The lottery grant is being used to plant a coppice, fruiting trees, wild flowers and to erect bird and bat boxes. Gates and picnic tables are being installed for disabled and pushchair access. Plans include a professionally designed website and interpretation boards about the biodiversity and history of Churchfield with a view to encouraging more community use.

2.3 The lottery grant provides for professionals to run walling courses for local people to undertake general maintenance but does not support the work involved in rebuilding the collapsed wall.

2.4 The work to rebuild the stone wall will involve volunteers who regularly work on the land. They will assist the local professionals and add to their skill set for maintenance of the field and its walls in future to ensure that they do not need to be rebuilt.

2.5 The wall rebuilding is part of a year long project to improve local wildlife habitat and actively involve local residents. The group has 70+ members of which 12 are actively involved in planning and delivering the project. The rebuilt wall will enhance the appearance of this entrance into Denby Dale on the Barnsley Road and increase pedestrian safety (drop of levels into field) on a busy junction.

2.6 Cost breakdown

Six volunteers from the group will help with the rebuild by sorting, grading and stacking stones as well as prepping the foundation mixes. They will observe and learn aspects of building. This will be 6 hours of planning and 24 hours+ of work.

2.7 Timescale

The work will be done in May 2016. Once repaired the wall should stand for another 100 years.

3. Implications for the Council

The application meets the Council's priority of supporting communities to do more for themselves and each other. The group is currently going through the Grant Application Registration process with the Council. The district committee contributed funding of £5k in February 2015 to the resurface of a footpath at Churchfield.

4. Consultees and their opinions

The work has been planned in conjunction with the Denby Dale Parish Council Countryside Officer and Denby Dale Parish Council which manages the land on behalf of Kirklees Council.

The Countryside Officer has confirmed that the wall is owned by Kirklees Council but a lease agreement is close to being signed which will mean that the management of the site will rest with the parish council for the next 25 years. The agreement is that the parish council will have responsibility for the site and the Friends of Churchfield will manage the majority of the site for public access.

Ward councillors have been informed of the application.

Kirklees Highways has been informed of the application as the wall is adjacent to the highway.
