#### 1 Welcomes and Introductions

The Chair welcomed everyone to the meeting and Councillors introduced themselves.

#### 2 Minutes of previous meeting

**RESOLVED –** That the Minutes of the meeting of the Committee held on 29<sup>th</sup> September 2016 be approved as a correct record.

#### 3 Interests

Councillor Bill Armer declared an other interest, as a member of the Kirkburton Parish Council in the grant application by the Parish Council for hanging baskets, and remained in the meeting.

#### 4 Admission of the public

It was agreed that all items would be discussed in public session.

#### 5 Deputations / Petitions

No deputations or petitions were received.

#### 6 Natural Flood Management in Leeds City Region

Guy Thompson, Kirklees White Rose Forest Project Manager gave a presentation on the role of natural flood management and the work that is starting with Yorkshire Water through the West Yorkshire Nature Partnership to create natural barriers, and to work with all landowners.

#### District Committee - Kirklees Rural - 22 November 2016

Guy explained that tree coverage in West Yorkshire is low at 7.9% and the region's economic strategy is that it has to increase. Since the year 2000 1.2 million trees had been planted, an extra 6 million was required over the next 20 years. In the rural areas there was a lot of over grazing by sheep compacting the soil and preventing woodlands and rough grass from growing. This allowed water to flow quickly to water courses which contributed to the risk of flooding.

The approach was to slow up water and make space for it, which can reduce peak flows by 4 - 10%. Trees slow the time it takes water to run into the ground and can be used to create leaky dams. Interventions include planting woodlands and creating wetlands on the moors, taking care not to interfere with wildlife habitats.

A capital funding plan is in place with the Natural Trust and Yorkshire Water regarding water quality and retention and creating an area of conservation in the Holme Valley and Wessenden catchment areas. Funding would also be sought from the Local Enterprise Partnership.

There is an opportunity to work with small landowners if they are interested. This message needs to get out locally. Changes to farming subsidies in the next few years would mean more control over sheep grazing.

It was noted that the Local Authority has a role to play in managing drains and ensuring that natural springs are not damaged as part of the Planning process.

It was commented that the opportunity to pilot some innovations locally ought to be taken and trees should be regarded as having an economic value when determining flood prevention costs.

**RESOLVED** – That Guy Thompson be thanked for the presentation.

#### 7 Winter Maintenance

The Committee received an update on the Council's approach to winter maintenance in 2016-2017, which was unchanged from the previous year.

A number of questions were raised and will be forwarded to Kirklees Highways for response:-

- (i) As we cannot provide any more grit bins, can we require applicants to include them in Planning applications for new estates particularly those on hill sides?
- (ii) We are told there is a night patrol, can gritters be sent out on a case by case basis targeting areas where there is snow, for example when there is snow on the tops only?
- (iii) We have a priority gritting route which has a bad junction, the Council makes provision for the grit. Every year vehicles get stuck because there is not a community group or farmer who can help. So how can we help to provide the grit?

(iv) Regarding differential gritting of heights (the tops rather than the town centres in the valley bottoms). In the past we have been told it is too "problematic", at the last meeting we were told it is now at the stage we can do it. So can we now do demand based gritting of the upper hills?

#### 8 District Committee Budgets

The Committee considered a number of proposals for funding.

**RESOLVED** – That funding for projects be approved as follows:

- (i) £570 revenue grant to Milnsbridge Enhancement Group towards the repair of steps to the riverside walk.
- (ii) £950 revenue for traffic investigations at St Mary's Mews, Honley and £180 revenue for a speed count on Mill Moor Road, Meltham, total £1,130
- (iii) £1,500 revenue grant to Kirkburton Parish Council towards the cost of hanging baskets in Summer 2017
- (iv) £12,400 revenue to purchase a new Speed Indicator Device (SID), for 2 sockets and 24 moves in the Colne Valley Ward
- (v) £7,101 revenue and £2,499 capital (total amount £9,600) for 24 moves for the Speed Indicator Devices (SID's) in the Holme Valley North Ward
- (vi) £1,100 revenue to install 5 sockets and for 24 moves of the Speed Indicator Devices (SID's) in the Kirkburton Ward

#### 9 Community Projects - Feedback

- (v) Wessen Court, Marsden replace flagged area with tarmac, bench, and artificial grass £7,800
- (vi) Deacon Close, Meltham plant trees and shrubs to design out dog walking area £9,000
- (vii) Various addresses retirement living schemes £68,000
- (viii) Barnsley Road, Flockton clear shrubbery £12,350

#### 11 Public Question Time

A question was asked about concerns raised in the community about the Council's new approach to dealing with waste, how the new rules are being implemented at the local tips and concern that more restrictions will be introduced.

Councillors responded and updated on the questions they have asked at the full Council meeting and raised with the Cabinet Member for Housing and Enforcement Management. Members of public are asked to raise any particular issues direct with ward Councillors.

A question was asked about an increase in fly tipping. Councillors responded and asked that people report any incidents to the Council.

#### NOTES

#### **Disclosable Pecuniary Interests**

If you have any of the following pecuniary interests, they are your disclosable pecuniary interests under the new national rules. Any reference to spouse or civil partner includes any person with whom you are living as husband or wife, or as if they were your civil partner.

Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner, undertakes.

Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses.

Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority -

- under which goods or services are to be provided or works are to be executed; and
- which has not been fully discharged.

Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.

Any licence (alone or jointly with others) which you, or your spouse or your civil partner, holds to occupy land in the area of your council or authority for a month or longer.

Any tenancy where (to your knowledge) - the landlord is your council or authority; and the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.

Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and (b) either -

the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or

if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

# Agenda Item 7

#### Feedback on Honley Christmas Lights event

#### Project

Honley Business Association held a Christmas lights switch on event on 19<sup>th</sup> November 2016 for the 4<sup>th</sup> year in a row. This included stage entertainment, a Santa Parade and fireworks display.

#### <u>Cost</u>

The total cost of the project was £6,193 for trees and lights, insurance, publicity, park and tent hire, entertainment and volunteer expenses. A grant of £1,000 from the district committee went towards the costs.

The project costs increased with the installation of additional lighting on Church Street/ Westgate and DJ costs were more. A grant from the Big Lottery of £3k was used to hire a cherry picker, enabling the investment in the lights infrastructure. A grant of £1,000 from Holme Valley Parish Council allowed for the purchase of larger trees. The Association contributed £2,000 from its own fundraising.

#### **Volunteers**

82 volunteers installed the lights and 110 trees throughout the village. They built up tents, furnished the grotto, provided cakes and biscuits to sell, manned the drinks tent and the grotto. Over 30 volunteers manned the Santa Parade, were first aiders, litter pickers and general supervisors. Total volunteer hours 1,020.

#### **Beneficiaries**

There were over 3,000 visitors to the event. The purpose of the event was to encourage the local community to use local businesses. It was a resounding success with the community getting behind it. The event created a great community vibe making everyone proud of the village. Feedback throughout the Christmas period from local people was very positive.

#### **Evaluation**

A debrief has taken place with the volunteers. Feedback was that the event was fabulous and there are some suggestions for improving it. Future events will need more volunteers involved at the early stages of planning as this is very time consuming for the committee. The events contribute to cohesion between the local community and local businesses; shops and business premises in Honley are never vacant for long.

#### What next?

Three events are planned for 2017; Honley Feast in September, Christmas Lights Switch on in November and a Christmas Street Market in December.

A website is being launched for local business collaboration, fundraising is continuing for CCTV and a fourth defibrillator for the village.

#### Feedback on Holmfirth Christmas Lights event

#### Project

The Holmfirth Christmas Team installed an external Christmas lights display in the town centre and held a switch on event and community parade to make the town more attractive to residents, visitors and businesses during the festive season.

#### <u>Cost</u>

The total cost of putting up the display was £9,565 for plugs and lights, installation, repairs, insurance, publicity, trees, hooks and fixings. The £1,000 grant from the district committee contributed to the capital purchase of plugs and lights.

Due to successful fundraising additional lights were purchased (265 strings were put up), more brackets were purchased and slightly fewer plugs were needed, saving £580 on the cost of an electrician.

£9,000 was raised from local businesses (147 businesses) and the local community. Holme Valley Parish Council gave a grant of £2,000. The cherry picker was provided free of charge by a local business and a local resident donated batteries to power additional lights in public areas.

#### Volunteers

5 volunteers on the committee spent between 100 and 150 hours each fundraising, planning and putting up/ taking down the lights. A team of 20 volunteers spent 8 hours each putting up and taking down the lights and trees.

These volunteers also organised a celebration event on 26<sup>th</sup> November, which was supported by many more volunteers making lanterns at workshops/ with local schools, stewarding the parade and providing entertainment.

#### **Beneficiaries**

18,000 residents of the Holme Valley and visitors. Positive feedback and a huge number of compliments were received orally and on social media for example –

"Holmfirth looks absolutely beautiful with these decorations. Thank you!!"

It's the best I've seen the Holmfirth lights look for a long time. Simple but very effective."

*"I have a grin on my face every time I drive through and have even walked the long way round to enjoy more of them! Huge thank you to everyone involved."* 

#### **Evaluation**

The project was a great success, encouraging the community to work together to make Holmfirth look lovely. The town looked co-ordinated and festive. Local businesses and residents got involved and were enthused. Some great volunteers came forward to assist.

Those taking part were very positive about how it was organised and the quality of the project. The volunteers who had not been involved before all agreed to help in future. Despite the terrible weather when putting up the lights there was a real team spirit. *"It's been great to volunteer and meet lots of people I didn't know before. Lots of laughs along the way too!"* 

The Committee has found that there are many businesses in Holmfirth who are willing to help make the town look better. Key to success is persistence and having a small team to make decisions and plan thoroughly for example measuring every stretch of building to work out how many lights were needed. Putting a new infrastructure in place is time consuming with many stakeholders to speak to and listen to, starting early in the year.

#### What next?

Planning for 2017 lights will start early in the year. The same string of lights will be installed and seeking to extend them along more public areas and in a few more business areas. Cross street professional festoon lighting on Victoria Street will also be considered.

#### Feedback on Milnsbridge Village Hall Christmas lunch

#### Project

For the second year in a row Milnsbridge Community Trust provided a Christmas lunch and entertainment at the Village Hall for those who would otherwise be on their own, the elderly, infirm and with mental health issues.

#### <u>Cost</u>

The total cost of the lunch was £1,508 for food, ingredients, crackers, equipment and kitchen improvements. The district committee grant of £205 was invested in new pots and pans for the kitchen which will be reused at future events. Fundraising and donations in cash and in kind contributed to the event. Donations included the turkey crowns, Christmas cake, presents, a magician and a singer.

#### **Volunteers**

25-30 volunteers contributed over 200 hours. They helped to decorate and prepare the room and with shopping. They prepared, cooked and served the food, as well as clearing up and cleaning. Also providing transport and entertainment for those who attended. Plus some administrative work.

#### **Beneficiaries**

Sixty people attended the lunch, their feedback from them on the day was very positive.

#### **Evaluation**

The aims of the project were achieved and the careful planning paid off. People have been very generous in giving their time and making donations.

#### What next?

The improvements to the kitchen and the new equipment will mean that the Village Hall can deliver other projects for the local community as well as next year's Christmas lunch.

## Feedback on Clayton West Cricket Club equipment

#### Project

The replacement of ground machinery with a new mower and repair of an outfield mower to improve the quality of ground maintenance at the Club.

#### <u>Cost</u>

 $\pounds$ 5,250 in total was spent on a new cricket wicket mower and full refurbishment of the existing outfield mower. The club received a grant of  $\pounds$ 3,500 from the district committee and contributed  $\pounds$ 1,750 from its own funds.

#### <u>Volunteers</u>

Seven club members were involved in the purchase and transporting of the new equipment.

#### **Beneficiaries**

Up to 150 playing club members; 40 adults and 80 -100 children will benefit directly. The groundsman is over the moon! People connected with the club are delighted at being able to purchase machinery that will last for many years to come. The purchase will contribute to the sustainability of the club at what is a very uncertain time.

#### **Evaluation**

The purpose of the project was to replace broken ground machinery, therefore make significant improvements to the quality of the wicket including artificial square and outfield on which adults and children play. The quality of the ground maintenance will be significantly enhanced compared with the current standard. This improvement will be noticeable at the start of the 2017 season.

The club will no longer have to spend £300 - £500 per year fixing the broken machinery.

### What next?

There is likely to be fundraising in future for new heating systems at the club.

## Aspire to Play Toy Library

The Aspire Cooperative Learning Trust was delighted to receive a grant from the Kirklees Rural District Committee to fund a Toy Library for our Trust partner schools.

A lot of preparatory work has been undertaken by the school library manager to purchase and record the stock of toys and to create a loaning system that can be replicated in each of our Trust partner schools. We have undertaken a training session with staff plus parent and student volunteers who will run the library each week. We have 9 students who are using the experience of running the toy library at Luck Lane to fulfil their commitment for their Duke of Edinburgh award and a mum of children at the school who has stepped forward to manage the weekly library sessions. Further volunteers will be recruited in each of the schools as their library is launched.

Each child who wishes to join is issued with a library card and the parent is asked to sign the terms of agreement form. It's quite simple; from there on they can borrow a toy for 50p each week and return the week after. If the toy is not returned a reminder of the terms of agreement is sent home stating that the RRP will be charged if the toy is not returned. This ensures that the system runs smoothly and that the stock does not diminish. We do have a number of children who due to circumstances are not charged.

The Toy library is fully operational at the new Luck Lane Primary School and has over 70 members with 9 secondary students and one parent volunteer managing it on a weekly basis. The toys are put on display in the hall after school, the student volunteers promote the library in the playground and the children and parents come along and choose a toy together. With an increasing selection ranging from family games, jigsaws, pirate ships and dolls houses to garages and Lego we have tried to cater for all children and selected toys that can be enjoyed as a family. We have many children attending on a weekly basis, returning one toy and selecting another to enjoy over the weekend. The look on their faces as they leave the hall carrying their chosen toy shows how much this means to them. It's like Christmas every week!

Our intention is, not for the Toy Library to be a profit making enterprise, but to provide fair access to good quality, robust toys. However, by charging 50p each week we will be able to sustain the club into the future as this gives us the scope to restock and replace tired toys.

The library is promoted in our newsletters and on school displays acknowledging the generous support of the Kirklees Rural Committee (as the logo above). All our promotional and registration documents also acknowledge the support of the Committee to who we are extremely grateful.

Our intention over the next couple of months is to extend the library into all our Trust partner schools that are all waiting in eager anticipation for their first delivery of toys. The joy of learning through play will be spread across the Trust and we believe will enable the families that are associated with our schools the opportunity to enjoy many happy hours of play and interaction.

We would like to sincerely thank the Kirklees Rural Committee for enabling our children and families access to a wide range of educational and recreational toys that support learning and strengthen the role of parents as first educators.







# Agenda Item 8

## Briefing Note - Consultation for Huddersfield Narrow Canal - 13<sup>th</sup> February to 12<sup>th</sup> March 2017

There are plans to improve a stretch of the Huddersfield Narrow Canal towpath, approximately 4.6km between Longroyd Lane in Huddersfield and Low Westwood Lane opposite Titanic Mills.

The improvements are an element of the Canals project, a programme of works across West Yorkshire being delivered as part of the second phase of CityConnect, in partnership with the Canal and River Trust.

Public consultation for this scheme will take place for four weeks. Local people will be invited to give their feedback on proposals which will include improvements such as;

- Resurfacing using a combination of bound surface and self-binding aggregate to improve poor drainage and water erosion. This will result in a path which will allow people to use it all year round.
- Widening the towpath where possible the width of the towpath will be increased to allow people to pass comfortably.
- Cobbles the cobbles around locks and bridges are a heritage feature of this unique trans-Pennine route, at some locations where they have become uneven or worn they will be relaid and re-pointed to make towpath more accessible.
- Improved Signage a bespoke suite of signage will be created for the canal. It aims to promote positive user behaviours and warn of areas where extra care is needed.

Upgrades to the towpath will provide local communities with a convenient option to travel away from the roads for utility, employment or leisure. CityConnect is committed to improving cycling routes around West Yorkshire and is working towards the vision of West Yorkshire being recognised as a great region for cycling.

During the consultation there will be three public consultation events; people are invited to come and view the plans, meet the CityConnect Team and the Canal and River Trust designers and leave their feedback.

For the first time there will be a live Twitter consultation <u>@CityConnect1</u>. People are invited to join in and give their views. The CityConnect team and designers from the Canal and River Trust will be online to answer questions.

#### 1. Purpose of report

The Committee is asked to consider a contribution of £4,188.53 capital towards the refurbishment of the Golcar library garden.

#### 2. Key points

**2.0** The Friends of Golcar Library plan to refurbish the garden, path and patio area to create disabled access and to replace the worn and uneven patio with a disabled friendly surface. The space is approximately 500m2.

- 2.1 The garden will be used for activities linked directly to Golcar Library such as story time, picnics, family activities (The Big Lunch) and initiatives to combat social isolation among the elderly. It will also be available for formal and informal groups in the wider community to use.
- **2.2** Currently 1,350 people per month use Golcar Library and it is anticipated that this development will increase that number. The project will enhance the environment and provision of greenspace in the local community and help groups to be more socially inclusive.
- **2.3** The work will be done by Kirklees Council Parks, Open Spaces and Street Cleaning Development Team. The quote provided by the team is:
  - To do the top area of the garden, remove slabs and stack up, lay rubber crumb surfacing in black £ 2,418.58
  - Ramp construction and new curving pathway to gated entrance with timber edges and crush stone surface 1.2 metre wide £ 3,270.00
  - Total £5688.58

## 2.4 Cost Breakdown

A grant of up to £1,800 has been secured by the Friends of Golcar Library from the Co-operative Retail Society towards the project. The actual amount will be known when this round for community projects closes.

## 2.5 Timescale

It is expected that the work will start in April 2017 and take 4 weeks to complete.

## 2.6 Volunteers

The hard landscaping would all be done by the Council team. There would be scope for volunteers to add to the project in the building and planting raised beds etcetera but this would be seen as a future phase of the project. The initial funding would be for the hard landscaping of the patio area, ramp access and path down the garden area.

### 3. Implications for the Council

The approval for the work on the Library site comes from Robert Crossland, Asset Management Officer, Place (Physical Resources & Procurement)-

In principle we don't have any objections to what is being proposed, however please bear in mind:

- The land remains in the Council's ownership and under the control of Physical Resources and Procurement.
- The group undertaking the work is responsible for all aspects of Health and Safety and for management of the scheme.
- Any "investment" by the group does not give any additional rights above current arrangements.
- If there is a review in the future the group may lose its investment.
- Access to the vacant first floor flat will need to be maintained.

The application meets the district committee criteria of Place; communities looking after local assets for all to use and enjoy and Health and wellbeing.

#### 4. Consultees and their opinions

Kirklees Library Service is supportive of the proposal.

Andy Wickham, Volunteer Co-ordinator Streetscene and Housing is supportive.

#### 1. Purpose of report

To consider a grant application by Golcar Together for £345.50 revenue contribution towards the Weaving Women's Wisdom project.

#### 2. Key points

**2.0** Golcar Together has brought together a group of women of different faiths and no faith to weave small rugs together which illustrate a picture of their joint vision. This follows an idea launched by the Touchstone Interfaith project in Bradford and taken up across the country.

- 2.1 The 450 x 900 mm rugs will be made using the shared skills of the rug makers. The expectation is that the women will share their life experiences and their faith over the duration of the project which will last about 6 months. The voices of the women will be digitally recorded and will be given to the Kirklees Library Service and to the Colne Valley Museum as part of their record of local history.
- **2.2** The project will be based at the Colne Valley Museum in Golcar with a core group of around 12 local women who will undertake production of the rugs. The project aim is to build local friendships across ethnic and religious divides and it will promote community cohesion. Many of the core group will live in Golcar Ward, others will come from the wider Huddersfield area.
- **2.3** Golcar Together has approached representatives of the major religions in the area to let them know about the project and ask them if they have any interested participants. They have also approached other local non-religious organisations to ask the same question. The invitation process is ongoing. Ten volunteers have come forward so far. The facilitators Touchstone believe from their experience that the optimum number is 8 for a single rug. If 12 women are interested then the suggestion is that they make 2 rugs. Examples of rugs made from other areas –

An application for £345.50 has been made to the By and Buy Community Shop in Golcar for 50% of the cost. The decision on funding will be made on  $13^{th}$  March 2017.

The digital recorder will be lodged with Colne Valley Museum for their safekeeping at the end of the project. The museum will use it for memory recording and it will be available to groups on request.

The grant application has been put together on the basis that all the items are bought new. It is likely that the wool and/or rags can be sourced locally at no expense. It may be that the needles, ancillaries and hessian canvass can also be obtained from participants.

#### 2.5 Volunteers

Touchstone believe that the number of volunteer-hours for a single 450x900mm rug is likely to be around 100 hours.

## 2.6 Timescale

The project will take place from April to October 2017.

## 3. Implications for the Council

The group's Grant Access Point registration with the Council is currently being renewed. If the grant is approved the group will enter into a grant agreement with the Council.

The application meets the district committee priorities of Place, communities looking after local assets for all to use and enjoy.

## 4. Consultees and their opinions

Colne Valley Museum has welcomed this project and believes that it forms an important part of its outreach to the wider community as well as being a valuable addition to its collection of local history. The museum has agreed to host an exhibition of rugs from across Yorkshire in January 2018.

## 1. Purpose of report

To consider £600 revenue funding for the redesign of the car park at Cliffe House, Shepley in order to increase its capacity and the safety of adjacent roads.

## 2. Key points

#### **Background**

**2.0** Councillor John Taylor is working with staff at Cliffe House to resolve a parking problem which is causing some road safety concerns on Cliffe Road and Lane Head Road, Shepley. Since some additional services have been moved into Cliffe House and the usage has increased the car park has proved inadequate.

As a result cars are parked on the narrow road outside and also more dangerously on the main A629 just adjacent to the entrance to Cliffe Road.

This is also causing some problems with schoolchildren accessing the site as they often arrive by coach. There have been instances when the coach is stuck as it cannot access the site because of the car parking outside of Cliffe House.

- **2.1** It is proposed that the car park be redesigned to increase capacity. Kirklees Highways has recommended local company Alpha Marking Services Ltd undertake the work.
- 2.2 A quote for £600 (excluding VAT) has been provided to reconfigure the car park. This should provide an additional 10 spaces, an increase from 22 to 32. A sketch of the existing and the proposed layout is attached at appendix 1. 30 spaces are set out on the plan with another 2 to be included.

#### 3. Implications for the Council

The proposal meets the district committee's priority of Place and Streetscene issues, local assets being looked after for all to use and enjoy.

#### 4. Consultees and their opinions

Kirklees Highways Service is supportive.

Kirklees Corporate Landlord has been consulted on the proposal and has no objection.



#### 1. Purpose of report

The Committee is asked to consider a grant application by the Friends of Honley Library for £1,000 towards the Honley Children's Book Festival 2017.

## 2. Key points

**2.0** The Friends of Honley Library runs activities during the school holidays for children from birth, focussing on children and families who do not use the library. The programme provides opportunities for literacy and enjoyment of books through affordable, enjoyable activities in the library.

- 2.1 Last year's festival included puppet making, "Shark in the Park", Babies into Books, craft workshops, Little Elves, Story Sacks, and author visits (creative writing and a poetry workshop). *The proposed programme for 2017, from February half term through to Christmas, is attached.* Most of the events will take place at Honley Library, some will be outdoors at Honley Woods and the People's Park.
- **2.2** Last year's summer book festival was popular, 112 adults and 156 children benefited and were mostly Honley residents. A summary of the evaluation is attached. The programme has an established reputation and the good will of the local community. The group works with local schools and playgroups to recruit participants. It is anticipated that an extended programme in 2017 will increase the number of participants to around 300 adults and 300 children. High school age young people and children with special needs will be included this year.
- **2.3** Monitoring information on the impact of the programme is collected including new library members. For example increased use of the library especially by families for which schools receive the pupil premium, increased confidence of the children and difference it makes on their achievement at school. The programme aims to use local businesses wherever possible. It has resulted in more people volunteering at the library.

## Key Points from Evaluation of Honley Children's Summer Book Festival 2016

Evaluation forms were distributed and collected at last year's book festival events.

Participants are asked to answer seven questions. We ask for information about how the children enjoyed the event, rated on a scale of 0-5 with 5 being very much and 0 being not at all. We also asked about frequency of visits to the library; whether it was a first time visit; and whether attending the event encouraged more frequent visits to the library. The last questions ask what future events participants would like to see, and ask if anyone would like to volunteer or offer support of the library in other ways.

The events run in 2016 were attended by a total of 156 children and 112 adults:

- 'Shark in the Park' an interactive story-telling event attended by 38 children and 26 adults.
- in Honley People's Park, with treasure hunt and games

- **Babies into Books** encouraging parental confidence in introducing books to babies. 27 adults and 25 children attended. It was the first visit to the library for five people and nine people joined the library as new members.
- Puppet-making attended by 9 adults and 17 children
- Story sacks attended by nine adults and 16 children
- Author visit with Alan Gibbons for 8-11s : an interactive workshop on creative writing attended by 11 adults and 19 children
- Author visit with Conrad Burdekin poetry workshop in October 2016 for 4-8 year olds. This was attended by 11 adults and 17 children
- Little Elves workshop (pre-Christmas event) attended by 24 children and 19 adults
- None of these events interrupted normal running of the library. Funds to run the events were raised through a sponsored swim, and two grants from Friends of Honley Library and Honley Village Trust. Author visits were especially enjoyed as the authors were experienced in engaging the children.

#### What we learned:

- Last year's events were attended by 112 adults and 156 children.
- Overall reactions showed that 28 to of 33 evaluations gave score of 5 for enjoyment of the events.
- The remaining 5 evaluations rated the events as 4. Out of possible score of 165 we achieved 156 (95%)
- On average, about 25% of those attending each event said the event had encouraged them to visit the library more often. At all the events held in the library there were participants for whom this was their first visit
- The workshops were very effective in signing up new library members (especially Babies into Books where new members included nine babies, one parent and a pensioner)
- Marketing is a job in itself!
- We have a great team of volunteers who give time to these activities, including childcare and adult learning professionals. Some volunteers have taken part in library services training which will allow us to offer story workshop events for children with special needs. We also plan to offer more for high-school aged pupils.

To consider a grant application by Holme Valley Sharing Memories Group for  $\pounds$ 1,000 revenue contribution to an intergenerational project with a group of pupils at Holmfirth Junior and Infant School in Spring 2017.

### 2. Key points

**2.0** Members of the Holme Valley Sharing Memories Group (all older people in their 70's, 80's and 90's) will work with a group of pupils to learn a favourite song, talk about their local identity and get to know each other better. At the end

of the project they will share their songs with a wider audience at a public performance in Huddersfield. They will discuss where they live and how they live together, and express their identity through the personal songs and artwork as part of the larger event.

- 2.1 This project brings together two diverse groups; ten elderly members of the Group and 14 Key Stage 2 pupils, age 7 to 11 years. Members of the Holme Valley Sharing Memories Group experience a high degree of social isolation due to the fact that they live alone or care for someone with mental/ physical needs. The project gives them the opportunity to work with young people which boosts their confidence and sense of self worth, and makes them feel valued as members of their community.
- **2.2** Young people will get the opportunity to have meaningful conversations with older people from their community, find out more about local heritage and share life experiences in a creative way. They will have opportunity to share what they have learnt on a public platform in front of a much larger audience.
- **2.3** The project will also create opportunities for future partnership working locally.

### 1. Purpose of report

The Committee is asked to consider a grant application by Roundway & Stoney Lane Tenants and Residents Association (TRA), Honley for £1,500 towards the creation of an easy access fruit and vegetable garden for all the tenants to use.

#### 2. Key points Background

- 2.0 The project was instigated through the Kirklees Neighbourhood Housing (KNH) plan it, grow it, eat it initiative. Four raised beds will be created for fresh vegetables and an area to grow fresh seasonal fruits such as strawberries, raspberries, gooseberries, rhubarb as well as a small sized greenhouse for propagating. A pathway will be created to the raised beds to ensure access and safety for all participants.
- **2.1** The garden will grow a variety of vegetables for the benefit of all residents in the Association area, supply the twice weekly luncheon clubs, and provide fresh home grown produce for several buffet teas throughout the year, providing cheaper, healthier produce.
- **2.2** All tenants will be encouraged to participate in the vegetable garden regardless of ability and knowledge. The TRA covers over 130 properties. Support will be sought from a range of professionals for advice of what to grow / when as well as suggestions from tenants.

### **Expected benefits and outcomes**

2.3 The project will enable those with poor mobility and limb/ back issues to enjoy gardening with very little effect on their health. It will bring people together, helping to reduce social isolation and reduce recourse to NHS/ GP services. Being outdoors will have a positive effect on health and well being, helping participants to improve their confidence and bring a sense of achievement. Using moderate physical strength will assist in reducing blood pressure and improve respiratory health, mental health, agility, bone strength and sociability. The project will encourage team work among the tenants.

# 2.4 Cost breakdown

The project was instigated through KNH Plant it, Grow it, Eat it and received an initial £300 funding, with a further amount due in 2017/18. £1,900 was secured through Awards for All with £1,000 granted by Holme Valley Parish Council, due April 1st.

The shortfall of £950 will be met by tenants' fundraising activity, exploring other funding and if necessary reducing costs.

In addition to the cost of the project £2,170 from The Big Lottery Celebrate Fund will be used for a launch event in July, hopefully to involve the school, wider community and supporters of the project.

The KNH Caretaking Team have offered support to the project, but certain activities may involve specialists using specialist machinery / equipment, so a small contingency is included for such costs.

The project hopes to get support from Comoodle for borrowing tools and equipment for the groundwork and developing the site, but need a tool bank on site that is easily accessible to the allotment users for day to day use.

The project will constantly look for best value and negotiate the best prices possible, recycling and reusing whenever practicable. A number of compost bins will be made out of recycled timber and pallets, and manure is free of charge.

#### 2.5 Volunteers

Around 30 volunteers/ 300 hours will be involved as much as possible in the initial groundwork, though professional involvement is essential in developing the infrastructure to ensure pathways and growing areas are safe and fit for purpose in the interest of the wellbeing of all uses. Volunteers will be repairing, planting, growing, picking, distributing and supporting others.

### 2.6 Timescale

The project will start on 1<sup>st</sup> March 2017 with preparation taking place through to 1<sup>st</sup> September 2017, after which it is planned to be ongoing and sustainable.

The groundwork is planned to start the last week in February when the site will be prepared, raised beds and planters built and hard core laid. The work on the paths will be completed in April ready for use in May.

### 3. Implications for the Council

The TRA is registered with the Council's grant access point. If the grant is approved the group will enter into a grant agreement with the Council.

The application meets the district committee priorities of Health & well being; community food growing projects and Place; communities looking after local assets for all to use and enjoy.

### 4. Consultees and their opinions

The garden will be on KNH land, KNH is fully supportive of the project.

# 5. Next steps

If the grant is approved the group will be asked to give feedback on the project.





### 1. Purpose of report

The Committee is asked to consider a grant application by Kirklees Bridleways Group for £2,000 towards work to create and maintain a bridle path in Honley Wood.

2. Key points

- **2.0** Kirklees Bridleways Group is a local community group which, over the last three years, has been conducting historical research for evidence on bridleways and footpaths to ensure they are correctly added to the definitive map and statement thereby ensuring their survival for future generations. Work parties clear large areas of brambles, nettles, overhanging branches etc with small hand tools. In the last 12 months 400 hours of volunteering time.
- 2.1 The Group is planning work to install gates, horse stiles and vehicle barriers at both ends of Honley Wood and will undertake surface repairs. Work will also be done to clear paths of over hanging branches, brambles, nettles, and any thing that makes use of the bridleway and footpaths difficult. The group has borrowed petrol strimmers to clear a number of routes in the Holme Valley. The group is proposing to buy a professional multi tool. It will be used for work with The River Project, Open Spaces Society and South Pennine Pack Horse Trust.
- 2.2 The work will improve access to Honley Wood and benefit local horse riders, removing them from a long main road, as well as cyclists. Maintenance will encourage more use of the woods and improve disabled access.
- **2.3** The group has £2k funds currently unallocated but which are planned to be used on research and Definitive Map Modification Orders. The group is currently working on 20 tracks/upgrades.

# 2.4 Cost Breakdown

The group will contribute £2,000 towards the cost of the items from its own funds. The machinery would be kept in a locked garage, insured and it would have regular services. This multi tool would be used by males only, wearing gloves, integrated forestry helmet and goggles.

### 2.5 Timescale

The work to improve the bridle path will start at Easter 2017 and take 2 weeks.

# 2.6 Volunteers

Kirklees Bridleways Group is a local voluntary community group with about 100 members. It organises voluntary work parties most weekends throughout the Summer. 20 volunteers will take 800 hours in total to install the new gates and undertake pruning, trimming, brush cutting, hedge trimming, rubbish collecting, tidying and safety assessment.

# 3. Implications for the Council

Kirklees Bridleways Group is in the process of renewing registration with the Council's Grant Access Point. If the grant is approved the group will enter into a grant agreement with the Council which includes a clause that groups make available on Comoodle for other groups to borrow any equipment purchased with district committee funding, as appropriate.

The application meets the district committee criteria of Place; communities looking after local assets for all to use and enjoy and Health and wellbeing.

# 4. Consultees and their opinions

The group will seek permission from the landowners Myers to do the work, the bridle path will be a permissive route.

Kirklees PROW supports schemes to widen access for horse riders.

Holme Valley North Ward Councillors have been consulted.

# 1. Purpose of report

To consider a grant application by Holmbridge Cricket Club for £3,270 revenue contribution to complete works to the Cricket Pavilion and Club House.

### 2. Key points

### 2.0 Background

Holmbridge Cricket Pavilion has been undergoing work to improve the fabric of the building. £89k funds raised by the club so far have been used to get the building into a good state of repair and modernize the ground floor. Additional works which were not anticipated (to the roof and foundations) have increased the costs. This has left a shortfall of £3,770 to complete the first floor accommodation with female and umpire changing rooms.

**2.1** The current pavilion was last modernized in 1980 and is no longer fit for purpose with some areas unsafe to use. Modernization works will provide two new changing rooms with integral showers, a kitchen which will allow improved catering for both the cricket and football clubs, a new social area and bar for players/supporters and public, new indoor public toilets, and a score box that is safe to use. It will also incorporate the installation of a heating system and new electrics to comply with current standards, and an improved external viewing area. *Photos of the current facilities are appended.* 

### 2.2 Expected benefits and outcomes

A modernized facility would enable the Cricket and Football Club to keep the existing players it has and run the current 8 teams. Improved facilities will allow both clubs to implement their Sports Development Plans of increasing the number of junior teams through maintaining the U9's, U11's, U13's, U15's and U17's junior cricket teams along with the establishment of a junior section of the football club.

A potential impact of **not** modernizing the club house would be to lose some of its junior players to other clubs that may have better facilities, not just in terms of training equipment and coaching, but in terms of club house facilities. For the senior players not having modern club house makes it difficult to not only retain the current players but also to attract new players to the club.

Modernisation of the pavilion would substantially improve the attractiveness of the clubs to the local community. The majority of the junior and senior players of both clubs, committee members and volunteers are from the local community. Over the last few years this has widened to incorporate adjoining communities through the success of the junior set up within the cricket club, and this is something the football club also wishes to emulate.

A modernised pavilion will allow both clubs to host events themselves, including joint events, and so bringing together the community. It will provide a smaller venue within the heart of the community for such events as children's parties, club meetings, OAP meetings and gatherings as well as offering a place for other clubs to meet if required. There are three schools in the area and one pre-school that would also consider using the improved facilities if they were made available for sports days and summer fairs etc.

The playing relationship with the Holme Valley Girls Cricket Club could also be enhanced further by offering them the opportunity to use the ground for games and training. It may also attract more girls to play cricket through the junior teams as they will have their own secure changing facilities. This again is something that has not been promoted widely to-date.

The whole of the ground floor will be DDA compliant so accessible to people with disabilities. There will be a disabled accessible toilet.

In the local community the club has established that there are several families with children with complex needs and adults with disabilities. They are currently unable to access sports facilities in their local area without driving, particularly in the Holme, Holmbridge and Hinchcliffe Mill area. The improved facilities would enable these vulnerable children, young people and adults to access activities and facilities which will improve their physical and mental health through increasing their access to sports activities, community events and outdoor space.

### 2.3 Sustainability

The modernized facilities will be used year round by both clubs. They will be run by a joint committee made up of members of both clubs. The club committees meet on a monthly basis.

The modernization of the pavilion will allow the clubs to enhance current income substantially by attracting more members.

A modernized pavilion will allow a number of the fund raising events currently held by the clubs in alternative venues, such quiz nights and race nights, to be held within the club.

Improved catering facilities and a small bar will increase the income to the Club substantially.

The Club's Committee will be able to explore the possibility of working with other sporting and social organisations in the community providing an alternative meeting place.

The Club also has strong links with a Sports Coaching Company - Project Sport - sports within schools and sports clubs out of schools. The ground and facilities would be available to hire to run cricket coaching sessions etc. (Project Sport has provided support to this project.)

Providing such sporting coaching during school holidays would be a fantastic benefit as it would allow a number of people the ability to try new sports in their local area, on their doorstep, for both young and old alike.

It would also encourage cricket supporters in the community to come and watch a game of senior or junior cricket and enjoy the facilities and refreshments from a comfortable viewing area - something that was once an integral part of community life.

### 2.4 Cost breakdown

The total cost of the project is £89k excluding the work to the 1<sup>st</sup> floor; the club has contributed £5,000 and obtained grants from Sports England, Huddersfield Common Good Trust and Holme Valley Parish Council. The work to the upper floor would be done by the plumbing and electrical contractors engaged to do the work on the ground floor.

# 2.5 <u>Timescale</u>

The initial work started on 14<sup>th</sup> December 2016 is expected to take 12-14 weeks. Work to complete the upper floor would start in March 2017 if funding is in place.

# 2.6 Volunteers

Over 20 volunteers are involved in the project undertaking various manual handling operations such as moving materials, removal of rubbish from the site and 2 volunteers are working with the building contractor on day to day management. A total of 200-250 hours for the whole project.

# 3. Implications for the Council

The group's Grant Access Point registration with the Council is currently being renewed. If the grant is approved the group will enter into a grant agreement with the Council.

The application meets the District Committee priorities of Health and well being; access to physical activity in local communities and Place; communities looking after local assets for all to use and enjoy.

Planning permission for the pavilion works was granted in August 2016, for a single storey extension and external staircase, alterations to roof height, dormer and decking. The land is owned by the cricket club. *Copy of plan is appended.* 

# 4. Consultees and their opinions

The Council's Sports and Physical Activity Team – "this seems to be a very reasonable project, with significant benefits to the local community and for participation in football and cricket in particular. There is clearly significant input from the club in terms of monies and in lieu of monies (volunteering to keep building costs down etc) so I would be supportive of this bid to help them fill the shortfall they are faced with."

Ward Councillors are supportive of the project.

### 5. Next steps

Subject to approval of the grant the funding will be paid to the group and feedback will be provided.





### 1. Purpose of report

To consider an extension to the Citizens Advice Bureau (CAB) outreach service in the Denby Dale ward for a 12 month period, 1<sup>st</sup> April 2017 to 31<sup>st</sup> March 2018.

### 2. Key points

2.0 In addition to the current Advice Contract funded by Kirklees Council the district committee has funded outreach sessions in the Denby Dale ward for the last 6 years. The Council's contract provides for an advice service across Kirklees via the telephone advice line and for face to face appointments in Dewsbury and Huddersfield centres.

- 2.1 An outreach service in Denby Dale ward provides for an adviser being available once a fortnight, on Wednesdays 10 am to 1 pm for appointments with clients at Skelmanthorpe library.
- **2.2** Clients contact the telephone advice line service and receive an initial assessment. If an appointment is required and the client is based in the Denby Dale area they are offered the next appointment at the library. Clients usually have a 45 minute appointment slot although double appointments can be booked for form filling etc.
- **2.3** Quarterly reports on progress are made to the Denby Dale ward councillors on the numbers using the service and outcomes.

# 2.4 Monitoring information 2016/17

For the period April 2016 to January 2017:-

- 128 Denby Dale residents have called our telephone advice service for help
- 45 of these were given a telephone call back from our outreach adviser to get more in depth information
- 12 of these were helped over the phone only
- 33 people were given appointments at Skelmanthorpe Library during the 13 outreach sessions
- The income gains for the 33 clients seen at Skelmanthorpe are £55,000, an average of over £1,600 per client per annum.

The main enquiry area tends to be benefits but other issues we have offered advice on include; housing, debt, consumer, employment and health.

From April 2013 to December 2016 we have helped face to face over 159 clients in the Denby Dale area at a cost of £14,544. This amounts to £91 per client. We have also supported many other Denby Dale residents who have used our telephone advice service (see section 2.2)

# 2.5 Costs

One session per fortnight held at Skelmanthorpe Library will cost  $\pounds$ 4,475 in 2017/18. This is the same cost as 2016/17.

# 3. Implications for the Council

The proposal meets the Council priority of social action, supporting people to take actions for themselves. There is inequality of access to advice for people living in the Denby Dale ward compared to the average across Kirklees.

# 4. Consultees and their opinions

Ward councillors are proposing to continue funding this provision in 2017/18 on the same basis as in previous years.

Kirklees Revenues and Benefits Service has been informed of the proposals.

# 5. Next steps

Subject to a decision to fund this the outreach sessions will be booked at the library and staffing allocated.

To agree funding of £4,475 revenue to continue to deliver one outreach advice session on a fortnightly basis at Skelmanthorpe Library 1<sup>st</sup> April 2017 to 31<sup>st</sup> March 2018.

### 1. Purpose of report

To consider a grant application by Denby Dale Walkers are Welcome Group for £8,252 contribution towards work to improve the surface of the Kirkburton Spur, an extension to the Trans Pennine Trail from Kirkburton to Penistone.

# 2. Key points

**2.0** The Kirkburton Spur was created with £144,000 EPIP funding under the LEADER programme 2009-2013. Both an on road and off road route were provided to give a welcome link from Kirklees to the nationally renowned Trans Pennine Trail. EPIP funding enabled the design, procurement and signage of two links between Denby Dale/ Kirkburton and the Trans Pennine Trail near Penistone.

- **2.1** The new project will improve two sections of bridleway on the off- road route which are becoming virtually impassable at certain times of year for all but the most dedicated mountain biker. These are at Bank Lane, Denby Dale and at Long Lane, Thunderbridge. *Maps of the routes are attached.*
- 2.2 The success of the link has enhanced the growing reputation of the Denby Dale/ Kirkburton area for outdoor recreation. The Trans Pennine Trail is of national importance and has boosted the rural economy of businesses along its route. A letter of support is attached which shows visitor spend in this area by walkers and cyclists using the route. Letters of support are also attached from local businesses. The project will increase the numbers using the route and strengthen the profile of the area as an outdoor visitor destination. The route is used by walkers, cyclists and horse riders.
- 2.3 The work at Long Lane, Shepley will involve reconstructing a 50 metre section of the bridleway using the existing cobbles and installing drainage. The work at Bank Lane, Denby Dale will involve excavation of a spoil, resurfacing, cleaning drains and adding 2 metres of concrete. Three quotes were obtained for each section. The lowest quotes have been selected by the group; £25,180 plus VAT for Long Lane and £9,200 plus VAT for Bank Lane. Copy of the preferred quotes/ contractors attached.

#### 2.4 Cost breakdown

An application for 80% of the cost of the work has been made to the East Peak Innovation Partnership (EPIP) fund. This is the maximum amount that EPIP could fund. The outline application to EPIP has been approved. The full application to EPIP will be submitted by 10<sup>th</sup> February 2017 and a decision made shortly after.

#### 2.5 Timescale

The work is planned to start on 1<sup>st</sup> March 2017 and is expected to take 3 weeks.

#### 2.6 Volunteers

Ten volunteers from the Group will assist with the planning and organising of the project and will keep the route clear of overhanging vegetation. This is a total of 150 volunteer hours.

#### 3. Implications for the Council

All the work will take place on Public Rights of Way. Kirklees Public Rights of Way Team gives permission for the works on both sections of the route –"maintenance of the improved surface of the route will remain the responsibility of Kirklees Council, as Highway Authority, unless altered without permission by others."

The application meets the district committee priority of Place; footpaths, roads and greenway improvements, Economic Growth & Regeneration; contributing to the rural economy and local tourism and Health and well being; access to physical activity in local communities.

Denby Dale Walkers are Welcome Group is registered with the Council's Grant Access Point. If the grant is approved the group will enter into a grant agreement with the Council.


Councillor Bill Armer: "I support this in principle. I am currently dealing with complaints of off-road motorbikes on the Long Lane section. Difficult to improve access for equestrians without making the route more attractive to off-road motorcycles, but I wonder if there is anything which could be incorporated into the scheme."




I would strongly support any assistance in helping improve bridleway surfaces in and around the Denby Dale area for the benefit of both walkers and cyclists.



#### 1. Purpose of report

To consider a grant application by Slaithwaite Civic Hall Trust for £12,000 revenue towards a new boiler at Slaithwaite Civic Hall.

Public

#### 2. Key points

**2.0** The asset transfer of Slaithwaite Civic Hall from the Council to the Slaithwaite Civic Hall Trust is under discussion. Building surveys (electrics, plumbing and heating) have identified faults with the boiler and heating system. The Trust's draft business plan 2017-2020 identifies that the boiler is a priority to repair or replace.

- 2.1 A new boiler and heating system would be more eco-friendly, save on costs and provide a warm, welcoming environment for the benefit of the community. A reliable heating system would encourage more people to make bookings and generate income. This investment would include the ability to isolate areas of the building needing heat when in use, saving on costs. Long term maintenance would be easier and cheaper.
- **2.2** If the boiler is not replaced it is likely to fail in the near future and the building would have to close to bookings. The Trust would have to find funding for repairs and maintenance.

These costs are based on two quotes received to date from local companies and include VAT. A third quote is being obtained.

The Trust is applying to the Centre for Sustainable Energy for a grant towards the cost of the project and a decision will be made on 1<sup>st</sup> April 2017.

#### 2.4 Timescales

The work to install the new boiler will take place once funding is in place.

#### 2.5 Volunteers

Between 10 and 20 volunteers will clear the hall before the work takes place and decorate it afterwards. This will take around 5 full days.

#### 3. Implications for the Council

Permission has been obtained from the Council's Physical Resources and Procurement Service and is subject to approval of the asset transfer application by the Trust.

The Slaithwaite Civic Hall Trust is not yet registered with the Council's Grant Access Point. It is a new organisation with a management committee, constitution and 3 year business plan in place with projected cash flow for 3 years.

If the grant is approved the Trust would enter into a grant agreement with the Council. The grant would be paid in two instalments; 75% on proof a contract is in place between the Trust and the contractor to do the work and 25% on proof of completion of the work.

Any grant funding awarded would be held by the Slaithwaite Philharmonic Orchestra on behalf of the Trust. The Orchestra is a main user of the hall and is registered with the Council's grant access point.

The application meets the district committee's priority of Place; communities looking after local assets for all to use and enjoy.

#### 4. Consultees and their opinions

Physical Resources and Procurement – A final copy of the group's business case is awaited for assessment. The process for asset transfer and decision can take anything from 3 months upwards from assessment. The group has been offered a full lease of the premises from 1<sup>st</sup> April 2017.

Kirklees Legal Services – the asset transfer of Slaithwaite Civic Hall has not yet been approved by Cabinet (Committee Assets) and the business plan of Slaithwaite Civic Hall has not yet been assessed as robust. Slaithwaite Civic Hall Trust is not yet registered as a company, Charitable Incorporated Organisation or incorporated organisation.

Colne Valley Ward Councillors are supportive of the application.

#### 5. Next steps

Subject to approval of the application a grant agreement would be entered into with the group.

#### 6. Officer recommendations and reasons

The Committee is asked to consider the grant application and if approved the release of the grant funding is to be conditional upon completion of the asset transfer on the grounds that reason for the application is that there is going to be an asset transfer, and to be conditional on the set up of Slaithwaite Civic Hall Trust as a Charitable Incorporated Organisation or an incorporated organisation.

#### 1. Purpose of report

To agree to fund £7,500 for the construction of parking bays in the roadside verge service margins at St. Mary's Mews, Honley.

#### 2. Key points

Holme Valley North Councillors have been considering solutions to difficulties caused by inconsiderate parking to residents of St. Mary's Mews.

Discussions with officers have determined that any long term solutions would depend on the location of utility apparatus in the grass verges at the entrance to the cul de sac.

There are services in this grass margin as predicted but the override strip would still be possible, although at a slightly reduced width of 800mm.

The override strip would consist of 800mm of available running for vehicles plus a kerb to the rear (100mm in width) – 900mm in total. The new kerb is necessary to deter traffic from running off the back of the strip and endangering the resident's fence / churning up the remaining grass.

Topsoil and grass seed to the rear to reinstate the verge area following the works will tidy things up.

The cost of the works will be in the region of £7,500.

#### 3. Implications for the Council

There will not be a future maintenance liability to the council at this time as the bays will not be a part of the adopted highway.

#### 4. Consultees and their opinions

Holme Valley North Councillors are in support of the proposals.

#### 5. Next steps

If approved officers will commission and carry out the works.

#### 1. Purpose of report

To advise members of the funding arrangements for Litherop Lane, Clayton West - Environmental improvements.

#### 2. Key points

Councillor Michael Watson requested that officers investigated options to reduce the number of incidents of inconsiderate off road parking and littering occurring on Litherop Lane Clayton West. The district committee allocated £1,000 in November 2015 to install kerb stones.

This is the second phase of works and whilst the first stage has very much improved conditions, there is now a need to make a number of minor alterations. in order to complete the task.

At this time there are no justifications for funding these works from main stream highways budgets, but officers have considered a number of options available if funding can be secured elsewhere.

Officers from Streetscene & Housing have costed proposals to re-line the carriageway edges in white in order to determine the extent of the road width and it is estimated that these works could be completed for a maximum of £200.

Local stone suppliers Marshalls have offered kerb stones to fill in 10 laybys created by off road parking on the lane. The cost of moving the stones from Shepley Quarry to Litherup Lane is £400 for a full day (price provided by local haulier specialising in this work).

If approved, it is proposed that these works will be funded from the Denby Dale Ward allocation in the Kirklees Rural District Committee Revenue budget.

#### 3. Implications for the Council

There will be a future maintenance liability to the Council for the lining which can be managed from within existing maintenance budgets.

Once funding is approved officers will commission the works.

#### 1. Purpose of report

To seek approval to allocate £14,000 New Homes Bonus funding to pay for mental health first aid training for community champions.

The training will equip participants to recognise and respond appropriately to signs of mental ill health and raise awareness of the range of local provision available to support 'at risk' individuals, and how this can be most effectively accessed.

#### 2. Key points

#### 2.0 Background

Kirklees Rural District Committee has identified improving health and wellbeing as one of it's' priorities, in particular young people's emotional health and wellbeing. This report proposes how the committee could take forward and make a positive contribution to the public Mental Health agenda within the Kirklees Rural District.

- **2.1** Mental health is defined as a state of well-being in which every individual realises his or her own potential, can cope with the normal stresses of life, can work productively and fruitfully, and is able to make a contribution to his or her community, (WHO, 2014). Half of all lifetime cases of mental illness begin by the age of 14 and 1 in 4 of us suffer from a mental health problem in the course of any given year (DH, No Health without Mental Health, 2011).
- **2.2** Mental health is everyone's business; just like physical health, we all have mental health, which can change over time, with periods where we may struggle and other times when we feel well (Mind, 2015). Public mental health interventions can play a role in improving the mental health of people across these different stages. Public mental health is concerned with preventing mental health problems from happening, by targeting the whole population and those at risk groups (those experiencing: stressful life events, unemployment, poor housing, social isolation and loneliness).
- 2.3 Current Living In Kirklees 2016 (CLiK Survey) -

#### Adults

Residents were asked 'which, if any, of the following health conditions or illnesses do you have or have you had in the last 12 months?' There were options of depression, anxiety or other mental health condition, so the responses to this question incorporated all of the above.

Those living with any mental health condition was highest in Colne Valley and lowest in Holme Valley South. If we look at anxiety and depression separately, it shows how self reported measures of these conditions is also highest in the same geographical areas within Kirklees Rural.

(It is important to note that these figures are not mutually exclusive, therefore one person could have ticked more than one mental health condition).

#### Young People

Kirklees Rural had the highest amount of young people reporting they have anxiety or depression at 1 in 29 (4%) young people and also the lowest wellbeing score out of the four District Committees. Overall for Kirklees, 1 in 20 (5%) young people have problems sleeping due to anxiety and this was higher in Kirklees Rural (1 in 17, 6%) than the other four District Committees. (Young Persons Survey, 2014)

#### Loneliness

Having a mental health problem increases your chances of feeling lonely and feeling lonely can have a negative impact on your mental health (Mind, 2013). Residents were asked in the CLiK survey 'Do you ever feel lonely or isolated where you currently live?'

Kirklees Rural had lower reports of feeling lonely than the Kirklees average, therefore efforts should be focused on those areas with higher self-reported levels of mental health conditions as these people are more likely to feel lonely.

#### 2.4 The Proposal

This proposal is to provide Mental Health First Aid Training (MHFA) and Youth MHFA for identified community champions working with those most at risk of developing mental health problems, including awareness raising of local provision amongst primary care.

Mental Health First Aid Training is an internationally recognised, accredited twoday course that teaches people how to recognise and respond appropriately to signs of mental ill health. The practical skills based approach demystifies mental health problems and challenges the stigma and discrimination that surrounds mental illness. Participants learn about anxiety, depression, psychosis and suicide, and they gain an understanding about risk factors, signs and symptoms.

At the end of the course delivered by Community Links, participants are able to:

- Recognise and respond appropriately to signs of mental ill health.
- Feel confident helping someone experiencing a problem.
- Help stop a mental illness from getting worse.
- Help someone recover faster.
- Guide someone towards the right support.
- Reduce the stigma of mental health problems.

The benefit in supporting the development of Kirklees Rural specific community champions, is the extensive understanding they will have about relevant local provision and how to access this. Details of local support opportunities will be shared and there will be follow up after the training as part of the evaluation, and to share case studies of what difference the training made.

A scope will be done of the best-placed individuals from across the district to attend the MHFA training. These individuals would need to be well known in the community and come across people at risk of developing or already experiencing early stage mental health conditions. They need to be in a position to have those 'conversations' with those living in the community who would benefit from some help. It is envisaged that a broad range of individuals will be identified from community and voluntary organisations and relevant services.

The work of the champions will be monitored, to look at what impact the training has had on their contacts and to ask for case studies for the difference the training has made. GP's will be notified that this training has taken place as they may observe an increase in people asking for help. There will be awareness raising of existing local level services to support those who may benefit from signposting to these services alongside treatment or instead of or as part of their recovery, and there will be the development of a leaflet that combines all services available and how to access them to hand out to communities where appropriate.

These costs are based on the cost of the programme delivered in Dewsbury and Mirfield District as a pilot; where 128 champions will be trained. Four courses (16 people per course) relate to adult mental heath and four relate to youth mental health (16 people per course).

#### 2.6 Timescales

The training would take place during 2017-18 on a rolling programme of 2-day sessions involving sixteen individuals per training course.

#### 2.7 Commissioning

As three district committees are considering this proposal for their district and the total value will be above £20, 000 the training organisation will be selected via the Council's procurement process, which has potential to reduce costs.

#### 2.8 Expected outcomes and benefits

Improved emotional health and wellbeing for those living in Kirklees Rural.

Increased awareness and understanding of mental health: by public and front line staff (housing, primary care staff, neighbourhood management groups, youth workers etc).

Local communities and organisations learn how mental health conditions affect others, reducing stigma and creating a mentally healthy community. More people living well in their community.

MHFA and youth MHFA will be delivered to communities of interest e.g. faith groups, older peoples groups, primary care, workplaces, the community and voluntary sector, to increase basic awareness and understanding of mental health conditions and more importantly what can be done to help.

Partnership working and co-ordinated approaches to improving mental health through raising awareness of existing local community and voluntary mental health services.

Specific work with GPs in the area to promote social prescribing to local mental health services, especially for those already in contact with GPs for their mental health condition.

#### 2.9 Other agencies or services involved:

Greater Huddersfield Clinical Commissioning Group, General Practitioners, wide range of community based community and voluntary sector groups, and frontline staff working in local communities.

#### 2.10 New Homes Bonus criteria

The proposal meets the criteria:

- a. Funding is used to help deliver priorities and actions contained in the Early Intervention & Prevention and Economic Resilience work programmes that are evidence based.
- b. Projects demonstrate innovation, new ways of working, encourage partnership involvement and deliver benefits across several wards.

#### 3. Implications for the Council

This project proposal meets the following priorities for the Council and for the District Committee:

Health and Wellbeing and Early Intervention and Prevention.

The project will support those people at risk of developing mental health problems (including children), as well as those who might already be experiencing early stage mental health problems.

MHFA has existed for many years but this project aims to take mental health awareness as upstream as possible, for people to identify signs and symptoms as early as possible and take action, helping people to help themselves.

This programme has no identified negative impacts and no legal, financial, IT or HR implications for the Council. The programme will enhance life chances for young people.

#### 1. Purpose of report

To seek approval for £15k New Homes Bonus funding to develop and deliver a series of activities in the Kirklees Rural wards in 2017/18.

Public

This will include introductory sessions to exercise including dancing, walking, running, cycling, fitness classes and sporting activities for beginners and families. Festivals will be put on to promote and celebrate being physically active.

#### 2. Key Points

#### 2.1 Background and Project Objective:

Our objective is to support and encourage children and adults leading sedentary lifestyles to take part in outdoor and indoor exercise to benefit their physical and mental health and sense of wellbeing. We believe that by taking part in physical activity and sharing positive experiences that people will strengthen their connections with their family, friends and local community.

We will focus the project on targeting currently inactive people:

- to engage them in physical activity
- to raise awareness of opportunities to participate
- to identify people in communities to take a leadership role to sustain the activity.

## **2.2 Evidence Base** (from the Joint Health & Wellbeing Strategy and Everybody Active Strategy)

Around one in three people across Kirklees are classed as "inactive", doing less than 30 minutes of physical activity per week. We know there are major health gains to be made from the move from inactivity to doing some activity in a week.

The number of women participating in sport and active recreation is low and appears to be declining. There is also low participation by those on low incomes.

There are inequalities in participation with lower socio-economic groups being less active, activity reduced with age, and women less active than men. Those who were more likely to be inactive included those with poor health and those claiming income related benefits. Tellingly, people who were obese were twice as likely as those who were a healthy weight to be inactive.

#### 2.3 Project Outline:

#### 2.3.1 Scope of activity and venues:

We propose organising a series of beginners / taster events specifically in the Rural District which will include Dancing, Walking, Running, Cycling, Walking Football, Tennis, various Sports and Exercise classes with a focus on building people's confidence and ability to exercise and to be more active.

We will deliver festivals, to promote and celebrate this programme. These events will bring participants and providers together to share experiences, have fun and build links between groups and establish regular sessions. We will use our existing green spaces (playing fields, woodland areas) to organise walks, runs and cycle rides and develop activities with local organisations in venues such as KAL, sports clubs and community centres, outdoor spaces. A mapping exercise will be carried out to identify current opportunities and then the programme will be developed on a ward basis with councillors, partners and interested community members and groups.

We will organise a number of activities and work with existing providers of community activity to encourage people to engage with exercise opportunities and support individuals to take up training.

Working with KAL we will identify organisations to work with, and specific individuals, who are leaders within their communities/ social groups to promote uptake of organised walks, runs, rides, sports and exercise.

#### 2.3.2 Expected outcomes:

- Engage new people in dancing, walking, cycling, jogging, exercise and sport; encourage them to adopt behaviours in daily lives, e.g. active travel to get to school, shops, services, and regular participation in exercise.
- Introduce sense of fun in taking part in activities and enjoying the great outdoors and local indoor facilities.
- People exploring their local neighbourhoods
- Identify activity 'leaders' and train them to organise activity
- People joining clubs and accessing existing opportunities

#### 2.4 Cost breakdown:

- £10,000 will support different activities in 6 wards delivered by local providers. As required by the organisation delivering the session to cover venue hire, instructor costs, volunteer expenses or equipment as required.
- £2,000 for festivals
- £2,000 for marketing and promotion
- £1,000 for follow on leadership training for volunteers

Number of beneficiaries approximately 10 per session (120 in total)

Funding will be used to commission activities, pay activity leaders, hire venues, provide refreshments, organise publicity and promotion, train new activity leaders and buy equipment.

Through alignment with other programmes of activity we expect officer support from key partner organisations and contributions from volunteers to develop activity and offer mutual support and promotion across the different activity areas and themes.

#### 2.5 Volunteers

As an estimate based on 2 volunteers per session and 2 sessions per ward x 6 = a minimum of 24 volunteers will be involved over a 4 week period = 96 hours, this is a conservative guess. This is dependent on how many sessions are run by volunteers versus paid deliveries and how many sessions they would like to run.

#### 2.6 Evaluation:

We will use participant questionnaires and evaluation tools developed for existing physical activity/behaviour change projects, e.g. Cycle for Health / Healthy Walking / England Athletics / Sports Clubs. We will collect participant contact details to allow for follow-up evaluation.

#### 2.7 Sustainability:

There are existing programmes of community activity and more formal clubs to which we can signpost new participants:

Walking: Healthy Walking programme – Nordic Walking – Buggy Movers Running: 3-2-1; Jog Kirklees; Parkrun Cycling: Sky Ride programme (Sky Ride Local – Breeze – Ride Social) Sports clubs Kirklees Active Leisure - KAL

### 3. Implications for the Council

- There are no specific legal, financial, human resources (HR) or information technology (IT) implications of this project apart from these additional areas which will be incorporated within Council officer support. Support from Marketing and Communications
- Web Development
- Good will and some organisational input from council colleagues

What is the impact on the Council's priorities? The initiative supports:

- Joint Health and Wellbeing Strategy
- Sport England's Strategy
- National Governing Bodies Strategies.

Will deliver against these council priorities:

- support older people to be healthy, active and included

No specific climate change adaptation responses are required other than being prepared to accommodate/ plan around bad weather for outdoor activities.

#### Equality impact statement:

Activities will be planned to be as inclusive as possible. For example, we have local providers of inclusive cycling, walking and jogging activities, inclusive clubs. All activity will promote equality of opportunity and seek to create good relations between different people.

- Organise training courses as identified by the volunteers and organisations involved in the delivery of this programme.

#### 1. Purpose of report

To consider allocating £25k New Homes Bonus funding towards the building of a wheelchair friendly skatepark for use by young people and families across the Colne Valley and wider area at the Old Goods Yard in Marsden.

#### 2. Key points

**2.0** A group of 20 young people (mainly from Marsden village), supported by Communities Who Can, got together in Autumn 2015 to discuss provision of a skatepark for the Colne Valley area.

- 2.1 The proposal has progressed since then. Planning permission was granted in November 2016 for a skatepark to be built at the Old Goods Yard. The young people's group has been working with the local community for 12 months to raise funds and build support for the scheme in Marsden and the Colne Valley.
- 2.2 The facility will be used for skating, scooting and BMXing. The village of Marsden will benefit from the addition of a community facility. Young people and families who enjoy wheeled sports such as skating, bmx and scooters will benefit from a local facility. It would enhance the existing multi-use games area (MUGA) facility at the Goods Yard and be a well designed meeting place for local young people. The nearest skatepark is currently in Meltham and as such the local young people skate on the streets/ churchyard in Marsden when they are unable to travel over there. The skatepark will be accessable and the youth group will continue to develop the site, alongside the new partner organsiations they have now developed good relations with, to include a bmx/ off-road track, suitable for use by hand bikes (Experience Community CIC www.experiencecommunity.co.uk).
- **2.3** The Old Goods Yard is an under used resource. The project will improve it and develop a broader community facility which does not impact detrimentally on existing local residential areas or village facilities. A condition of the Planning permission was that the existing teen shelter at the site be removed which will provide a safer more open site. A Copy of the site plan is attached.

#### 2.4 Cost Breakdown

An outline application made by Communities Who Can for match funding of £50k has been approved by the Veolia Trust. A stage 2 application will be submitted in April 2017 and a decision will be made on 2<sup>nd</sup> June 2017.

The young people's group has so far raised £5k towards the cost of the build of which they have already paid towards the plans being draw up and the planning permission application. They will continue to fund raise

and apply for grants to improve the facility for example for improved lighting, benches, storage, possible bmx track and outdoor movie shows.

#### 2.5 Timescale

Subject to the above funding being in place by early June 2017, it is anticipated that the successful contractor will be in place by October 2017. The design elements of the site will be done, with the involvement of the young people, over Autumn 2017, with work starting with the better weather in Spring/Summer 2018 and taking approximately 3 months.

#### 2.6 Volunteers

The young people involved have volunteered approximately 168 hours to date, organising events and taking part in fundraising activity in the local community; clean ups, planting, coffee mornings, promoting what they are doing (presenting at school and district committee meeting), developing their skills as community leaders.

#### 2.7 New Homes Bonus Criteria

The proposal meets the New Homes Bonus criteria: -

- a. Funding is used to help deliver priorities and actions contained in the Early Intervention and Prevention and Economic Resilience work programmes that are evidence based. Example -Refurbishment of existing play areas to improve quality of provision and encourage use.
- b. Projects demonstrate innovation, new ways of working, encourage partnership involvement and deliver benefits across several wards.

In addition the project meets the District Committee priorities of Health and well being; access to physical activity in local communities and Place; communities looking after local assets for all to use and enjoy.

#### 2.8 New Homes Bonus Criteria and Sustainability

h. Funding should not commit the Council to any future maintenance liability, unless a 5 year commuted lump sum is included in the budget.

The main material will be concrete which has a 20-25 year life expectancy and is easy to maintain.

The Multi-use games court on-site currently has a maintenance regime in place – the rubbish bin is emptied and the site is swept as part of existing rounds. From experience, facilities such as these experience problems with litter (not helped by the windswept location). Cleansing Services have recommended that a trade waste bin would be needed and have indicated this could be incorporated into an existing round. There is also the potential to disucss with the National Trust the shared use of their facilities.

# 3. Implications for the Council

The land is owned by Kirklees Council. The proposals will help to develop the currently under-utilised site into a destination skate park and contribute further, to the facilities provided at the Old Goods Yard whilst also helping to fulfil all four Kirklees priorities including the Joint Health and Wellbeing Strategy Vision which promotes:

'Open spaces and green infrastructure that encourage physical activity and support positive emotional wellbeing.'

The facility will bring more people to the site, potentially creating more rubbish/litter which will need collecting and disposing. The users already do a lot of work keeping the facility clean and tidy, something they have assured us will continue, there will still be a need for the rubbish to be collected and disposed. As mentioned above, the site is already part of a maintainace route and there is potential to discuss sharing refuse facilities with the neighbouring National Trust building.

Also mentioned above, the existing MUGA next to the proposed site which is already included within the current maintenance routes of the play area inspection team, the design and construction of the facility will be a concrete construction which will require very little maintenance.

#### 4. Consultees and their opinions

Ward councillors Donna Bellamy, Nicola Turner and Rob Walker are supportive of the project. They have met with the skatepark group a number of times since it formed in Autumn 2015 to help progress the proposal with the Council.

#### 5. Next steps

If funding is approved then the next step will be to submit the full application for match funding to the Veiola Trust. Part of the Veiola Trust application process is that match funding be in place when the full application is considered.

#### 6. Officer recommendations and reasons

The Committee is asked to approve the allocation of £25k New Homes Bonus funding towards the building of a wheelchair friendly skatepark for use by young people and families across the Colne Valley and wider area at the Old Goods Yard in Marsden.

The project will meet the District Committee priorities of Health and well being; access to physical activity in local communities and Place; communities looking after local assets for all to use and enjoy. It will also help to fulfil all four Kirklees priorities including the Joint Health and Wellbeing Strategy Vision.



#### 1. Purpose of report

- **1.1** To consult with councillors on a project to upgrade the surfacing and drainage of a footpath in Denby Dale.
- **1.2** To request Councillors agree to provide £27,000 New Homes Bonus funding delegated to Kirklees Rural District Committee.

# 2. Key points

2.1 The project plans a major improvement to a route linking Denby Dale railway station to Upper Cumberworth. Parts of the recorded public footpath (Denby Dale Nos 84 and 119) have become waterlogged and are almost impassable at times of the year. In better weather the path dries to a very uneven surface.

- **2.2** The path is part of the "Denby Dale to Shepley Trail", waymarked by Denby Dale Walkers are Welcome Group and linking the 2 stations. Walkers Are Welcome is a locally focused national initiative aiming to encourage walking and improve facilities, bringing benefits to health, the environment and the local economy.
- **2.3** Denby Dale Walkers Are Welcome group have suggested moving the path from its current route, shown dashed X-X on the attached plan, to the route shown dotted Y-Y. This is because of the very poor condition of the current route and the drier, less convoluted route of the alternative.
- **2.4** To facilitate improvement work taking place on route Y-Y, the Council could consider:
  - An application to divert the route X-X to Y-Y. This process is open to public consultation, may result in a public inquiry and has estimated costs of £2500 - £7500
  - Creation by agreement of a new path Y-Y and preferably extinguishment of the X-X route. The creation aspect may incur legal costs for the landowner. The extinguishment process is open to public consultation, may result in a public inquiry and has estimated costs of £2500 - £7500
  - Compulsory creation of a new path Y-Y and preferably extinguishment of the X-X route. Consultation takes place with other local authorities on the creation order, with the public on an extinguishment, may result in a public inquiry and has estimated costs of £2500 - £7500
  - Dedication of a public right of way by the landowner. The council would be likely to gain maintenance responsibility in addition to the existing path. Permission would be needed to carry out works
  - Permissive agreement with the landowner. A permissive agreement does not dedicate the route as highway (public footpath) and does not therefore gain the protection such designations provide. The Council would still have responsibility for the existing route X-X. Some legal costs may be incurred on both parties. Planning permission may be required
  - Permission of the landowner to construct the path with no formal agreement. The path would be provided but with no protection. Planning permission may be required.
- **2.5** Highways Act applications to divert or create a public right of way are assessed under a Cabinet approved priority scoring matrix. An application to divert the path, for example, may not score enough points to trigger starting the process.

- **2.6** It is understood that a new planning application has been made by the quarry owners in connection with restoration works. The proposed haulage road in this application forms part of the route on the recorded right of way. It is not known at this early stage how the footpath will be accommodated.
- **2.7** The proposal works towards the District Committee's Plan of Place vision: "To work in partnership with local communities, to plan how to make the district a better place for people to live, work and play, by building on its strengths, resources and assets", because it would provide better access along a promoted route which also links to the area's public rights of way network
- 2.8 This proposal contributes to the Plan of Place priorities of:
  - Economic growth and regeneration Tourism local infrastructure and promoting attractions locally
  - Health and Wellbeing Young peoples' emotional health and wellbeing, Access to physical activity in local communities
  - Place Footpaths, roads and greenway improvement
- **2.9** The proposal would meet the New Homes Bonus fund criteria under the following headings:
  - Economic Resilience 3.Support to VCS/Community to develop business planning skills
  - Early intervention and prevention
- **2.10** The proposed works for the path are:
  - Site preparation remove vegetation as required, remove soft material to a sound base
  - Lay textile membrane
  - Lay a base layer of sandstone aggregate
  - Lay a surface layer of sandstone aggregate
  - Install stock fencing along the field path
- **2.11** The estimated cost of the project is approximately £27,000.

# 2.12 The amount requested from New Homes Bonus Kirklees Rural District Committee is £27,000.

#### 3. Implications for the Council

**3.1** Promoting and improving routes such as this works towards New Council aims such as improving health and wellbeing and increasing access between communities.

- **3.2** The West Yorkshire Local Transport Plan highlights maintenance and improvement to rights of way within its Delivering Accessibility, Tackling Congestion and Effective Asset Management themes.
- **3.3**Local users and those from further afield will benefit from a well-surfaced route which is unlikely to deteriorate for many years
- **3.4** As Highway Authority, maintenance of the surface of the existing public right of way will remain the responsibility of Kirklees Council. If this existing path is resurfaced the legal responsibilities of the Highway Authority continue unchanged. If a new path is created by agreement or by order and it is dedicated as a public right of way, its maintenance will be responsibility of the council. Its existence, and capital investment, is then protected by legislation. Other methods do not necessarily offer this protection. Details under point 2.4 above are also relevant here.

#### 4. Consultees and their opinions

Ward councillors have been consulted on and support the proposals. Councillors would wish to see a conclusion to any legal issues associated with movement of the path before any works commence on site.

Public Rights of Way officers support this in principle.

Denby Dale Walkers Are Welcome Group support the proposals.

Denby Dale Parish Council support the proposals.

#### 5. Next steps


**5.1** Denby Dale Walkers Are Welcome Group need to consider the options available and the consequences on their proposal, in discussion with Public Rights of Way officers.

#### 1. Purpose of report

The Committee is asked to consider a request from Denby Dale Walkers are Welcome Group to use  $\pounds$ 33,204 New Homes Bonus funding as a short term loan.

# 2. Key points

- **2.0** Denby Dale Walkers are Welcome Group has applied for a £33,204 grant from EPIP's LEADER programme 2015 -20. The funding will be used to improve the Kirkburton Spur of the Trans Pennine Trail at Long Lane,Thunderbridge and Bank Lane, Denby Dale.
- 2.1 The Group has also applied to the district committee for a grant of £8,252 as match funding for the work. This application is being considered at the committee meeting on 25<sup>th</sup> February 2017.

- 2.2 The EPIP funding application is being considered by the East Peak Board (Local Action Group) in February 2017. EPIP grants to charitable organisations can only be paid retrospectively i.e. the grant can be claimed only after the work has been completed and the invoices settled. The work will involve reconstructing the bridleway and adding drainage at Long Lane and excavating a spoil, adding drainage and resurfacing at Bank Lane. Two preferred quotes have been selected from local contractors.
- **2.3** Subject to all the funding being in place the work is planned to take place in April 2017. The loan would be paid in April 2017 and would be re-paid to the Council in May 2017 when the EPIP grant of £33,204 is paid to the group.

#### 3. Implications for the Council

Denby Dale Walkers are Welcome Group is registered with the Council's Grant Access Point. If this short term loan is approved the Group will enter into a agreement with the Council to repay it immediately on receipt of the EPIP grant.

All the work will take place on Public Rights of Way. Kirklees Public Rights of Way Team gives permission for the works on both sections of the route –"maintenance of the improved surface of the route will remain the responsibility of Kirklees Council, as Highway Authority, unless altered without permission by others."

The application meets the district committee priority of Place; footpaths, roads and greenway improvements, Economic Growth & Regeneration; contributing to the rural economy and local tourism and Health and well being; access to physical activity in local communities. It supports the Council priorities of Early Intervention and Prevention and Economic Resilience.

#### New Homes Bonus Criteria met:

- Funding is used to help deliver priorities and actions contained in the Early Intervention & Prevention and Economic Resilience work programmes that are evidence based.
- b) Projects demonstrate innovation, new ways of working, encourage partnership involvement and deliver benefits across several wards.

#### 4. Consultees and their opinions

Kirklees Rural Councillors have been consulted. Cllr John Taylor "This seems like a sensible solution to what is otherwise an intractable problem with scheduling the work to be done. So long as the correct processes are in place to recoup the monies promptly, I am happy to support this proposal."

#### 5. Next steps

The amount of £33,204 would be paid to Denby Dale Walkers are Welcome Group on receipt of written confirmation from EPIP of the grant award, on receipt of the signed agreement with the Council for the loan and on receipt of written confirmation of the timescale for the work.

EPIP have confirmed that the grant claim would be paid directly to Denby Dale Walkers are Welcome Group on submission of the reecipts, which would then re pay the Council. The Rural Payments Agency have to pay the EPIP grant direct to the applicant.

#### 6. Officer recommendations and reasons

The Committee is asked to consider approving a short term loan of £33,204 to Denby Dale Walkers are Welcome Group to facilitate improvements to Kirklees Bridleways.

#### 1. Purpose of report

**1.1** To consult with councillors on a project to continue surfacing a public bridleway running across open moorland with reclaimed mill flags and stone.

Public

**1.2** To request Councillors agree to provide £22,500 New Homes Bonus funding delegated to Kirklees Rural District Committee, with an intention that match funding be sought. Total cost of the scheme is £45,000.

# 2. Key points

- 2.1 Colne Valley Area Committee funded the purchase of materials in 2012/13 and 2013/14 financial years to begin work on this project. The National Trust, as landowner, organised and funded an airlift of the materials and provided volunteers to carry out the works. A reminder of the scheme details is provided in points 2.2 to 2.8 below. This section of the project is 330 metres in length and directly connects to previous works. This is shown Y-Y on the accompanying plan "Works Close Gate"
- **2.2** The bridleway, Colne Valley No 197, runs from Close Gate Bridge (also known as Eastergate Bridge), Hey Green at Marsden to Haigh Gutter on the A640 New Hey Road. The route is shown dotted X-X on the accompanying plan and is approximately 2.8 kilometres or 1.7 miles in length. As a public bridleway, the public have a right to walk and to ride a horse and can also use bicycles.
- **2.3** The bridleway is significantly damaged due to poor drainage, a high level of use and the lack of a durable surface. There are substantial lengths of braiding caused by users moving wider and wider to avoid mud or deep eroded channels.
- **2.4** There are links from CV197 to the Pennine Way and the Pennine Bridleway. Both these routes have significant numbers of users, many of whom require overnight stays. Better access along this bridleway to Marsden's hospitality, other commercial activities and transport links would contribute to the local economy and tourism aspirations.
- **2.5** The land has several designations. It is a site of special scientific interest, SSSI, which gives UK statutory protection for the best examples of flora, fauna, geological or physiographical features. It is within the South Pennine Moors Special Protection Area due to its European importance for several upland breeding bird species and it is registered common land, almost all owned by The National Trust.
- 2.6 The works are:
  - carry out drainage works to properly manage adjacent water flows
  - surface sections of the bridleway using recycled mill flags.
  - surface steep sections of the bridleway with stone pitching. This is a technique similar to laying setts but constructed to make non-regular steps
- **2.7** The works involve recognised materials and methods used, for example, by the North York Moors and Peak District National Parks and on National Trails such as the Pennine Way and the Cleveland Way.
- **2.8** Discussions have taken place with the National Trust, as landowner. The Trust can offer its volunteer team to assist with the airlifts, flagging and pitching.

- **2.9** The proposal works towards the District Committee's Plan of Place vision: "To work in partnership with local communities, to plan how to make the district a better place for people to live, work and play, by building on its strengths, resources and assets", because it would provide better access along a promoted route which also links to the area's public rights of way network
- 2.10 This proposal contributes to the Plan of Place priorities of:
  - Economic growth and regeneration Tourism local infrastructure and promoting attractions locally
  - Health and Wellbeing Young peoples' emotional health and wellbeing, Access to physical activity in local communities
  - Place Footpaths, roads and greenway improvement
- **2.11** The proposal would meet the New Homes Bonus fund criteria under the following headings:
  - Economic Resilience 3.Support to VCS/ Community to develop business planning skills

The project would be a partnership with The National Trust, which is a registered charity, and it would be their volunteers who would implement the practical works on the ground with technical assistance from the Council (PROW Streetscene). The value of volunteer labour on this project is approximately £40,000.

#### • Early intervention and prevention

The National Trust is promoted via its website, Facebook and Twitter. Together with the public's right to use the bridleway, this encourages use of the route which works towards improving health and wellbeing, the refurbishment allowing a greater range of users due to better surfacing.

People dealing with mental health issues benefit from being outdoors. This is supported by evidence from the mental health profession such as "Feel better outside, feel better inside" Mind (2013), and "Let's get physical" Mental Health Foundation (2013)."

Volunteering can help combat social isolation across all age groups and this project also brings with it the health advantages of appropriate physical activity.

• The main outcomes and benefits of the project The Pennine Way and Pennine Bridleway are routes of national importance. Those users can be funnelled via improvements to this route into the Colne Valley, bringing trade to the varied businesses of Marsden and beyond. Both these routes have significant numbers of users, many of whom require overnight stays. Better access along this bridleway to Marsden's hospitality, other commercial activities and transport links would contribute to the local economy and tourism aspirations.

The refurbishment methods would largely involve pitching, a method of resurfacing steep slopes with re-used mill wall stone and flagging with re-used mill flags, linking back to the industrial heritage of the area. The improved surface would be easier and safer to use and would be virtually maintenance free.

#### 3. Implications for the Council

- **3.4** Promoting and improving recreational routes such as this works towards Council priorities such as reducing our carbon footprint, working with partners to better use resources and deliver services in new ways, and supporting the elderly in being healthy, active and included.
- **3.5** Because the West Yorkshire Local Transport Plan proposes "investment in low-carbon methods of travel such as...walking and cycling, in order to define, develop and manage and develop networks and facilities to encourage cycling and walking", this proposal will form part of the council's contribution to that objective.
- **3.3** Using District Committee funding as match or seed can pull in further significant funding, for example from organisations such as Pennine Prospects, the appropriate lottery fund or the Landfill Communities Fund.
- **3.4** The legal status of the route remains unchanged. As Highway Authority, maintenance of the existing surface of the route is the responsibility of the Council. Maintenance responsibility for the new surfacing would remain with the council. However, this type of surfacing has been shown to require very little maintenance.

#### 4. Consultees and their opinions

Councillors Nicola Turner, Donna Bellamy and Rob Walker have been consulted on and support the proposals.

The National Trust Marsden Moor Estate is a partner in the project and supports the proposals.

Public Rights of Way Officers support the proposals.

#### 5. Next steps

A funding bid will be submitted to Pennine Prospects. Detailed costings will be prepared for that bid and a work programme developed in conjunction with the National Trust.

#### 6. Officer recommendations and reasons

Officers recommend that members approve the proposed scheme from New Homes Bonus funding in the 2016/17 financial year.

The amount requested from Kirklees District Committee New Homes Bonus is £22,500 with a requirement that match funding be sought from the LEADER programme via Pennine Prospects. Total cost of the scheme is £45,000.


- This would allow further progress to be made on site and/or funding bids to be progressed.
- Improving the surface and drainage would be of benefit to existing users and encourage new use because the route would be solid and well defined
- This in turn can benefit the local economy by bringing more people into the area. Long distance users making overnight stops are a particularly important group to attract because of the relatively large spend compared to a day or half day trip.
- Because the surface is virtually maintenance free, future resource demands are negligible
- Use of the bridleway will be concentrated onto a single, robust line thereby reducing further erosion and allowing previously damaged areas to recover
- Vegetation alongside the first section of works is already recovering
- A contribution is made to the Council's input to MyJourney (West Yorkshire Local Transport Plan).



#### 1. Purpose of report

To agree to commit New Homes Bonus funding of £52,000 to fund proposals for Speed Limit Reduction Orders (SLO) and other associated works in the Denby Dale and Kirkburton Wards.

# 2. Key points

To change the speed limits at the following locations:-

on the B6116 Huddersfield Road between Kirkburton and Shelley - reduce from national speed limit to 40 mph

on the A629 Abbey Road from Shelley Bank Bottom to The Knowle reduce from 40 to 30mph

on the A629 Lane Head Road Cliffe Road to Shepley Lane Head Farm increase from 30 to 40mph.

on the A629 Penistone Road through Birdsedge village - reduce from 40 to 30 mph.

Part of the existing 30 and 40mph speed limits on the A629 are to remain to complement the proposed changes.

Costs to include legal fees for Traffic Regulation Orders (TRO) for each scheme to advertise the changes complete with appropriate signing, lining, electrical connections/ disconnections at all of the sites.

#### New Homes Bonus Criteria

Funding will help to deliver an evidence based scheme which meets the priorities of the Early Intervention and Prevention and Economic Resilience programmes specifically –

#### **Road Maintenance and Safety**

• Maintenance to busy connecting roads affected by significant or multiple developments particularly during the construction phase which can be over a number of years.

#### 3. Implications for the Council

There will be a future maintenance liability to the Council for the signing and lining which can be managed from within existing maintenance budgets.

#### 4. Consultees and their opinions

Kirkburton Councillors are in support of the proposals as are the residents that attended a public meeting which was held at Shepley Library on 28th September 2016 which was attended by Highways Officers. The residents of Birdsedge and Shelley were also consulted by letter.

#### 5. Next steps

Once funding is approved officers will commission the works.
