"I have previously asked you if there was an inequality in the number of paid holidays received by Christian and non-Christian teaching and teaching support staff in Kirklees Schools? You answered no, but did add that there was provision for staff to have time off for certain festivals at the discretion of their employer. Can I therefore ask why it is that although the Muslim festival of Eid was on a weekend this year Muslim staff in North Kirklees then took the following Monday off with pay?"

"This is not a political stunt it is a serious question. You'll get as much time as I got when the 'phones were ringing and people were reporting to me that there was a very strong chemical smell. I ask you, in that situation, which Officer would you call on a Sunday lunch time to try and sort this?"

There have been many accidents - one involving a cyclist who was quite badly injured. One a few weeks ago which involved a bus. The road has been resurfaced and is covered in loose chippings. There has been an accident earlier on this morning. Can Councillor Payne assure me that this will be investigated and that safety measures will be implemented as a matter of urgency?"

"I find myself in the same position as Councillor Hemingway with regard to a road where a new surface has been put down and carried along to Emley crossroads. We have a loose chip surface which is causing concern to local members covering up the road safety markers. ## (a) Question by Councillor K Sims

Seeing how the Health and Safety Inspectors in Leeds have refused point blank to investigate workmanship about the Decent Homes Programme in Holme Valley South which in itself is a gross dereliction of duty can Councillor Cooper tell me what mechanisms of quality control is he putting in place to ensure we get no reoccurrence of the type of bodged jobs that Councillors Firth, Patrick and myself have been called out to these past few weeks at night as called for Moorlands Estate where British Gas had to come in to do a proper job. At Kirkroyds, New Mill an eighty year old tenant was left with no heating and a gas leak. By good fortune her son happened to call in on her and smelled gas. If that lady had switched on a light or turned on her gas cooker her home would have been blow apart and so would that lady. Emergency action had to be taken - we called out a "Corgi" registered person who fixed the problem. Will Councillor Cooper put the following in place to ensure that

- (1) all work contracted to Enterprise is done by skilled craftsmen
- (2) only registered trades people are employed as gas fitters and electricians
- (3) that customer care to out tenants is first class it isn't with this group at the moment
- (4) that once inspectors are qualified to recognise the difference between good quality value for money work and "cowboy" jobs

"Could Councillor Cooper tell me how many skilled tradesmen are employed by the Enterprise Partnership because it is my belief there are very few and the standard of workmanship is an absolute disgrace?"
