Following discussion with Cultural Services Hall Bookings regarding the availability of rooms, specifically for the 'Break Out' sessions held between 1.00 p.m. and 3.00 p.m. on the day of Council, the following dates are suggested for ordinary meetings of Council during the 2005/06 Municipal Year (the Annual Meeting will be held on 18 May 2005 commencing at 1.00 p.m.):

A Special Council Meeting is scheduled for Friday 7 October 2005 (evening) to confer the Freedom of the Borough on the citizens of the Besancon subject to the proposal being approved at the Special Council Meeting to be held on 13 April 2005. A separate report on this proposal is included with the Agenda.

*The reason for the suggested December 2005 meeting being held on a Thursday instead of the 'normal' Council day of a Wednesday is because the Town Hall has been booked for an orchestral concert on 7 December 2005. The only rooms available on that date to accommodate the 'Break Out' sessions would be the Council Chamber, the Members Lounge and Room 16. These latter two rooms have provisionally been booked from 1.00 p.m. to 3.00 p.m. should Members wish to meet on 7 December instead of 8 December 2005. The Reception Room is only available for Council use between 2.00 p.m. and 6.00 p.m. on 7 December 2005 being booked from 6.00 p.m. onwards for use by the orchestral concert organisers and up to 2.00 p.m. by a local organisation hosting a festive lunch. If Council meets on 7 December

2005 then the tea break would have to be brought forward to 4.30 p.m to ensure that the Reception Room was vacated and cleared by 5.30 p.m.

Enquiries were made of Hall Bookings to move forward the December meeting to 30 November 2005. However the Town Hall has been booked for an orchestral concert that day and both the Main Hall and the Reception Room are not available from 12.30 p.m. onwards.
