## **West Yorkshire Police Authority**

The nine Elected Members of the Police Authority are appointed by a Joint Committee made up of the five District Council Leaders or their representatives. The appointments have to reflect "the balance of parties for the time being prevailing among the Members of the relevant Councils take as a whole." (Police Act 1996 - Schedule 2).

With no local government elections having taken place this year it is not expected that the Council's current representation will change (1 Liberal Democrat and 1 Labour)
