The Chief Executive gave an overview in respect of the forthcoming Comprehensive Performance Assessment. The Chief Executive referred to the current status of the Council's performance as outlined in the Audit Commission Annual Audit and Inspection Letter for 2005/2006 included with the Council Agenda at item 10. The Chief Executive advised that the CPA Team would carry out their assessment of the Council during the last two weeks in June and were likely to hold discussions with Members of Cabinet, Members of Overview and Scrutiny and the Leaders of Opposition Groups as well as relevant officers.

Andrew Pennington of the Children and Young People Service gave an overview in respect of the Joint Area Review which would evaluate and report on the extent to which services within an area improve the life chances of children and young people. The Review would focus on the experience of children and young people within the Kirklees area across the five 'Outcomes for Children' set out in 'Every Child Matters.' Services to be reviewed would include Council services, health services, police and probation services and publicly funded services provided by community and voluntary organisations. He drew attention to an increase in the number of Police Community Safety Officers attached to each Neighbourhood Policing Team and indicated the intention that these Teams would in future, be lead by an Inspector who would have power and influence to make decisions locally. The relevant Inspector would be the first point of contact for elected Members.

- 1. Write to the Minister for the Cabinet Office and Social Exclusion The Rt Hon Hilary Armstrong MP asking her to reconsider retaining valuable jobs within Kirklees.
- 2. Write to each of the five local members of Parliament asking them to support the employees at HM Revenue and Customs and write to the Minister for the Cabinet Office asking her to reconsider her decision and keep jobs in Kirklees."

On being put to the meeting the Motion was CARRIED and it was

RESOLVED -

- "1. That HM Revenue and Customs announced that it intends to move work out of Halifax, Huddersfield, Keighley and Skipton and centralise it in Bradford.
- 2. This Council is concerned that this is likely to lead to the closure of local offices.

This Council is concerned about the loss of income to the local economy and increasing congestion as people have to travel further to work.

This Council resolves to:

- 1. Write to the Minister for the Cabinet Office and Social Exclusion The Rt Hon Hilary Armstrong MP asking her to reconsider retaining valuable jobs within Kirklees.
- Write to each of the five local members of Parliament asking them to support the employees at HM Revenue and Customs and write to the Minister for the Cabinet Office asking her to reconsider her decision and keep jobs in Kirklees."
- (d) Called upon Councillor Bolt who had given notice of the Motion at item 27 of the Council Agenda

It was moved by Councillor Bolt and seconded by Councillor Lees without comment.

NOTE

You have a **personal interest** in an issue if a decision on it could be reasonably regarded as affecting you more than other people in Kirklees. Similarly you have an interest if it affects:-

- · your partner, relative or friend or your or their employment or business, or
- certain other bodies or interests which you have declared in the written register of interests (see the Code of Conduct paras. 9, 14 and 15 on pp. 116, 120 and 121 of your yearbook).

That interest becomes a **prejudicial interest** if a member of the public who knows all the facts would reasonably regard it as being so great that it is likely to prejudice your judgement of the public interest (see para 10(2) of the Code on page 117 of the yearbook for some <u>possible</u> exceptions).

If you declare a **personal interest** you may stay and speak and vote on the issue.

If you declare a prejudicial interest, you must leave the room during the discussion and voting on the item concerned.

If you are uncertain, seek advice from the Solicitor to the Council.
