The Mayor announced he would be attending a workshop run by the Huddersfield Choral Society so would need to adjourn Council at the appropriate point for his departure to allow the Deputy Mayor to preside over the remainder of the meeting.

The Mayor announced Councillor Peter O'Neill had suffered two minor strokes, and it was agreed that the Council's best wishes be conveyed to him and his family.

The Mayor provided details of minor adjustments to the running order of business.

Councillors Fearnley, Harkin, Jones, Smithson and Yates would be retiring in May, and the Mayor and Councillors Khan, K Pinnock and Light paid their personal tributes.

129 Petitions

Councillor Bates submitted a petition from local residents against the building of a supermarket store in Littletown/Liversedge.

Councillor Stewart Turner submitted a petition from local residents calling on the Council to protect greenfield land between High Lane/Ashes Lane/New Laithe Hill and also land adjacent to Jackroyd Lane and Newsome Road from development, and further seeking the support of the Council to get this land re-designated as green belt and protected from development under the new Local Development Framework.

Councillor Battye submitted a petition from local residents calling on the Council to install a pedestrian crossing by the junction of Long Lane with Dalton Green Lane and Briggate.

In accordance with Council Procedure Rule 9(3) the Mayor directed that the subject matter of the petitions be referred to the appropriate Assistant Director for investigation and report to Cabinet or an appropriate Committee.

130 Deputation

In accordance with Council Procedure Rule 10(6) the Mayor directed that the subject matter of the deputation be referred to the appropriate Assistant Director for investigation and report to Cabinet or an appropriate Committee.

131 Five Minute Motion submitted in accordance with Council Procedure Rule 14(5) as to Leeds Children's Heart Surgery Unit - Leeds General Infirmary (LGI)

It was moved by Councillor Khan, seconded by Councillor K Pinnock and

RESOLVED - "This Council notes with concern the potential closure of the Children's Heart Surgery Unit at Leeds General Infirmary, as a result of the Department of Health's 'Safe and Sustainable' review of Children's Heart Surgery Units.

The closure of the Leeds Unit, which serves a large population centre, will have a severe impact on Yorkshire families, including those living in Kirklees, and would mean that parents with sick children would have to travel to Newcastle, Liverpool or Leicester, to receive the essential treatment currently provided in Leeds. This will cause extreme difficulty as a result of the distances families will have to travel, at a time of high anxiety about their child's health.

This Council recognises that a Joint Health Scrutiny Committee is currently meeting to fully consider the proposals for children's congenital cardiac surgery services. Whilst not wishing to pre-determine the findings of that review, nevertheless this Council wishes to express serious concerns about the impacts of removing services from the Leeds area. These concerns to be forwarded in a letter to the Department of Health with copies to all MP's within the Kirklees area.

This Council also requests that representations be made on behalf of the Council as part of the Department of Health's consultation exercise in support of the retention of the Leeds Children's Heart Surgery Unit."
