# 1. Purpose of Report

To update Corporate Government and Audit Committee on the progress of the Constitutional Working Party in 2011/12 and to set out the areas of work to be considered in the 2012/13 Municipal Year.

## 2. Key Points

The Constitutional Working Party was established by Leading Members and has met on four occasions in 2011/12. During that period the Working Party has focussed on the following areas of work:

- Area governance and decision making
- Wider Council engagement in policy

The Localism Bill Act provides strong context for the Working Party, particularly in terms of emerging thinking in respect of the Council's response to our approaches to area based governance moving forward. It is for this reason that further work needs to take place in 2012/13 to establish the Council's position in this key area. It is intended that outcomes of such work will be presented to Council in September.

With regards to wider Council engagement in policy the Working Party proposes two options for consideration by Corporate Governance and Audit Committee and thereafter Annual Council:

# Option 1 (Does not require changes to the constitution)

That Cabinet determines areas of policy development for 2012/13 to be the subject of wider councillor engagement. As part of that process councillors will have the opportunity to identify areas for such consideration. Once priority areas are agreed, existing Executive governance arrangements will be used to undertake the detailed work, the recommendations of which will be considered by Cabinet.

Option 2 (Will require changes to the constitution in September 2012)

That work takes place between now and September 2012 to revisit and refresh the Council's Policy Framework. The Framework will thereafter be used as a basis for Full Council to establish a time limited Policy Advisory Committee that will undertake detailed work that is reported to Full Council who will thereafter agree policy and request Cabinet implement such policy.

NOTE: Due to timing of the last meeting of the Working Party, which fell in the purdah period, Cabinet have not yet been formally consulted.

### 3. Implications for the Council

The proposals in terms of policy development will potentially have implications for the Council's constitution in the context of the role of Full Council and its relationship with the Executive.

The wider work associated with area governance, to be undertaken in 2012/13, will similarly have potential implications for the Council's wider governance and decision making arrangements depending on the outcome of such work.
