#### 135 Oral Questions / Comments, within the Respective Terms of Reference, to Chair of Committee/Sub Committee/Panels and the Council's Nominated Spokespersons of Joint Committees/External Bodies

Councillor Khan asked the following question to Councillor Patrick, Chair of Overview and Scrutiny Management Committee:-

With reference to the referral from Council to the Overview and Scrutiny Management Committee in relation to Changes to Services for Deaf and Hearing Impaired Children and those with Special Educational Needs across Kirklees, when the Committee (Changes to Services for Deaf and Hearing Impaired Children Sub Group) looked into the referral around the overview and implementation of the change in strategy, was the Committee first of all in agreement with the policy change implementation, and did it find any areas of concern on the implementation of the policy and, if so, had those been reported to the relevant Cabinet Members; had the Committee sought further action from Cabinet Members on any areas identified of concern and did it also relay, if there were no concerns, back to the National Deaf Children Society that the Committee was satisfied with the policy as it is; also, when the Committee was looking into the matter, was it made aware that the resources available for expenditure on children with special educational needs which had not been cut had instead been used in such a way to enable young people to have the best start in life to empower them to be as much as possible in mainstream provision.

The question was deferred to Councillor Bellamy (Chair of the Changes to Services for Deaf and Hearing Impaired Children Sub Group) who undertook to supply a written response.

Councillor Khan then asked the following supplementary question:-

In view of the fact of this issue being referred to full Council for a deputation and then being referred back to Scrutiny do you believe that had there been any specific concerns in the implementation of the policy, you would now have recalled those, because they would have been of such importance that they would have been communicated with immediate effect to those Cabinet Members.

Councillor Bellamy undertook to provide a written response to the supplementary question.

#### 136 Motion Submitted in Accordance with Council Procedure Rule 14 as to Appointment of Police and Crime Deputy Commissioner.

In respect of the motion notified on the Council Summons the mover and seconder of the motion, with the agreement of the meeting, accepted alteration of the wording thereto to include a minor amendment in the opening paragraph and an additional part 7 (under the provisions of Council Procedure Rule 14 (11).

Accordingly, it was moved by Councillor Marchington, seconded by Councillor Cooper and

### RESOLVED

This Council notes with deep concern the Police and Crime Commissioner's intention to appoint a Deputy Commissioner from among members of the Labour Party.

Council opposes this decision on the following grounds:

1) That in the current climate of reduced public spending, a salary of £53K for a Deputy is unnecessary, excessive and gratuitous;

- 2) That the appointment of a Labour Party Member on such a salary reeks of cronyism that will further damage the fledgling reputation of Commissioners already badly tarnished by the poor turn out last year;
- The appointment of a Labour Party Member on such a salary will damage the reputation of all political figures, reinforcing the public's perception that people are "just in it for the money";
- 4) The decision to appoint a Labour Party Member to the post of Deputy effectively politicises the running of the police force in a way that was not intended;
- 5) That restricting the pool of applicants to just members of the Labour Party may mean that the best candidate for the job and for the people of Kirklees and West Yorkshire may never get a chance to even apply;
- 6) That the Commissioner's decision to restrict applicants to just members of the Labour Party is in fact discriminatory and contradicts the Commissioner's own responsibilities for ensuring equality and diversity within the running of the police force.
- 7) That there was no mention of appointing a political appointee Deputy Police and Crime Commissioner on the Labour Candidates Election literature.

This Council therefore resolves to instruct the Chief Executive to write to the Police and Crime Commissioner immediately informing him of this Chamber's views and its strong opposition to the appointment of a Deputy and that Council would prefer that the exorbitant salary be spent on frontline policing.
