1. Purpose of report

To consider allocation of places/ratios, as appropriate, to various Outside Bodies.

2. Key points

The Council's representation on the various Outside Bodies/other Committees is split into a three part schedule Copies of Schedules 1 and 2 are attached. Schedule 1 is primarily concerned with representation on joint authorities and major bodies. Schedule 2 is concerned with other bodies, and Schedule 3 is primarily concerned with representation on charities which are referred to Area Committees to put forward nominations.

The Council is responsible for overall allocations/ratios, as appropriate for those bodies within its remit, and Cabinet is responsible for nominations to bodies concerned with executive functions. The Director of Resources has delegated authority, in consultation with Group Business Managers, to receive and process nominations.

In relation to the Yorkshire Purchasing Organisation Joint Committee a request has been received that each of the constituent Authorities should pass a resolution, waiving political balance rules which are applicable to the Yorkshire Purchasing Organisation Joint Committee, and also determine which of the Council's two nominees will have the one vote on behalf of the Authority.

In relation to Kirklees Active Leisure, Council is asked to determine which Member will be authorised for the purposes of Member meetings, (which are distinct from Director meetings) i.e. to exercise a vote, pursuant to Section 323 of the Companies Act 2006; further, to note that Mr D Smith, Director of Resources, will continue as Company Secretary, with no director status or voting rights.

Other Kirklees officer company secretaries to note are:Ms Vanessa Redfern, Acting Assistant Director, Legal, Governance and
Monitoring – for Kirklees Metropolitan Development Company Limited;
Mr Paul Kemp, Acting Assistant Director, Investment and Regeneration – for
Kirklees Stadium Development Limited.

The Council's interests will be represented by the appointed representatives.

5. Next steps

Following approval, the various Outside Bodies will be notified of the nominations.

6. Officer recommendations and reasons

That, in order to fill places on the various Outside Bodies:

- (1) Council confirms the allocation of places/ratios, as appropriate in Schedules 1 and 2 and notes that Group Business Managers will put forward nominations to the Director of Resources to fill any vacancies or make any adjustments to nominees previously put forward, as appropriate, subject to (4) below.
- (2) Those bodies with executive functions be referred to Cabinet to put forward nominations.

- (3) In relation to the Yorkshire Purchasing Organisation Joint Committee, the Council agrees to waive political balance rules which apply in accordance with Section 17 of the Local Government and Housing Act 1989 (this requires approval with no Member voting against); and that Cabinet, in determining the nominees, resolves which Member will have the one vote on behalf of the Council.
- (4) That one of the Council Trustees on Kirklees Active Leisure be Councillor Amanda Stubley, who be authorised to represent the Council for the purposes of Member meetings pursuant to Section 323 of the Companies Act 2006, to exercise a vote, and that Council notes that Mr D Smith, Director of Resources, will continue as Company Secretary, with no director status or voting rights.
- (5) Further, Council notes that Ms Vanessa Redfern, Acting Assistant Director, Legal, Governance and Monitoring, and Mr Paul Kemp, Acting Assistant Director, Investment and Regeneration, are respectively Company secretaries for Kirklees Metropolitan Development Company Limited, and Kirklees Stadium Development Limited.
