## 1. Purpose of report

1.1 To provide members of the Calderdale and Kirklees Joint Health Scrutiny Committee with the background to the discussions with Monitor.

### 2. Key Points

2.1 NHS commissioners and providers are currently facing significant financial and operational pressures. In addition the NHS faces an increasing demand from an ageing population and an expectation to continue to provide good quality care and respond to rising patient expectations.

- 2.2 Locally, the Calderdale and Huddersfield NHS Foundation Trust (CHFT) has revealed plans to make significant savings to its budget over the next two years in an attempt to address a deterioration in its finances.
- 2.3 Monitor is the sector regulator for health services in England and its responsibilities include making sure that independent foundation trusts are well-led so that they can provide quality care on a sustainable basis and essential services are maintained should a provider get into serious difficulties.
- 2.4 In light of the challenges currently facing CHFT Monitor is working with the Trust to investigate options to address the financial problems while ensuring that the quality and safety of care is maintained.
- 2.5 Representatives from Monitor will be in attendance to brief the Joint Committee on:
  - The support it is providing to CHFT to address its financial challenges.
  - The context to CHFT's position in comparison to other NHS foundation trusts.
  - Monitor's views on CHFT's current position
  - The timescale for its regulatory requirements
- 2.6 The attached information provides some additional background to Monitor to help inform the discussions.
