Announcements by the Mayor and Chief Executive

The Mayor displayed a certificate of Fair Trade Status, advising that Kirklees had been reaccredited with Fair Trade Borough status.

The Chief Executive announced the appointment of Mr Richard Parry as Director for Commissioning, Public Health and Adult Social Care, effective from 26 January 2015.

The Chief Executive advised that, in relation to Agenda Item 9, two petitions had been received regarding libraries, markets, children's centres and Oakwell Hall, Birstall, which had been omitted from the submitted report, but which would be included within the budget consultation exercise.

The Chief Executive read out a position statement following the recent decision by Tesco not to proceed with development at Old Leeds Road, Huddersfield.

80 Minutes of Previous Meeting

It was moved by The Mayor (Councillor Smith), seconded by the Deputy Mayor (Councillor Kane) and

RESOLVED - That the Minutes of the meeting held on 10 December 2014 be approved as a correct record.

81 Declaration of Interests

Councillor Smaje declared a Disclosable Pecuniary interest in Agenda Item 14 on the grounds that she is a Member of West Yorkshire Combined Authority Transport Committee.

Councillor Walton declared an 'other' interest in Agenda Item 7 on the grounds that she has a relative who is employed for the Troubled Families Project.

82 Constitution - Revised Scheme of Delegation

It was moved by Councillor Richards, seconded by Councillor Hardcastle and,

RESOLVED -

(i) That Sections B and F of Part 3 of the Council's Constitution be amended to reflect that in order to streamline the initial application and Regulatory Panel process, additional delegated authority is granted to the Director of Place to refuse, revoke or suspend an application for a grant or renewal of a Hackney Carriage or Private Hire Vehicle Drivers Licence where there are concerns regarding the safety and well-being of children, young people and vulnerable adults.

(ii) That, pursuant to (1) above, authority be delegated to the Assistant Director – Legal, Governance and Monitoring to make the necessary amendments to the Constitution.

(iii) That a further report be submitted to a future meeting of the Licensing and Safety Committee to clarify the amended Terms of Reference of the Panel and to undertake consultation with the Committee with regards to future decision making processes.

(iv) That a further report be submitted to the appropriate Committee after a 12 month period to review the changes in process following implementation.

84 Revenue Support Grant and Autumn Statement

It was moved by Councillor G Turner, and seconded by Councillor Sheard, and

RESOLVED - That Kirklees Council welcomes the opportunity to comment upon the provisional 2015/16 settlement as below;

Local Welfare Provision

The decision, following the legal challenge to the Government over the summer, to separately identify an amount within the settlement funding assessment to indicate to local authorities what the government thinks they should continue to spend on local welfare provision, is puzzling to say the least. No additional funding has been provided to cover this sum, nor has it impacted at all on the distribution of funding to individual local authorities. The ability therefore of individual local authorities to meet the problem varies enormously Wokingham for example would be able to fund their amount at a cost of £1.45 a household whereas for Kirklees the cost is £5.51 a household. Any distribution made, if any, has not been made in regard to need as in previous years. We believe this is wrong and blatantly directs money from poor areas to affluent area, we thus suggest a needs based allocation.

Comparative position of authorities

Analysis by the National Audit Office indicates that the Government continues to remove proportionately more funding from the more deprived authorities. Ministers have argued that this a simply a local reward for growth, but it is in fact a reward for rich authorities growing richer – as both the decision to freeze the resource equalisation mechanism in the basic grant system and the New Homes Bonus ensure that additional reward is given to authorities who build more expensive properties in more expensive areas of the country. In the Ministerial telephone conference Leeds highlighted the contrast between their spending power and Wokingham's, Plymouth picked Devon's, we would compare our position to any of the districts and counties who received an increase in their funding.

Many of us feel that the ending of resource and needs equalisation has resulted in a fundamentally unfair distribution system. The only areas which needs appears to continue to be recognised, is in the additional support given to rural areas. A properly assessed rural sparsity indicator has its place in a needs based system in which all elements are regular reviewed. But this system should include assessment of need in all areas not just those favoured by the Secretary of State, the methods and calculations should be independently audited.

New Homes Bonus top-slice

We welcome any reduction in the top-slice for New Homes Bonus but call for a broader review of the New Homes Bonus mechanism. To ensure that it ceases to be a mechanism to shift money from poorer areas to more affluent areas as the current system was obviously designed to do.

For the longer term, the Council strongly supports a fundamental review of the system of Local Government Finance.

RESOLVED - That the current Localised Council Tax Support Scheme be amended from 29% to 20%, providing additional support for low income working age Council Tax payers at neutral cost on the taxbase.
