5. Budget 2015/2016

- (ii) That £25.349m of new borrowing (£30m gross investment less the existing £4.651m Spenborough pool provision) be added to the Capital Investment Plan Appendix A; paras 1.5.6 1.5.10 refer)
- (iii) That the Capital Investment Plan be recommended to with an intention that the Plan is reviewed as an integral element of the Council's Budget Strategy to support Council priorities (on both capital and revenue budget proposals) and is contained within our foreseeable resources (Appendix A Section 1; Appendices B-C refer)
- (iv) That the Prudential Indicators as referred to in Appendix A (paras 1.6.1 & 3.15.4) and in Appendix D be determined

(B) Treasury Management

- (iii) That the Policy for provision of repayment of debt outlined in Appendix G, be Approved
- (iv) That the Treasury Management Indicators at Appendix H, be approved

(C) General Fund Revenue

- (i) That the current forecast of spending in 2014-15, and any resulting changes to the estimated level of General Fund Balances at 31st March 2014, be noted (Appendix A, section 3.11 refers)
- (ii) That the strategy for the use of Balances and Reserves, as set out in Appendix A, section 3.13, be reaffirmed
- (iii) That it be acknowledged that for 2015-16 the minimum level of General Fund balances should be £5.0m; (Appendix A, para 3.13.5 refers)
- (iv) That approval be given to the re-direct of £3m earmarked reserves for New Council developments (Appendix A, para 3.13.7 refers)
- (v) That the estimated balances and all other earmarked reserves be maintained, and that a further reassessment of reserves requirements be undertaken at year end and reported as part of the 2014-15 Revenue Rollover and Outturn report (Appendix A, para 3.13.8 refers)
- (vi) That the Council Tax requirement for 2015-16 be approved (Appendix A, section 3.9 refers)
- (vii) That the determination on the Council Tax Technical Changes be reaffirmed; 'The Council Tax Determination' as set out Appendix A, para 3.9.12 and Appendix M, noting that it has no impact on the council tax base or Council income
- (viii) That the Council's continued participation on the Leeds City Region business rates pool for 2015-16 (Appendix A para 3.8.15 refers) be noted.
- (ix) That it be noted that Cabinet recommends that unspent resources within District Committee budgets, including any capital allocations remaining from the previous Area Committee structure) be rolled over into 2015/2016.
- (x) That approval be given to the Council's Pay Policy Statement for 2015-16 as set out in Appendix N $\,$
- (xi) That the Director of Resources' positive assurance statement be noted (Para 3.4 refers)
- (xii) That the Director of Resources be given delegated authority to amend how the finally approved precepts are recorded in the Council's revenue budget in line with the final notifications received following decisions by the Office of Police & Crime Commissioner, the Fire & Rescue Authority and Parish Councils, should these be received after 18th February;
- (xiii) That Cabinet's Draft Revenue Budget (Appendix I) be approved.
