#### **PENALTY POINTS SCHEME**

The aim of introducing this scheme is to provide stepped enforcement for those licence holders who have contravened licence conditions or associated legal provisions. Introduction of the scheme does not however prejudice the Councils ability to take other action, which it is entitled to take under legislation, bye laws or regulation.

The scheme will be operated as follows:

#### 1. Issuing of Points.

- a) Penalty points will be applied by officers of the Council upon completion of investigation of relevant breaches of the Councils hackney carriage and private hire conditions or other relevant statutory provisions where breaches of those conditions or other relevant statutory provisions are identified.
- b) Penalty points when issued will be confirmed in writing to the relevant licence holder. There will be a 21 day period provided to allow for any appeal to be made against the points issued.
- c) The number of penalty points issued will be in accordance with the attached table.
- d) The Council retains the discretion to issue penalty points to both drivers, driver/owners and operators for a single contravention if the circumstances warrant it.
- e) The imposition of penalty points against a driver who is an employee will not necessarily result in additional imposition of points to his/her employer or operator.
- f) Imposition of penalty points is at the discretion of officers of the Council and is not negotiable. The scheme does however have an appeals procedure.
- g) Penalty points issued under this scheme will have a 'life' of twelve months, and then will be deemed spent. The system is based on a rolling twelve month period.
- h) Six points become spent at the conclusion of any suspension of a driver or driver/owner. Twelve points become spent at the conclusion of any suspension of an operator.
- i) Penalty points will be issued by the Licensing manager or in his absence the deputy licensing manager. The officer investigating the breach will not issue penalty points.
- j) The Licensing manager will determine any appeals in relation to the imposition of penalty points. Only written appeals will be considered.

#### 2. Actions

- a) On the accumulation of 12 or more penalty points in a rolling twelve month period a driver will be subject to a recommendation to suspend his/her licence.
- b) On accumulation of 12 or more penalty points in a rolling twelve month period a driver/owner will be subject to a recommendation to suspend his/her licence.
- c) On accumulation of 24 or more penalty points in a twelve month period an operator will be subject to a recommendation to suspend his/her licence.
- d) Where a letter is sent to a driver, a copy will be forwarded to the relevant vehicle owner or operator.

#### 3. The suspension process.

- a) All suspensions will be determined by regulatory panel
- b) On accumulating 12 or more penalty points a driver or driver operator will be advised in writing that his/her licence is the subject of a possible suspension.
- c) On accumulation of 24 or more penalty points an operator will be advised in writing that his/her licence is the subject of possible suspension.
- d) The licence holder will be advised of the accrued total of penalty points and the specific infringements identified. The licence holder will be advised of the details of the regulatory panel that will hear the case for suspension.
- e) For drivers or driver/owners the first occasion with the accumulation of 12 or more points within a twelve month period the recommendation will be suspension for 28 consecutive days.
- f) For drivers or driver/owners a second occasion with the award of 12 or more penalty points the recommendation would be for suspension for 56 consecutive days.
- g) A third accumulation of 12 points by a driver or driver/owner would result in a recommendation to revoke his/her licence(s).
- h) An operator accumulating 24 points on the first occasion would result in a recommendation to suspend their operators licence for 28 consecutive days.
- A second accumulation of 24 points would result in a recommendation to suspend their operators licence for 56 consecutive days.
