(3) That discussions take place between the relevant parties and the Local Ward Councillors for the provision of appropriate Hackney Carriage Taxi Rank provision as part of the proposed new scheme for the Bus Station in Holmfirth.

**Decision:** (1) That the following changes be approved to the current criteria on vehicle age limits for licensed vehicles:-

(a) Applications for Hackney Carriage/Private Hire Vehicles be considered for first licensing up to six years of age.(b) That an open age limit be applied to London Cab type vehicles, but after reaching 15 years the vehicles be subject to a minimum twice yearly compliance test.

(2) That the Licensing Manager be requested to submit a report to the Committee in respect of Category C and Category D Insurance Vehicle Right Offs.
