1. Purpose of report

To consider and approve attendance at the West Yorkshire Regional Standards Conference.

2. Key points

The Monitoring Officers of the five West Yorkshire Councils, namely Kirklees, Leeds, Bradford, Wakefield and Calderdale, have agreed to organise a West Yorkshire Regional Standards Conference. The purpose behind the conference is to allow all members from those five Standards Committees to meet together, to share experiences and issues arising from local determination, to hear from representatives from the Standards Board for England and to have an opportunity to network generally.

Whilst the Standards Board for England arrange a national conference in October of each year, this is not accessible to all members due to cost and time commitments, and allows a limited opportunity for members to meet colleagues from neighbouring authorities. This regional conference will be held, initially as a one-off, to allow every Standards Committee member the opportunity to attend. If successful, the Monitoring Officers will review whether to hold further similar events. A draft outline of the programme for the conference is attached for information. The event will be held in Bradford City Hall on 9 July 2009. The cost per person attending is not yet confirmed, but will be a minimal cost to cover refreshment costs.

Councillor Mehboob Khan, the Leader of Kirklees Council who is also a member of the Standards Board for England, will attend the conference as will Paul Hoey, the Standards Board for England Director of Strategy and Guidance. There will be an opportunity to raise issues with those two speakers and also to ask them questions.

3. Implications for the Council

This is an excellent opportunity for members of the Standards Committee to meet and share experiences with colleagues in a similar position. A well-informed Committee will be better able to perform its functions effectively.
