1. Apologies for absence

Apologies had been received from Nicky Rogers (Special School Heads), Simon Sloan (Primary School Heads) and Loz Wilson (Secondary School Heads).

2. Minutes of the Schools Forum Public meeting held on 12th December

The minutes were agreed to be a true record of the meeting.

3. Matters arising from the Schools Forum meeting 12th December

No matters were raised.

4. Final funding submission to the Education Funding Agency (EFA) for 2015-16

The last Forum meeting on the 12th December 2014 was held before local authorities had received details from the EFA of the new data set (to govern 2015-16 Schools Block Funding allocations) and confirmation of their 2015-16 Dedicated Schools Grant (DSG) allocation. The 12th December meeting recorded decisions to finalise both the 2015-16 retained DSG budget account and the 2015-16 de-delegation pattern for the maintained schools sectors. The Education Funding Agency deadline for submission of the final 2015-16 Schools Block allocations to local schools and academies was Tuesday 20th January 2015. The attached report summarises for Forum the main developments between their 12th December meeting and the final submission of arrangements to the EFA. The paper provided details about the following topics: -

- The securing of local political sign-off for the final funding submission to the EFA
- An overview of Kirklees' 2015-16 DSG funding settlement compared to 2014-15
- An explanation of adjustments made between the three funding blocks to address internal pressure points
- An explanation of how some funding factor values have changed for 2015-16
- Confirmation of the EFA's acceptance of our submission and when Budget Share notifications were notified to maintained schools.

Forum members were consulted and kept informed about the above developments before the final submission was made.

5. Maintained Schools Budget Share allocations 2015-16

A summary analysis of 2015-16 Budget Share allocations to local maintained schools was one of today's agenda papers. [Academies were excluded from the analysis because, although the Schools Block part of their Budget Share is determined by the local authority's formula, the remaining part of the allocation is determined by the Education Funding Agency, so like-for-like comparisons are not possible].

The analysis showed for each maintained school their 2015-16 Budget Share and its component parts...

- The Schools Block local funding formula
- Specialist Provision funding (where applicable)
- Top-up funding for High Needs pupils
- (Estimated) Early Years funding for schools offering the free nursery entitlement
- Pupil Premium allocations
- Service Children Pupil Premium allocations

To give some context to the allocations, the spreadsheet also gives the equivalent Budget Share figures for 2014-15 and plots the change between the two years in terms of cash difference and percentage change in budget. For the larger differences listed there are notes provided in the end column to highlight the main reasons underlying the change.

CONSTITUTION AND TERMS OF REFERENCE

BACKGROUND, PURPOSE AND PRINCIPLES

The Kirklees Schools Forum is operated in accordance with the Department for Education and Skills 'Schools Forums (England) Regulations 2012' which lays down the statutory instruments in respect of the establishment of the forum, membership, and constitutional, procedural and administrative matters.

The purpose of the Kirklees Schools Forum is to provide unambiguous professional advice and strategic direction from Headteachers to education decision-makers regarding the funding of schools. The forum is a representative group of service providers who are required to use the variety of funding streams to ensure coherent educational provision for children and young people to maximise the positive impact of funding on the quality of teaching & learning and standards.

TERMS OF REFERENCE

1.1. The Kirklees Schools Forum provides a formal channel of communication between Kirklees LA and schools and serves as the principal mechanism for consultation and decision making relating to the funding of schools.

1.2. The Forum consults on any proposed changes to the school funding formula, and specifically any changes in relation to the factors and criteria, methods, principles and rules used to calculate schools budgets and the financial effects of any proposed changes.

1.4 The Forum acts as a consultative body on issues relating to:

- Changes to the local funding formula
- Proposed changes to the operation of the minimum funding guarantee
- Changes to new contracts affecting schools
- Arrangements for the education of pupils with special educational needs, in pupil referral units and in early years provision.

1.5 The Forum is responsible for decisions on:

- The amount of funding to be centrally retained within the Dedicated Schools Grant
- Proposed carry forward of deficits on central spend from one year to the next
- Proposals for de-delegation of funding from maintained primary and secondary schools
- Changes to the scheme of financial management

MEMBERSHIP

2. The membership of the Forum shall be at least 19. The membership shall be divided into school and non-school members, ensuring fair representation across all phases including early learning providers and the Pupil Referral Units, and including representation from local academies. The mechanisms for nominations of members, and their terms of office, are outlined in the Forum Protocols.

3. The non-school members will constitute a maximum of one-fifth of the total membership of the Forum to represent PVI providers of early learning and childcare, teaching unions, governors and Post 16 providers.

4. The schools members, who are drawn from headteachers of existing schools, will reflect the proportion of pupils in primary and secondary schools maintained by Kirklees LA (confirmed by an annual review of pupil

numbers). Of the total number of places available on the Forum for school members there shall be one representative for special schools, the Pupil Referral Units, middle schools and nursery schools.

5. Kirklees Council elected members, including the Portfolio Holder for Children and Young People, are invited to attend meetings but may not be appointed as a member of the Forum. Other interested parties may be invited to attend meetings, in line with the Forum protocols. A representative from the Education Funding Agency (EFA) may attend as an observer and participate in discussions to support the local process and provide a national perspective.
6. The Local Authority is represented by an officer nominated by the Director of Children and Young People's Service and by the Chief Finance Officer. Additional officers attend, as invited, to contribute to discussion or set agenda items.
7. The composition and membership of the Kirklees Schools Forum is available online on the Kirklees Council Schools Forum website. All representatives or nominatives shall be appointed as members for an initial term of three years, which may subsequently be reviewed through re-election or re-nomination in a subsequent process.

ADMINISTRATION

8. The clerking and officer support arrangements for Kirklees Schools Forum are provided through the appointed representatives from Council Finance and Children and Young People's Service
9. Forum meeting papers are available online on the Schools Forum webpage (<http://www.kirklees.gov.uk/community/parentsCarers/schools/schoolsForum.aspx>). Agendas and minutes are available 5 working days before each public meeting, and circulated to all members electronically. Papers from past meetings are available on the Council Meetings site for Kirklees Schools Forum (<https://www.kirklees.gov.uk/Secure/meetings/>).

CONDUCT OF MEETINGS

10. Timing and Frequency of Meetings

Public meetings of the Forum will take place on at least three occasions per year/one occasion per term. However the volume of business may require meetings to take place more frequently. The dates, times and Venues of public meetings are published on the Schools Forum webpage.

11. Quorum

For Schools Forum to be quorate, 40% of members must be present. Inquorate meetings may proceed, but any key decisions may be deferred to a future meeting to ensure full representation of views.

12. Substitution

Members of the Forum may nominate appropriate substitutes, representing the same group of providers, to attend meetings in their place in the event that they are unable to attend themselves. Substitutions for school representatives can only be by headteachers from the same constituent group.

13. Voting

The decisions and recommendations required of the Kirklees Schools Forum will be agreed at the start of discussion. On items relating to funding formulae, only schools, academy and PVI setting members can vote.

The Forum aims to arrive at such decisions and recommendations by actively building a consensus around a proposed course of action. Details of situations requiring a vote and voting procedures can be found in the protocols.

14. Declarations of Interest

Schools Forum members should, for reasons of probity, be aware of circumstances in which they should withdraw from meetings due to a conflict of personal interest.

15. Right of Attendance

Kirklees School Forum Public Meetings are open to all. The Forum may also invite, by agreement, individuals to attend a meeting to provide information or reports. Visitors should be asked to leave if confidential items are discussed, unless the Forum have asked them to take part in a specific discussion. Additional briefing meetings may be called to enable discussion on detailed areas of funding in line with the EFA timetable for the submission of information.

ARRANGEMENTS FOR CHAIR AND VICE CHAIR

16. Election of Chair / Vice Chair

The Forum shall elect a chair and vice chair by a majority of votes cast on an annual basis at the first meeting in the academic year. The term of office of the chair will run until the first meeting in the following academic year

WORKING ARRANGEMENTS

17. Sub Groups

The Kirklees Schools Forum may establish sub groups and/or working groups on an adhoc basis for the consideration of specific matters as it deems necessary and shall decide upon the terms of reference for such groups and on additional individuals to invite as deemed necessary. The Forum shall consider the work of such sub groups or Working Groups and shall make decisions or recommendations to the LA as appropriate.

18. Kirklees Schools Forum budget / members' expenses

Forum determines the annual budget for meeting costs and support, and reimburses all reasonable expenses incurred by members engaged in the work of the Forum.

ARRANGEMENTS FOR REVIEW AND REVISION

20. Review of Terms of Reference:

The Terms of Reference, and associated protocols, are reviewed annually at the start of the new academic year, and more frequently as national changes and regulations require.
