1 Minutes of Previous Meeting

The minutes of the meetings held on 29 August, 6 September and 12 September 2017 were approved as a correct record.

2 Interests

No interests were declared.

3 Admission of the Public

The Panel considered admission of the public and determined that in accordance with the Licensing Act 2003 (Hearing) Regulations 2005 Regulation 14 the hearing should be heard in public as this was in the public interest.

4 Deputations/Petitions

No deputations or petitions were received.

5 Public Question Time

No questions were asked.

Application for Review Hearing Under S51 Licensing Act 2003 - Wisla Store, 31-33 John William Street, Huddersfield, HD1 1BL

The Panel considered an application made by West Yorkshire Police for the review of the premises licence for Wisla Store, under Section 51(1) of the Licensing Act 2003. The applicant believed that the following licensing objectives were not being met at the premises:-

- The prevention of crime and disorder
- Public safety

The Panel was advised that the application made by West Yorkshire Police followed a joint operation with Trading Standards on 22nd July 2017 where large amounts of non-duty paid tobacco products were discovered. The tobacco products were incorrectly marked and were not compliant with the Tobacco and Related Product Regulations 2016. The Panel was advised that a sniffer dog was used to help identify areas within the shop where tobacco was stored. The dog located a number of hidden compartments in the rear kitchenette area, as well as in the cellar area. The Panel was informed that a large quantity of cash was found in a safe in the building, which had subsequently been confiscated by the police under the Proceeds of Crime Act 2002.

A condition of the stores licence was that they must be a member of the Huddersfield Retail Radio Scheme, and that staff must have access at all times licensable activities are taking place to a retail radio. The Panel was advised that at the time of the hearing, the store had not become a member of the scheme.

Licensing Panel - 12 October 2017

The Panel heard representation against the review application and was advised that an employee of the store had admitted that he was responsible for obtaining the non-duty paid cigarettes and for secreting them at the premises. This employee had subsequently been dismissed. The Panel also heard that the £12,000 cash that was found at the premises had been generated in the proper course of business, and that the sum seized was due to be used to pay for rent, wages, suppliers and business rates.

The Panel having carefully considered all the representations made both verbally and in writing; and the options available to it decided that the licence be revoked.

In arriving at its decision, the Panel considered the written representations made by the objectors, the evidence presented at the hearing, the Council's Statement of Licensing Policy, the Licensing Act 2003, Regulations made there under; and the guidance issued by the Secretary of State under the Act.

RESOLVED -

The Panel determined that the licence should be revoked.

7 Application for Review Hearing Under S51 Licensing Act 2003 - Kingsgate News, 14 Cross Church Street, Huddersfield. HD1 2PT

The Panel considered an application made by West Yorkshire Police for the review of the premises licence for Kingsgate News, under Section 51(1) of the Licensing Act 2003. The applicant believed that the following licensing objectives were not being met at the premises:-

- The prevention of crime and disorder
- Public safety

The Panel was advised that the application made by West Yorkshire Police followed a joint operation with Trading Standards on 22nd July 2017 where large amounts of non-duty paid tobacco products were discovered. The tobacco products were incorrectly marked and were not compliant with the tobacco and related product regulations 2016. The Panel was advised that a sniffer dog was used to help identify areas within the shop where tobacco was stored. The dog indicated that a secret room was behind wooden panelling on the first floor of the shop. To gain entry to the room a compact disc had to be entered into a slot that tripped a micro switch which then released the magnetic door locks.

That Panel heard that despite a condition on the licence which stated that footage from the CCTV should be made available on request to a police constable or a representative of a responsible authority no-one at the premises at the time of the operation was able to operate the CCTV.

The Panel heard no representation against the review application by West Yorkshire Police.

The Panel having carefully considered all the representations made both verbally and in writing; and the options available to it decided that the licence be revoked.

In arriving at its decision, the Panel considered the written representations made by the objectors, the evidence presented at the hearing, the Council's Statement of Licensing Policy, the Licensing Act 2003, Regulations made there under; and the guidance issued by the Secretary of State under the Act.

RESOLVED -

The Panel determined that the licence should be revoked.

1. Summary

On 14 December 2017 an application to transfer the premises licence was received for the above Premises PR(A)1613, International Express, 27 John William Street, Huddersfield, HD1 1BL. The application is in the name of Mohamed Zada. A full copy of the application can be seen at appendix A.

On the 20 December 2017 an application to vary a premises licence to specify an individual as designated premises supervisor was received for the above premises naming Mehdi Karmi as the Designated Premises Supervisor (DPS). A full copy of the application from can be seen at appendix B.

2. Information required to take a decision

West Yorkshire Police have objected to both these applications.

The request to transfer the premises licence into Mr Mohamed Zada, the Applicant's name, is linked to selling non-duty paid tobacco products from this shop. A full copy of the Police objection can be found at appendix C along with evidence at appendix D.

Mr Mehdi Karmi (proposed DPS) was a full time employee at Wisla Store in 2014. While employed the premises was visited as part of a multi-agency enforcement plan where non-duty paid tobacco was found on the premises. Due to the links that Mr Karmi had to Wisla Store during this time, West Yorkshire Police feel Mr Karmi is not suitable to be a Designated Premise Supervisor. A full copy of the objection can be seen at appendix E along with evidence at appendix F.

3. Implications for the Council

We wish to make a formal objection to the transfer of the premises Licence for International Express, 27 John William Street, Huddersfield. HD1 1BL.

The reason we wish to object is that the applicant, Mr Mohammed Zada, 01/01/1987 is linked to selling none duty paid tobacco products from the shop. This is impacting on both the public safety licensing objective, as well as crime and disorder objective. It is also a straight forward criminal act of evasion duty.

Mr Zada has been involved in running the shop since May 2017, during that time a number of incidents involving none duty paid cigarettes have been witnessed by West Yorkshire police, culminating in a joint operation between West Yorkshire Police and trading standards, with assistance from Kirklees licensing dept.

West Yorkshire police also have an intelligence report from the 4th June 2017 naming Mr Zada as selling illegal cigarettes from International Express.



This is a redevelopment site for which no rateable value has been fixed attributable to the proposed development of a Hotel on the site. Building works have commenced and therefore a Band C fee is payable.

It is intended that the premises, when complete, will operate as a bespoke luxury hotel with related accommodation, dining and function facilities.

Both a formal and less formal dining offer will be made available to residents and members of the public. The offers will include a restaurant offering a' la carte fine dining in the evening and a less formal breakfast, brunch, lunch and afternoon tea offer throughout the day in the restaurant, bar and external areas (weather dependant). In room dining will also be available upon request.

The hotel was a former Kirklees Council building formally utilised as a remand home for young persons and was de-commissioned some years ago. It has stood dormant since that time before the sympathetic restoration of the main buildings and redevelopment of the grounds by the Applicant.

The restaurant, bar, multiple function areas, gym and a single luxury bedroom will be located at ground level a further 9 bedrooms and roof terrace area will be located on the first floor. A cellar bar will also be created as described on deposited plans.

The details of the development are shown on the drawings identified below, deposited with this application, in respect of which Planning Permission has been granted.

It is proposed that the permitted hours for licensable activities for these premises should be as follows:

- 1. For non-residents Monday Thursday 07.00 24.00 and Friday Sunday 07.00 02.00.
- 2. The sale of alcohol to residents will be available 24 hours per day, seven days per week.

The earlier commencement hour for the sale of alcohol to non-residents is sought to facilitate a limited service of alcohol with breakfast such as a Champagne celebratory breakfast or Bloody Marys, it is not anticipated that traditional bar services would commence before 10:00hrs daily.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the
 audience does not exceed 500. However, a performance which amounts to adult entertainment remains
 licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
- 3. Where taking place in a building or other structure please tick as appropriate (indoors may include a tent).
- 4. For example the type of activity to be authorised, if not already stated, and give relevant further details, for example (but not exclusively) whether or not music will be amplified or unamplified.
- 5. For example (but not exclusively), where the activity will occur on additional days during the summer months.
- 6. For example (but not exclusively), where you wish the activity to go on longer on a particular day e.g. Christmas Eve.
- Please give timings in 24 hour clock (e.g. 16.00) and only give details for the days of the week when you intend the
 premises to be used for the activity.
- 8. If you wish people to be able to consume alcohol on the premises, please tick 'on the premises'. If you wish people to be able to purchase alcohol to consume away from the premises, please tick 'off the premises'. If you wish people to be able to do both, please tick 'both'.
- 9. Please give information about anything intended to occur at the premises or ancillary to the use of the premises which may give rise to concern in respect of children, regardless of whether you intend children to have access to the premises, for example (but not exclusively) nudity or semi-nudity, films for restricted age groups or the presence of gaming machines.
- 10. Please list here steps you will take to promote all four licensing objectives together.
- 11. The application form must be signed.
- 12. An applicant's agent (for example solicitor) may sign the form on their behalf provided that they have actual authority to do so.
- 13. Where there is more than one applicant, each of the applicants or their respective agent must sign the application form.
- 14. This is the address which we shall use to correspond with you about this application.

15. Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- Is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this by providing with this application copies or scanned copies of the following documents (which do not need to be certified).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a
 British citizen or a citizen of the UK and Colonies having the right of abode in the UK {please see note below about
 which sections of the passport to copy}.
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder
 indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay
 indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.

- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating
 that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay, in the UK, when
 produced in combination with an official document giving the person's permanent National Insurance number and
 their name issued by a Government agency or a previous employer.
- A full birth or adoption certificate issued in the UK which includes the name(s) of at least one of the holder's parents
 or adoptive parents, when produced in combination with an official document giving the person's permanent
 National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in
 combination with an official document giving the person's permanent National Insurance number and their name
 issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official
 document giving the person's permanent National Insurance number and their name issued by a Government agency
 or a previous employer.
- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work
 and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable
 activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder
 which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on
 of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an
 endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a
 condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in
 combination with an official document giving the person's permanent National Insurance number and their name
 issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with
 the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable
 evidence that the person has an appeal or administrative review pending on an Immigration decision, such as an
 appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who
 is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK
 including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy or the following pages should be provided:-


- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (III) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

We would like to oppose the application of license by The Manor House to sell/provide alcohol and play music until 2am on Fridays, Saturdays and Sundays. The Manor House is in the heart of Lindley's residential area and is surrounded by homes. It is not appropriate that a venue in a residential area is allowed to be open, sell alcohol and play music until the early hours of the morning. A similar venue in Mirfield, Northorpe Hall, which is also in a residential area has a very limited license and we think that The Manor House should also be subjected to the same rules.

There are now a number of late night venues in the heart of Lindley which are causing problems for the residents in the early hours of the morning, i.e after midnight, including anti social behaviour by intoxicated people; beeping of taxis etc. Lindley is a mixed use locality for living, shopping and socialising however, it seems that some late night businesses forget that people also live here. Due to the location of our home, we are already disturbed most weekends by noise associated with people who have drunk far too much alcohol.

We would like to strongly oppose this license and ask the Council to reject this application.

Application 143924 Manor House, Lindley.

I live at 2A Lidget Street. Lindley, directly opposite this new venue. I wish to make several objections to the application 143924.

- 1) I object to the supply of alcohol for consumption on and off the premises until 2.00am for the following reasons:
- a) I live directly opposite this venue, my house is slightly below the level of the road, this means that cars and taxis leaving the venue will shine their headlights directly into the 2 main bedrooms in my house and cause us to wake up.
- b) Allowing the venue to sell alcohol until 2am and allowing for drinking-up time, will mean that taxis will be arriving and leaving, along with some of the guests until 3am in the morning.
- c) Allowing this to happen on a Sunday evening/Monday morning has an impact on those of us trying to sleep ready for work or school on Monday morning. It is unacceptable.
- d) Some people already use the Clock Tower as a convenient place to arrange to be picked up in a taxi after a night out "on Lindley". So, those of us living there are woken by car doors and voices between 11.30 and 12.30 as people are collected.

Others use the Clock Tower as a convenient drop off point after an evening out in Huddersfield, this involves lots of slamming car doors, shouts of goodbye and often loud conversations about other people or the cost of going out etc. These happen between about 12.30 -2.00 am. Allowing Manor House to sell alcohol until 2.00am just extends all of this noise and disruption for another hour.

e) Allowing Manor House to sell alcohol for consumption off the premises just makes it permissible for the local Sainsburys store to ask for an extension to their licensing hours.

Please spare a thought for the ordinary people who have to live here. This is not in a city centre where you might expect hours to be extended if you chose to live there. This is a residential area which is very quickly being turned into a commercial area with all the disadvantages of noise, pollution from busy roads and disruption.
