#### 1 Membership of the Committee

Councillor Jim Dodds replaced Councillor Karen Allison as a panel member.

#### 2 Minutes of Previous Meeting

That the minutes of the meeting of the Panel held on 12 October 2017 be approved as a correct record.

#### 3 Interests

No Interests were declared.

#### 4 Admission of the Public

All items on the agenda be considered in public session.

#### 5 Deputations/Petitions

No deputations/petitions received.

#### 6 Public Question Time

No questions were asked.

#### 7 Member Question Time

No questions were asked.

8 Objection to transfer premises licence to be granted AND to vary a premises to specify an individual as designated premises supervisor under Section 37 of the Licensing Act 2003 at International Express, 27 John William Street, Huddersfield, HD1 1BL

The Panel considered 2 objections made by West Yorkshire Policy to the application to transfer a premises licence and to vary a premises to specify and individual as Designated Premises Supervisor in respect of International Express under the Licensing Act 2003.

The Members of the Licensing Panel which considered the Applications were Councillor Carole Pattison (Chair) and Councillors Dodds and Watson.

Mr Woodhead, West Yorkshire Police, explained that the police had received intelligence that International Express was involved in selling non-duty paid tobacco products. On the 19<sup>th</sup> and 20<sup>th</sup> December 2017 joint operations between West Yorkshire Police and Trading Standards were made at which a large amount of non-

duty paid tobacco was found hidden in a closed compartment, opened by a trip switch and a further amount was found secreted behind a mirror.

Although Mr Zada told the police that he had only bought the shop four days before the joint operation, Mr Woodhead submitted that he was complicit in the sales of non-duty paid products, as he had worked in the shop for a number of months before the joint operation. Mr Woodhead informed the Panel that Mr Zada had been arrested on four occasions at the premises between 28th April 2017 and December 2017. He also explained that there had been a total of six assaults and three public order offences within the premises since 13th April 2017.

The Panel was informed by Mr Woodhead that West Yorkshire Police also objected to the second application for the transfer of the Designated Premises Supervisor for the premises to Mr Karimi.

Mr Woodhead explained to the Panel that Mr Karimi was a Kirklees personal licence holder and was a full time employee of Wisla Store in 2014. On the 30th October 2014, a multi-agency visit was carried out to the Wisla Store where non-duty paid tobacco was found at the premises.

Mr Zada informed the Panel that since 27<sup>th</sup> April he had been in partnership at International Express with the previous owner. Mr Zada explained that he officially took over the premises on 15<sup>th</sup> February 2017 and bought the shop, sold as seen without doing an inventory. Mr Zada informed the Panel that he was unaware of the non-duty paid tobacco, and that he suspected that his former business partner had called the police to inform them of the products. Mr Zada explained that the assaults that he had been arrested for involved his former business partner as he had disagreements with him when at the premises.

Mr Zada also informed the Panel that it was no longer his intention to transfer the DPS to Mr Karimi.

**RESOLVED** – That the application to transfer a premises licence and the application to vary a premises to specify an individual as Designated premises Supervisor under Section 37 of the Licencing Act be refused.

The Panel decided that granting the application to transfer the premises licence would be contrary to the Licensing Objective of the prevention of crime and disorder. The Panel was concerned about the amount of time that Mr Zada had worked at International Express, but claimed to be unaware of the non-duty paid tobacco. The Panel found that the non-duty tobacco had been traded at the store whilst Mr Zada was a partner there.

The Panel also decided that the application to vary premises to specify an individual as Designated Premises Supervisor to Mr Karimi would also be contrary to the Licensing Objectives of the prevention of crime and disorder. The Panel felt that Mr Karimi was not a fit and proper person to hold the DPS at International Express, given that he was a supervisor at Wisla store when non-duty tobacco was found on the premises. The Panel found that either Mr Karimi was aware of the hidden tobacco or he had not properly supervised the store to allow the non-duty paid tobacco to be sold.

# 9 Objection to vary a premises to specify an individual as designated premises supervisor under Section 37 of the Licensing Act 2003 at Ryan's Newsagents, 13 Kirkgate, Huddersfield, HD1 1QS

The Panel then considered an objection made by West Yorkshire Policy to vary a premises to specify and individual as Designated Premises Supervisor in respect of Ryan's Newsagents under the Licensing Act 2003.

Mr Woodhead informed the Panel that Mr Zadeh had become the DPS of International Express on the 28<sup>th</sup> December 2016 and was in day to day control of the building and the business.

On the 22<sup>nd</sup> July 2017 Trading Standards carried out a test purchase at International Express where non-duty tobacco was found.

On the 29<sup>th</sup> November and 7<sup>th</sup> December 2017 PC Nichols of West Yorkshire Police witnessed sales of non-duty paid tobacco from the shop.

Mr Woodhead explained that Mr Zadeh was the DPS at International Express up until 18th December 2017. International Express was then the target of a joint operation with Trading Standards on the 19th December 2017, the day after Mr Zadeh resigned. A large amount of counterfeit and non-duty paid tobacco products were discovered in various hidden locations within the shop.

**RESOLVED** – That the application to vary a premises to specify an individual as Designated Premises Supervisor under Section 37 of the Licencing Act be refused. The Panel was concerned about the non-duty paid tobacco that was found when Mr Zadeh was the DPS at International Express and concluded that he was not a fit a proper person to be DPS at Ryan's Newsagents.

# 10 Application for the GRANT of a premises licence on behalf of The Manor House, 1 Lidget Street Lindley, Huddersfield, HD3 3JB

The Chair invited Mr Anwar Butt, Licensing Officer to outline the application. In summary, the Panel was informed that on the 28 November 2017, the Licensing Department received an application for the grant of a premises licence for The Manor House Lindley. The site had undergone extensive redevelopment and would operate as a bespoke luxury hotel with dining and function facilities.

The Panel was informed that in response to the application, two local residents had submitted representations objecting on the grounds that the prevention of public nuisance licensing objective will not be achieved.

No representations were received from any of the Responsible Authorities.

Environmental Health Service had made some suggestions which were agreed by the applicant.

The Chair then invited John Gaunt, John Gaunt & Partners to present the case in support of the application. In summary, referring to a document that had been submitted prior to the meeting, the Panel was advised that the building was previously owned by the Council. It had since been purchased and the redevelopment of the site would see premises of the highest quality with an investment inward of £4.5million. The premises would offer, hotel, dining and function facilities. The front part of the building would open in March and the rear of the premises in April. The Panel was advised that it is important for the function facilities that the terminal hour of operation be 02:00.

Mr Gaunt further informed the Panel that the building would have sophisticated double glazing to minimise noise emanating from the premises. The screen of trees would minimise any nuisance to residents from headlights, there would be no passing trade after midnight and the courtyard was in a completely enclosed area.

Following questions, the Panel was advised that the premises would employ thirty people with the aim to double this to sixty with at least five apprentices.

Mrs Moran and Councillor Cahal Burke were invited to put forward their representations. Mrs Moran expressed concern about the adverse effect this venue would have on the neighbourhood, given its proximity to residential properties. This was particularly in relation to the roof terrace which was approximately 120 metres from her bedroom and the entrance being approximately 25 metres from her home. She explained to the Panel the potential disturbance this would cause and that the hours requested for the roof terrace appeared to differ with the hours stipulated by planning.

Cllr Burke made representation on behalf of residents who were unable to attend the meeting. He stated that while he welcomed the development of this site as it had previously been a site for anti-social behaviour, vandalism and had become an eyesore, residents were concerned about the venue operating until 02:00.

The Panel sought clarification from the Licensing Officer on the operating times of other licensed premises in the area. The Panel was advised that the Lindley Tap Bar and Grill opens until 02:00 on Fri – Sat 02:00; and The Old Wire Works Sat until 2.00am. Both these premises were in the vicinity of the Manor House.

**RESOLVED –** That the application for the GRANT of a Premises Licence of behalf of The Manor house be granted as requested, with no additional conditions applied. The Panel was satisfied that granting the licence as requested by the applicant would not be inconsistent with the licensing objectives.

#### 1. **Summary**

On 09 January 2018 West Yorkshire Police made an application for the review of the premises licence under Section 51(1) of the Licensing Act 2003. The applicant believes that two of the four Licensing objectives are not being achieved at this premises, being:

- The prevention of crime and disorder
- Public safety

Full details of the grounds for the review are contained in the attached review application at Appendix 1.

#### 2. Information required to take a decision

The key information required to make a decision is contained in the initial application from West Yorkshire Police. Below is the background information relating to the premises and its licence.

The premises has benefited from the premises licence, PR(A)1613 since December 2016. The current premises licence holder is Mohammad Zada. Mr Zada took over the premises licence on 14 December 2017. Due to Mr Zada being linked to selling non-duty paid tobacco products from this shop. West Yorkshire Police objected to the transfer which was refused at a hearing on 25 January 2018. Currently Mr Zada has 21 days from receipt of his letter to appeal the decision.

#### 3. Implications for the Council

3.1 Policy considerations (extracts from Kirklees Licensing Policy 2015-2020).

Para 2.3 Licensing Objectives

The Policy promotes the four licensing objectives contained in the Act and each has equal weight.

- The prevention of crime and disorder;
- Public Safety;
- The prevention of public nuisance:
- The protection of children from harm;

Para 7.9 The Licensing Authority will determine any application by considering the Act, the statutory guidance, this Policy and the four licensing objectives including how it may support other key aims, strategies and objectives.

Para 7.10 The following factors would normally be considered (although other relevant matters may be considered as the individual case dictates):

- The type of use, the numbers and type of customers likely to attend the premises;
- The proposed hours of operation;
- The level of public transport accessibility for customers either arriving or leaving the premises and the likely means of public or private transport that would be used by the customers;
- The impact of car parking on local residents or businesses;
- The scope for mitigating any impact;
- How often the activity occurs.

and, in considering any application the Licensing Authority may also take into account

- historical evidence, whether favourable or adverse, relating to activities carried out at the premises, especially on local residents or businesses;
- and where adverse impact has been caused, appropriate measures have been agreed and put into effect by the applicant to mitigate that adverse impact.

Additionally in accordance with regulation 39 of the Licensing Act 2003 (Premises Licences and Club Certificates) Regulations 2005, Officers from Kirklees Licensing Service arranged for advertisement of the review including being posted on the premises for 28 days and on the public notice board at the licensing office. Interested parties and responsible authorities are therefore allowed to make additional representations during that 28 day period. The period of advertisement ended on 06 February 2018.

No response was received from each of the responsible authorities; however information from Environmental Health is contained in the representation made by Licensing.

#### 6. **Next steps**

In determining the application the panel can take such any of the steps as it considers necessary for the promotion of the licensing objectives, which are:

- Issue warning with licence unaffected;



On the 19 <sup>th</sup> Dec 2017, a large amount of none duty paid and counterfeit cigarettes and hand rolling tobacco was found at the premises by trading standards and West Yorkshire Police The approximate retail value of the cigarettes is £3060, at the retail value of the counterfeit tobacco is £1405.		
On a return visit on the 20 <sup>th</sup> Dec 2017 a further cache of illegal cigarettes and tobacco pouches were discovered by the same agencies in the stock room of the shop. There were 37 packets of none duty paid cigarettes found, with an approximate retail value of £358, and the tobacco around £244		
Also on the return visit 110 bottles of Smirnoff Vodka was seized as it could not be identified by trading standards as to whether it was meant for sale in the UK. When asked for a receipt from a wholesaler showing who supplied the vodka the premises licence holder was unable to show any evidence as to where the vodka had been purchased from.		
Prior to the joint visits sales of illegal tob	acco products had been witnessed by town centre officers.	
In July 2017 a number of none duty paid	cigarettes were found in the premises by trading standards.	

#### RESTRICTED

Intelligence had been received that a number of town centre shops were selling counterfeit and none duty paid tobacco products with Huddersfield town centre.

One of the shops was International Express, on 27 John William Street,

A joint operation was put into place where the illegal products were found to be hidden and secreted in the shop.

What I need to demonstrate to you is that the premises licence holder was complicit in the sales, and the shop is a place of distribution for illegal, none duty paid products.

Mr Zada put an application in to the local authority to become the premise licence holder on the 18<sup>th</sup> Dec 2017, the day before the visit was made.

However Mr Zada has worked in the shop since it was granted a licence and the evidence I submit today will clear up and doubt that Mr Zada is not just a new shop owner who inherited the illegal stock.

I can confirm that Mr Zada has been arrested 4 times from within the shop from the 28<sup>th</sup> April 2017 to Dec 2017.

2 arrests for assault, and two for public order offences while working in the shop.

The dates of the arrests are:

28th April 2017 Assault

23rd June 2017 Public Order Offence

29th June Public Order Offence.

2<sup>nd</sup> Sept 2017 Assault

West Yorkshire police also have an intelligence report from the 4<sup>th</sup> June 2017 naming Mr Zada as selling illegal cigarettes from International Express.

Since 13<sup>th</sup> April 2016 the shop has had six assaults and three public order offences committed within the premises.

Because of the strong possibility that the International Express shop was selling illegal products town centre officers started to observe the shop and the sales made from within the licensed area.

On the 29<sup>th</sup> Nov PC Nicholls observed a sale made to a customer, of illegal cigarettes, the customer made a statement to PC Nicholls that they had definitely bought the cigarettes from the shop.

Further sales were witnessed by PC Nichols on the 30<sup>th</sup> Nov, and on the 7<sup>th</sup> Dec 2017. Statements were taken from the customers stating the shop had sold the illegal cigarettes.

Because of these incidents a joint operation was set up between West Yorkshire Trading Standards, West Yorkshire Police and Kirklees Licensing Department.

On the 18<sup>th</sup> Dec a test purchase was made by a plain clothes trading standards officer where a packet of none duty paid cigarettes were bought.

On the 19th Dec 2017 the shop was visited by the joint operation team, where the

following products were found to be secreted in a false panel above the back door exit of the shop. (photo one)

316 packets of counterfeit and none duty paid cigarettes, with an approximate retail value of £3060.

Also 145 pouches of counterfeit tobacco, 50 grams with a retail value of £1404.

The shop assistant who was in the shop at the time stated he had only been working for one day, and Mr Zada was in overall control.

On the day after, the 20<sup>th</sup> Dec 2017, a second visit was carried out to the same shop, where a further stash was discovered behind a mirror, to open this cache you needed to trip an electronic switch. (photo 2 and photo 3)

Within the alcove was discovered 37 packets of counterfeit cigarettes and 12 pouches of tobacco, with a combined retail value of £602.

West Yorkshire police also seized 110 bottles of Smirnoff vodka as It could not be identified as to whether it was meant for the UK market, The owner Mr Zada could not produce a receipt showing where he had purchased the vodka from.

Mr Zada has a complete disregard to UK law, and is willing to put the people of Huddersfield's health at risk by selling counterfeit and none duty paid tobacco products. He is also defrauding the UK government of much needed revenue by not paying excise duty on the tobacco.

The guidance on section 144 of the licensing act, keeping smuggled good on licence premises states that this is a serious offence.

Other premises' in the Kirklees area have lost their ability through licence revocation to sell alcohol, , and so I respectfully ask that the panel strongly agree to revoke this licence, in order to send a firm message to other retailers who are thinking about selling such products
