1 Membership of the Committee

Apologies for absence were received from Cllr Paul Davies, Cllr Richard Smith, Cllr Amanda Pinnock and Toni Bromley (Co-optee).

2 Minutes of the Previous Meeting RESOLVED -

The minutes of the meetings of the Panel held on the 16th December 2019 were agreed as a correct record.

3 Interests

No interests were declared.

4 Admission of the Public

All items were considered in public session.

5 Deputations/Petitions

No deputations or petitions were received.

6 Public Question Time

No questions were received from the public.

7 Number and Age of Children in Care

The Panel considered a report giving an update on the number and age of children in care presented by Julie Bragg, Head of Corporate Parenting (Children in Care and Care Leavers).

In response to a question from the Panel relating to the number of children in care under 1 year old, Julie Bragg advised that there had been an increase in numbers following more pre-birth assessments and plans had been agreed for some children to come into care. The Chair of the Panel, Cllr Marchington, agreed to discuss this matter in more detail at the Lead Member Briefings and report back to the Panel.

In response to a question from the Panel relating to the placement of young people in unregistered homes, Mel Meggs advised that part of the plan for young people leaving care was for them to live in semi-independent accommodation when it was right for them to live without support. Mel Meggs further explained that some young people did not do well in children's homes and thrived when they moved into semiindependent accommodation and often made strides in that environment. Mel Meggs advised the Panel that it would not be appropriate for children to live in unregistered children's homes and Kirklees did challenge non-registered children's homes. The Panel was advised that all necessary checks were undertaken to ascertain if the home was the right place for the child but that it was often a complex issue. The Panel was advised that there had been a recent review of children in care by well qualified staff to ensure that all children were supported properly and officers had been looking at what provision was available in the next 2 years for the 16 plus age range. The Panel was informed that children leaving care still had a coperson until the age of 18 and that they could ring that person should they have any issues. Mel Meggs advised the Panel that it was important to the Service to nurture good relationships between young people leaving care and the Independent Reviewing Officers. Mel Meggs advised the Panel that the Independent Reviewing Officers would check that the quality of care was up to the required standard and as they were independent they provided challenge to the Children's Service and could also escalate issues if necessary.

In response to a question from the Panel relating to reducing the number of children placed outside Kirklees, Julie Bragg advised that the Council was constantly trying to reduce this figure but some children wished to stay in the area where they had been placed due to networks and attachments formed and schools that they were attending. The Panel was informed that placements of children in care outside the district were reviewed on a regular basis to ensure they were meeting the needs of the child. Tom Brailsford informed the Panel that the Council's ambition was to place as few children as possible outside the district and that officers were looking at a number of creative ways to achieve this. Mel Meggs advised that the Council's aspiration was to have no children living outside the area within approximately 5 years. The Panel was informed that the Children's Service were in discussions with other Local Authorities who did not have any children living outside the area to learn from their approaches and practices.

In response to a question from the Panel relating to how children in care felt about it and what their experiences were, Julie Bragg advised that the Children's Service did work with young people in care to help them to understand their situations which

could often be complex and that there were forums such as the Children in Care Council where officers could listen to children and their experiences. Julie Bragg assured the Panel that it was very important to the Service to listen to children as the services and support could only be improved if the Council learnt from their feedback.

Cllr Marchington advised the Panel that a report would shortly be considered by the Corporate Parenting Board on the Voice of the Child and agreed to share the report with the Children's Scrutiny Panel when it was available. The Panel requested that information be included in future reports on the voice of the child and their experiences and officers should demonstrate to the Panel that children were being listened to. Tom Brailsford advised the Panel that a lot of good work was being undertaken within the Service on the children's voice and how this could be embedded across the service.

In response to a question from the Panel regarding special guardianships and what support was offered to wider families, Julie Bragg advised that the Council continued to support the transition from birth to being cared for by family members to make sure the carers were confident and had the support team they required. Julie Bragg further explained that the Carer and Connected Support Team supported carers, families and grandparents and it was about their needs and those of the family and what support they required. The Panel was informed that Children's Services had been working closely with Grandparents Plus and a carer's independent support group had been set up that met regularly and was run by themselves.

RESOLVED -

- 1. The Panel noted the report on Number and Age of Children in Care and thanked Julie Bragg for her contributions.
- 2. The Panel agreed to visit the Independent Reviewing Officers to further explore the support they give to young people leaving care or living in semi-independent accommodation.
- 3. The Panel agreed that the voice of the child and their experiences should be clearly demonstrated in all future reports to the Panel.
- 4. The Chair of the Panel agreed to discuss the numbers of children in care under 1 year old at Lead Member Briefings and report back to the Panel.

8 Kirklees Children and Young People's Partnership Plan

The Panel considered a report on the new Kirklees Children and Young People's Partnership agreements and the draft Children and Young People's Plan presented by Tom Brailsford, Service Director (Resources, Improvements and Partnerships) and Mary White, Commissioning and Partnerships Manager.

Mary White informed the Panel that the Kirklees Children and Young People's Partnership was relaunched following consultation and engagement at an event in March 2019 which was attended by 80 participants from a cross section of organisations working with children in Kirklees. The new partnership model was developed at the March event and aspired to bring together collective insight, expertise and resources to collaborate to achieve the best start in life for children

and young people. The Children's Partnership identified a need to improve outcomes in 3 new priority areas which were:-

- To work to alleviate the impact of poverty on children;
- To support inclusion and better outcomes for LGBT+ young people;
- To grow the Council's youth offer places to go, people to see, things to do.

Tom Brailsford advised the Panel that a number of key performance indicators had been defined to inform the Service if the partnership arrangements were working as they should be.

In response to a question from the Panel relating to how success was measured and how confident the Service was that they were meeting their aspirations in terms of the Children and Young People's Partnership, Tom Brailsford agreed to bring a further update to the Panel in the future on this matter.

In response to a question from the Panel relating to the voice of the child and how this could be demonstrated, Tom Brailsford advised that formal boards were held where children could attend and give their opinion and children and young people would be asked to feedback into the Partnership Plan. Tom Brailsford informed the Panel that the voice of the child was very important to the Children's Service and that it was essential to engage with children and young people and talk to them about their experiences.

RESOLVED -

- 1. The Panel noted the report on the new Kirklees Children and Young People's Partnership agreements and the draft Children and Young People's Plan and thanked Tom Brailsford and Mary White for their contributions.
- 2. That the Panel consider a future report on the measures for success of the Children and Young People's Partnership.
- 9 Children's Scrutiny Panel Work Programme and agenda plan for 2019/20 The Panel considered the work programme and agenda plan for the 2019/20 and considered issues for inclusion.

Jo-Anne Sanders gave an update on the Almondbury Community School and highlighted the following key issues:-

- The Ofsted report for Almondbury Community School following the inspection in November 2019 was now available to view on the Ofsted website; Leaders and Managers at the School were taking effective action towards removing special measures:
- The Learning Service was focusing on planning the staff transitions and working with the partnerships at the school to begin the staff engagements and would update the Panel at future meetings on progress;
- An evaluation would be taken of the Greenside Building to ensure it would be fit for purpose to house primary age youngsters to meet their learning outcomes and work had begun to assess what was required;
- Further work was being undertaken with the King James Partnership to progress the investment in their physical space.

The Panel noted that future updates would be provided to the Panel on Almondbury Community School.

The Panel agreed to consider a report on the following:-

- SEND and the 10 point improvement plan March 2020;
- Elective Home Education Ad Hoc Panel Final report March 2020.

1. Summary


This graph shows the number of children in care (672 excluding any looked after children receiving only S20 short term breaks) alongside the number of unaccompanied asylum seeking children (UASC).

The current number of LAC equates to a rate per 10,000 population aged 0-17 of 67.1. This compares to a statistical neighbour average of 91.6 and a national average of 65.0 based on recently published data for March 2019.







This graph shows the ethnic breakdown of the children looked after population at the end of January 2020 and the same point 12 months ago. This has been relatively stable throughout the period.



This graph shows the percentage breakdown by ethnicity of children entering care this month. Note that this outcome is based on small numbers. In January 2020 there were 8 young people who were recorded as entering care at the point of data extraction in the month of whom 7 were White and 1 did not yet have an ethnicity recorded.

Children and Young People placed more than 20 miles outside of Kirklees

The number of looked after children placed outside Kirklees District and 20 plus miles from their home address was 85 on 31 January 2020. This follows a continuum of decline from a number of 127 in 2017. The majority of our children and young people placed out of area are placed in foster care, the remainder are placed in children's homes, semi-independent homes, a small number in youth custody or other specialist settings.

The current Number of Children and Young People placed outside Kirklees and more than 20 miles from home is 85. This equates to 12.6% of the total LAC cohort. The recent historical position is detailed below:

1. Summary

A report was provided to Children's Scrutiny panel on 16th December 2020 outlining the progress made in implementing the decision the remove the secondary phase of Almondbury Community School by 1st September 2020.

This report aims to provide Children's Scrutiny panel with a further update on progress including information previously requested about the Academy Trust sponsoring Newsome High School and Almondbury Community School as a Primary School.

2. Current position

Working in partnership with Almondbury Community School, King James's School, Netherhall High School and Newsome High School

The partnership between Kirklees, Almondbury Community School, King James's School, Netherhall High School and Newsome High School remains positive with all parties committed to achieving the best possible outcomes for all pupils affected by the closure of the secondary phase of ACS.

This has resulted in decisions being made across a number of areas of this programme of work, details of which are included in this report.

Allocation of school places for current pupils at Almondbury Community School (current years 7 to 10) from September 2020

All parents who submitted a preference were offered a place for their child at their preferred school from September 2020.

Where a preference was not submitted extensive support was offered to ensure to parental/carer preference was considered and that the child was offered a school place.

Remaining pupils were auto allocated a place in their PAA school, in all cases this resulted in a place being offered at King James's.

There is currently one child who has yet to be allocated a place for September, but this is due to them currently being involved in another process. Monitoring of this case continues, and support will be provided if required.

All the partner schools have been fully involved in this process and plans for transition are well underway. Communications directly from the chosen schools are expected during March which will include information about parental engagement opportunities.

Uniform support

Parents of children who have moved schools in-year have been contacted regarding provision of a contribution towards the cost of uniforms already purchased and these payments are currently being processed.

The process for providing items of uniform for pupils still to move has been agreed and information about this shared with affected parents. Free uniform vouchers will be issued to parents before the planned transition for their child/ren.

Admissions Arrangements

Follow temporary changes to priority admission areas agreed by the Office of the Schools Adjudicator for September 2020, steps have been taken to normalise these arrangements for 2021 onwards.

Following the required consultation, the proposal for King James's School change to their catchment area (PAA) to include the primary admission areas of Almondbury Community School and All Hallows' CE(VA) Primary School was agreed in February 2020.

Following the required local authority consultation the proposals to changes the catchment areas of Newsome High School to include Lowerhouses CE(VC) Junior, Infant and Early Years School primary catchment area and Netherhall Learning Campus High School to include parts of Moldgreen Community Primary School primary catchment area were agreed at cabinet on Tuesday 25th February 2020.

Staffing/HR

Briefings have taken place with all Almondbury Community School staff, keeping them updated on the process going forward.

All staff have been aligned to either the primary or secondary phase based on where they carried out the whole or majority of their duties within the school. Staff received individual letters advising them of the phase to which they had been aligned and were given a period of time to consider this and discuss if they had queries. This period has now ended, and subsequently staff are now aligned to either the primary or secondary phase.

Primary phase staff will be engaged in a formal consultation about a new staffing structure to be implemented for September 2020, the consultation will be starting in early March. The proposed structure for the primary phase for September 2020 has been discussed and agreed by the Interim Executive Board and this has been shared with the trade unions and professional associations.

ACS Staff have been informed of a deployment agreement that has been agreed with the three partner schools, and have started to be given early access to vacancies. Vacant posts at King James's School, Netherhall Learning Campus High School and Newsome High School have been shared with secondary phase staff providing them with an opportunity to apply for suitable positions ahead of wider advertising. Further opportunities are expected to follow.

Ofsted monitoring

Following the Ofsted monitoring visit that took place at ACS on the 12th and 13th November 2019 the outcome was published on 19th December 2019 in the form of a letter to the school. The inspector concluded "Leaders and managers are taking effective action towards the removal of special measures" and the local authority's statement of action is fit for purpose and that the school's improvement plan is fit for purpose

3. Implications for the Council

3.1. Working with People

We are continuing to work with the partnership of local schools to plan smooth transition arrangements for all pupils to ensure that all children and young people enjoy the best possible standards of care and education in a school which is sustainable for the long term.

We continue to meet with a small group of parents, and we are ensuring that parents, staff and other key stakeholders are fully informed of progress through a robust plan of co-ordinated communication across the partnership of schools and continue to offer opportunities for questions to be asked and for any concerns to be raised.

3.2. Working with Partners

Regular meetings continue to be held with the Almondbury Community School Interim Executive Board and with leaders of local secondary schools regarding the future of the secondary school pupils.

Regular meetings are taking place with staff, school leaders and trade unions around ensuring that staff are clear on the process and are aware of opportunities available to them going forward.

We are continuing to build relationships with Impact Multi Academy Trust who are the future sponsor for Almondbury Community School and we are ensuring that they are included in discussions relating to the future of the school to ensure that the school meets the needs of the primary pupils and is sustainable in the long term.

3.3. Place Based Working

Following the recent preferencing exercise, all current Almondbury Community School pupils have been offered a place at their preferred local school.

We continue to work with the local partnership of schools to ensure that all local children have access to high quality educational opportunities.

3.4. Climate Change and Air Quality

The close collaboration between the partnership of schools have enabled parents to access schools local to where they live. This is supportive of enabling sustainable travel to schools.

3.5. Improving outcomes for children

Throughout programme of works involved, improving outcomes for children is at the heart of everything. In addition to ensuring that there are sufficient secondary places in the local area we continue to aim to maximise opportunities to:

- Offer high quality and inclusive education and diversity of provision to all
- Provide a breadth of curriculum offer that enables young people to have access to the widest opportunities to fulfil their aspirations and ambitions
- Be financially viable and therefore have future security
- Promote equality of opportunity
- Strengthen community cohesion
- Use sustainable travel and transport for school

3.6. Other (e.g. Legal/Financial or Human Resources)

Plans are in place for a cabinet process for consideration and approval of financial commitments relating to capital works in schools.

Work as outlined above relating to staffing and HR is underway and clear processes and timelines are being developed in line with agreed policy. Communications and engagement with staff is a priority and we are working with all affected staff to keep them fully informed, to ensure that they are aware of opportunities available and that that they are supported throughout the process where possible to reach an outcome that is right for them.

4. Consultees and their opinions

Communication with all stakeholders and keeping them up to date with progress and key milestones remains a priority.

A co-ordinated plan of communications to coincide with secondary school national offer day was devised in order to share key messages around plans for all King James's school year groups from September 2020.

Briefings and individual meetings have been held with staff at ACS and Trade Union colleagues are being kept fully involved in the HR process as it progresses.

Engagement opportunities are being planned for parents of pupils in each year group to give them the opportunity to ask further questions and raise any concerns they may have about the planned changes.

5. Next steps and timelines

- Continue to work with local schools on high quality transition arrangements for all ACS pupils
- Continue with the review of the primary phase staffing structure to ensure that it is fit for purpose for September 2020
- Continue to support staff aligned to the secondary phase with opportunities
- Issue school uniform payments as soon as possible and vouchers in advance of planned transitions
- Begin cabinet process to discuss and agree capital projects in partner schools going forward
