1 Site Visit – Playworld, 140 Westbourne Road, Huddersfield

Site visit undertaken on the 2nd August 2022.

2 Minutes of Previous Meeting

That the minutes of the meeting held on 18th May 2022 were agreed as a correct record.

3 Interests

No interests were declared.

Councillor Adam Gregg declared for transparency purposes a brief conversation with an interested party, advice was not provided.

4 Admission of the Public

All agenda items were considered in public session.

5 Deputations/Petitions

No deputations or petitions were received.

6 Public Question Time

No public questions were asked.

7 Licensing Act 2003 - Application for the variation of a premises Licence: Playworld, 140 Westbourne Road, Huddersfield

The Panel considered a report, which outlined an application for a variation of a premises licence for Playworld, 140 Westbourne Road, Huddersfield.

All parties present confirmed that they had received a copy of amendments submitted by the applicant prior to the hearing.

The Licensing Officer outlined the application, and advised the panel that on 13th June 2022, the Licensing Department received an application for the full variation of existing premises licence for the premises at Playworld, 140 Westbourne Road, Huddersfield.

The licensable activities applied for, both indoors and outdoors, were as follows:

Sale of Alcohol (on and off the premises) Monday - Sunday	09:00 – 23:45
Performance of Dance Monday - Sunday	09:00 – 23:45
Indoor Sporting Events Monday - Sunday	09:00 – 23:45
Live Music Monday - Sunday	09:00 – 23:45
Recorded Music Monday - Sunday	09:00 – 23:45
Late Night Refreshments Friday and Saturday	23:00 – 23:45

The application also includes:

- To increase the premises perimeter to include an outdoor area
- Six occasions per year with an end time of 01:00am with no dates specified

The Panel was informed that in response to the application, 41 representations were received from residents, Ward Councillors, Environmental Health, Planning Services and Public Health. The representations considered the licensing objectives in respect of Public Safety, Prevention of Crime and Disorder, Prevention of Public Nuisance and the Protection of Children from Harm would not be achieved should the licence be granted.

In response to questions from the Panel, the applicant's representative gave an outline of how the business would operate, explaining that the business was purchased in October 2020, and at the time of purchase, the business evidenced a healthy account. When Covid19 restrictions came into force, it resulted in the business closing for seven months. The application to vary the licence would

provide another means of income due to the significant loss of business throughout the Covid19 pandemic, where customers no longer felt comfortable in an enclosed and confined space.

In summary, the Panel was further informed that the business employed approximately 30 staff, however due to the lack of custom, they had lost four members of staff and a chef. There have been no instances of public nuisance or anti-social behaviour and there was CCTV cameras in operation. Environmental Health had visited the premises and set sound limits for music played indoors, and food would be served from inside, where a ventilation system would be in place to minimise food odour.

The Panel then invited the objectors to make representations. Concerns were raised in relation to public safety, road safety issues and the potential for accidents caused by an increase in traffic, noise nuisance from noise emanating from the premises, crime and disorder and protection of children from harm.

The Environmental Health Officer in attendance, advised the Panel that the outdoor area could create noise levels that could not be regulated, and that the door to the south elevation was inadequate, allowing noise to escape and needed to be replaced.

The Planning Officer informed the Panel that the business was not operating within the hours stipulated by planning, and an application submitted in 2014 to amend those hours was not progressed. Therefore, the authorised operating hours for the business remains as 9am to 9pm.

The Panel was further advised that the land between the building and the properties on Westbourne Road has been vacant until recently and was not part of the curtilage for Playworld. For this area to be used as an outdoor play area, an application for a change of use would be required.

The Public Health Officer advised the Panel that noise radiating from the premises throughout the day and at night, could impact on residents' mental health and subsequently impact on physical health. The Panel was further advised that Public Health had also made recommendations regarding the sale of alcohol.

The Panel highlighted the concerns raised by local Ward Councillors relating to public nuisance, noise, and the proposed opening hours and the impact this could have on neighbouring residents.

Following careful consideration of all the representations received both verbally and in writing, the Panel determined that:

RESOLVED:

That the application for the variation of a premises licence be approved with additional conditions/amendments which are:

 Removal of the existing external door and replacement with an appropriate door approved by Environmental Health,

- That it be noted the amended application on appendix E did not include the car park area, and the licence be amended accordingly,
- That recorded music in the outdoor area be non-intrusive background music only, and restricted to the hours of 09:00 to 19:00 Friday and Saturday and 09:00 to 18:00 Sunday to Thursday,
- That the sale of alcohol in the outdoor area be restricted to the hours of 09:00 to 19:00 Friday and Saturday and 09:00 to 18:00 Sunday to Thursday,
- That the occasional extension to the license of up to 6 times a year from 09:00 – 23:45 be refused with a suggestion of a Temporary Events Notice to be requested for these events.

5 Application for the grant of a premises licence: Batley Superstore, 91 Commercial Street, Batley WF17 5EF

The Panel considered a report which outlined an application under section S51 of the Licensing Act 2003, for the Grant of a premises Licence, Batley Super Store Ltd, 91 Commercial Street, Batley.

The Panel was advised that on the 11th July 2022, the Licensing Department received an application for the new grant of a premises licence for Batley Super Store Ltd, 91 Commercial Street, Batley, WF17 5EF.

The licensable activities applied for were as follows:

Sale of alcohol (off the premises)
Sunday – Thursday – 07:00 – 23:00
Friday – Saturday – 07:00 – 23:59 (Midnight)

In response to the application, one of the ward councillors for the area expressed concern that should the licence be granted the licensing objectives in respect of the prevention of crime and disorder and the prevention of public nuisance would not be achieved.

Licensing Panel - 5 September 2022

The Panel was advised that West Yorkshire Police were consulted and had no concerns regarding alcohol issues and anti-social behaviour in the area. No representations were made by any of the other Responsible Authorities regarding the application.

The applicant's representative explained that the business was a small shop, selling everyday goods in a commercial area. The business had held a licence since 2016 with no complaints or problems. The applicant's representative advised that one of the main principles of the application was to ensure that the application fully supported the licensing objectives and was confident that the operating schedule put forward, satisfied those criteria.

RESOLVED:

That the application for the Grant of a Premises Licence: Batley Super Store Ltd, 91 Commercial Street, Batley, WF17 5EF be granted as requested.

6 Application for the variation of a Premises Licence: Woodman Inn, 6 Hartley Street, Dewsbury, WF13 2BJ

The Panel considered a report which outlined an application under the Licensing Act 2003, for the variation of a premises licence, Woodman Inn, 6 Hartley Street, Dewsbury.

The Panel was advised that on the 19thJuly 2022, the Licensing Department received an application for the variation of a premises licence for Woodman Inn, 6 Harley Street, Dewsbury, WF13 2BJ.

The applicant requested that condition 2, which was set by the Licensing Panel on 3rd March 2021, which stipulated that there should be "a minimum of two door staff to be employed on a Friday and Saturday night from 8pm until all customers have left", should be removed.

The Panel was advised that West Yorkshire Police had no objections to the request that condition 2 be removed. In addition, Environmental Health had reviewed the application and had no reports of any recent complaints.

The Designated Premises Supervisor, explained that it was no longer financially viable to employ two door staff, due to the low numbers of customers, and the premises no longer attracted younger customers.

RESOLVED:

That the application for the variation of a Premises Licence, specifically the removal of condition 2, which stipulates "A minimum of two door staff be employed on a Friday and Saturday night from 8pm until all customers have left", set by the Licensing Panel in March 2021, be granted.

1 Summary

- 1.1 On 4th August 2022, West Yorkshire Police made an application for the review of the premises licence under Section 51 of the Licensing Act 2003. The applicant believes that the following Licensing Objectives are not being met.
 - Prevention of Crime and disorder
 - Public Safety

Full details of the grounds for the review & exhibits are contained in the attached review application along with a location map at **Appendix A**.

2 Information required to take a decision.

2.1 Background

- 2.1.1 On 18th July 2022, the premises known as Rio Foods, 229A Bradford Road, Huddersfield was inspected by West Yorkshire Police and Trading Standards. During the inspection, they found concealed 2,357 packets of illegal cigarettes. If these were sold at the price of UK duty paid cigarettes, approximately £10.50 per packet, the value would be £24,748. A concealment was found hidden in the rear of a cabinet for 'pick n mix' sweets. Another concealment was found in a storeroom in the back yard of the premises.
- 2.1.2 West Yorkshire Police have submitted all the findings in the review application which includes the following: Exhibits 229A 229F, statements from a Police Officer and a Trading Standards Officer. This can be seen at **Appendix A**.
- 2.1.3 The current licence PR(A)1446 was issued on 5th September 2013, and can be seen at **Appendix B**.

2.2 Licensing Policy

Members considering the application should take note of the Authority's Statement of Licensing Policy, which provides the following guidance on how Members should approach the application and representation:

1.0 – Executive Summary

1.2 In exercising its duties and responsibilities under the terms of the Licensing Act 2003, the Council will operate within the statements and procedures mentioned in this policy statement. Notwithstanding this statement, all applications will be treated on their merits and judged accordingly. The council will have regard to any relevant guidance issued by the Secretary of State in exercising its powers under the Act.

2.0 - Purpose and Scope of the Licensing Policy

2.7 The Licensing Authority recognises that each licence application must be considered on its own individual merits in the context of the four licensing objectives, and that unless relevant representations are received from

responsible authority's or interested parties, there is no provision for a Licensing Authority to impose conditions on a licence other than those proposed within an

application. Only conditions which have been volunteered by the applicant or which have been determined at a Licensing Panel hearing can be attached to a licence or certificate. If no relevant representations are made in respect of an application, the Licensing Authority is obliged to issue the licence on the terms sought.

Licensing Objectives.

- 1. Public Safety
- 2. Prevention of crime & disorder
- 3. Prevention of public nuisance
- 4. Protection of children from harm

2.3 Secretary of State Guidance

Members also need to consider statutory guidance issued, by the Secretary of State, under Section 182 of the Licensing Act 2003. As the representations relate to two of the licensing objectives, Members attention is drawn to Section 2 of this Guidance, the relevant parts of which may be found at **Appendix C**.

3 Implications for the Council

3.1 Working with People

Residents of Kirklees need to be confident that persons holding licences under the Licensing Act 2003 are in a position to uphold the four licensing objectives. Taking appropriate and necessary action against licence holders where they fall short of their duties under the Licensing Act 2003 will prevent harm to residents.

3.2 Working with Partners

The Council's licensing team work closely with partnering agencies, classed as 'Responsible Authorities' under the Licensing Act 2003, these include Planning, West Yorkshire Police, Trading Standards, Environmental Health, Fire Service, and Safeguarding Children team.

3.3 Place Based Working

Working closely with Responsible Authorities the Licensing Authority can address issues within the districts that make up Kirklees.

3.4 Improving outcomes for children

A key objective of the Licensing Act is the protection of children from harm, and any decision made by the Council, in its capacity as Licensing Authority, have to have regard to this objective.

3.5 Financial Implications of people living or working in Kirklees

Any decision taken by members may have a financial impact on the applicant and or any objectors.

3.6 Other (e.g. Legal/Financial or Human Resources)

In determining the application Members should have regard to the Authority's licensing policy statement and the Secretary of State's Guidance. The applicant or any other person who made relevant representations in relation to the application have a right of appeal to the Magistrates' court.

4 Consultees and their opinions

A review has been called by the West Yorkshire Police. Consultation has taken place in accordance with the requirements under the Licensing Act 2003. There have been no matters arising from the other responsible authorities.

5 Next steps and timelines

- 5.1 When determining the review application Members, having had regard to the information in the application, may take any of the following steps as they consider appropriate:
 - a) Modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition);
 - b) Exclude a licensable activity from the scope of the licence;
 - c) Remove the designated premises supervisor;
 - d) Suspend the licence for a period not exceeding three months;
 - e) Revoke the licence.
- 5.2 Findings on any issues of fact should be on the balance of probability.
- 5.3 In arriving at a decision Members must have regard to the relevant provisions of statutory guidance and the licensing policy statement and reasons must be given for any departure.
- 5.4 The decision should be based on the individual merits of the application.

6 Officer recommendations and reasons

6.1 Members of the Panel are requested to determine the application.

Trading Standards had received intelligence that a number of shops in the Huddersfield area were selling illegal products. West Yorkshire Police had also been informed by members of the public that illegal cigarettes were being sold from Rio Foods.

The partnership agencies entered the shop and requested no customers enter the store while the search was carried out. A specialist tobacco dog was also used to search the premises.

The male behind the counter, Mr was informed a full search would be carried out of the premises, the lead agency was West Yorkshire Trading Standards.

The tobacco dog indicated that tobacco was hidden in the rear of a display for 'pick and mix sweets'. It was not immediately obviously where the tobacco was and took Trading Standards an amount of time to find a concealment hidden in the rear of the display cabinet. See photo 229a. This concealment had to be opened by a long pin hidden near to the cabinet which pressed a micro switch inside the cabinet and opened the concealment. 229b shows the cigarettes found.

Further cigarettes were found in a storeroom that was located in the back yard of the premises. Keys belonged to Mr as they had his car keys on them, opened a black side door 229c and then a brown door 229d where boxes and bags of cigarettes were found 229e and 229f.

When the cigarettes were found _____ `stated to PC 4346, hat he regretted selling the cigarettes and he would not sell them again. He went onto ask if he would lose his alcohol licence.

It is illegal to sell none duty paid tobacco products in the United Kingdom. The packets do not carry the correct health warnings, the warnings are not written in English and the act of selling none duty paid deprives the Treasury of much needed funds in this current economic climate.

The act of selling counterfeit cigarettes goes much further, not only removing finances from the U.K. Government, but is a major health risk to the people buying the tobacco. The substances used to bulk out the substandard tobacco does range greatly, none of which is fit for use by the tobacco industry.

None duty paid tobacco also encourages young people to smoke due to the price. Intelligence suggest that they are retailed between £5-7 where duty paid retails between £10-£14.

The Designated Premises Supervisor and the staff working in this shop have absolutely no regard for UK Law by selling such products. West Yorkshire police feel that the only option the panel should consider is revocation.

Officers attending the shop on 18th July 2022 noticed that the CCTV cameras were not pointing towards and were not filming the till counter area and also the concealment area. This would suggest that evidence of any sales was being concealed. It is a condition on licence PR(A)1446 Annex 2: for CCTV to be installed covering all licensable activity areas, the public entrances to the premises and entrance foyers and that alcohol will be stored behind the counter and will only be sold with assistance of staff.

The cameras not covering the till counter area is a breach of their current licence.

It was also observed by Officers that this premises does not sell any duty paid cigarettes but sells lighters and cigarette papers

A search of the store was conducted and illegal tobacco was found concealed in the back

store room built in to the back of the sweets shelf. The concealment was opened using a

pin to press a micro switch.

Keys were found leading to the store room accessed via the back yard. The store room was

full of illicit tobacco products and other stock for the shop. Illegal vapes were also seized.

I visually examined the tobacco products and could see they were not in the standardised

format as required by The Standardised Packaging of Tobacco Products Regulations 2015

and were in violation of the Tobacco and Related Products Regulations 2016 as the

prescribed health warnings were not present in English. From discrepancies in the

packaging on some cigarettes and from the foreign excise stamps present on others it was

clear to me the cigarettes were a mix of counterfeit and smuggled items. The total amount

seized was 47,140 cigarettes (2,357 x 20 packets of cigarettes) & 13 disposable vapes.

A criminal investigation is ongoing.

The sale of Counterfeit/Illicit Tobacco products is not a minor breach of regulations but is in

fact Serious Organised Criminality. These items which cannot be legally sold in the UK are

smuggled into the country on a vast scale to be sold at stores like Rio Foods. The Profits of

this illegal trade going to criminals while the treasury is deprived of the Tax/Excise. The

current yearly loss in revenue is in excess of £2.5 billion which in turn deprives public

services of funding.






ANNEX 1 - MANDATORY CONDITIONS

Alcohol

- 1. No supply of alcohol may be made under this licence:
 - a. At a time when there is no designated premises supervisor in respect of the premises licence, or
 - b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date or birth and either -

- a. a holographic mark, or
- b. an ultraviolet feature.
- 4. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1 of this condition -

- a. "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- b. "permitted price" is the price found by applying the formula $P = D + (D \times V)$ where -
- i. P is the permitted price,
- ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- c. "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- i. the holder of the premises licence,
- ii. the designated premises supervisor (if any) in respect of such a licence, or
- iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d. "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables

the member or officer to prevent the supply in question; and

- e. "value added tax" mean value added tax charged in accordance with the Value Added Tax Act 1994.
- 5. Where the permitted price would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 6. (1) Sub-paragraph (2) applies where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

ANNEX 2 - CONDITIONS CONSISTANT WITH THE OPERATING SCHEDULE

West Yorkshire Police Conditions

1. CCTV to be installed covering all licensable activity areas, the public entrances to the premises and entrance foyers.

The CCTV system installed and operated in accordance with Home Office/ACPO guidelines as adopted by West Yorkshire Police.

A competent person must be present during licensable activities that can operate the CCTV system. Footage from the CCTV system to be made available on request to a police constable or representative of a responsible authority as defined by the Licensing Act 2003 where the images are to be used in the prevention or detection of crime, the prosecution or apprehension of offenders or where the disclosure is required by law. The disclosure and request must be in accordance with the Data Protection Act 1998.

- 2. Incident and accident books to be maintained along with a refusal register detailing any attempted purchases by under age or drunken customers. These books to be made available for inspection on request of any police constable or representative of a responsible authority as defined by the Licensing Act 2003
- 3. Staff training records to be maintained recording training in relation to the Licensing Act 2003 and must cover section 144 of the Act, Keeping of Smuggled Goods on Licensed Premises. These records to incorporate authorisation for staff to sell alcohol. These records to be made available for inspection on request of a police constable or representative of a responsible authority as defined by the Licensing Act 2003.

General

4. Alcohol will be stored behind the counter and will only be sold with the assistance of staff.

Appendix C

Relevant Sections of Secretary of State Guidance – Under Section 182 of Licensing Act 2003

Crime and disorder

- 2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).
- 2.2 In the exercise of their functions, licensing authorities should seek to co-operate with the Security Industry Authority ("SIA") as far as possible and consider adding relevant conditions to licences where appropriate. The SIA also plays an important role in preventing crime and disorder by ensuring that door supervisors are properly licensed and, in partnership with police and other agencies, that security companies are not being used as fronts for serious and organised criminal activity. This may include making specific enquiries or visiting premises through intelligence led operations in conjunction with the police, local authorities and other partner agencies. Similarly, the provision of requirements for door supervision may be appropriate to ensure that people who are drunk, drug dealers or people carrying firearms do not enter the premises and ensuring that the police are kept informed.
- 2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in licensed premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.
- 2.4 The inclusion of radio links and ring-round phone systems should be considered an appropriate condition for public houses, bars and nightclubs operating in city and town centre leisure areas with a high density of licensed premises. These systems allow managers of licensed premises to communicate instantly with the police and facilitate a rapid response to any disorder which may be endangering the customers and staff on the premises.
- 2.5 Conditions relating to the management competency of designated premises supervisors should not normally be attached to premises licences. It will normally be the responsibility of the premises licence holder as an employer, and not the licensing authority, to ensure that the managers appointed at the premises are competent and appropriately trained. The designated premises supervisor is the key person who will usually be responsible for the day to day management of the premises by the premises licence holder, including the prevention of disorder. A condition of this kind may only be justified as appropriate in rare circumstances where it can be demonstrated that, in the circumstances associated with particular

premises, poor management competency could give rise to issues of crime and disorder and public safety.

2.6 The prevention of crime includes the prevention of immigration crime including the prevention of illegal working in licensed premises. Licensing authorities should work with Home Office Immigration Enforcement, as well as the police, in respect of these matters. Licence conditions that are considered appropriate for the prevention of illegal working in licensed premises might include requiring a premises licence holder to undertake right to work checks on all staff employed at the licensed premises or requiring that a copy of any document checked as part of a right to work check are retained at the licensed premises.

Public safety

2.7 Licence holders have a responsibility to ensure the safety of those using their premises,

as a part of their duties under the 2003 Act. This concerns the safety of people using the

relevant premises rather than public health which is addressed in other legislation. Physical safety includes the prevention of accidents and injuries and other immediate

harms that can result from alcohol consumption such as unconsciousness or alcohol poisoning. Conditions relating to public safety may also promote the crime and disorder

objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be

the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene.

2.8 A number of matters should be considered in relation to public safety. These may include:

- · Fire safety;
- Ensuring appropriate access for emergency services such as ambulances;
- Good communication with local authorities and emergency services, for example communications networks with the police and signing up for local incident alerts (see paragraph 2.4 above);
- Ensuring the presence of trained first aiders on the premises and appropriate first aid

kits;

- Ensuring the safety of people when leaving the premises (for example, through the provision of information on late-night transportation);
- Ensuring appropriate and frequent waste disposal, particularly of glass bottles;
- Ensuring appropriate limits on the maximum capacity of the premises (see paragraphs 2.12-2.13, and Chapter 10; and
- Considering the use of CCTV in and around the premises (as noted in paragraph
 2.3

above, this may also assist with promoting the crime and disorder objective).

- 2.9 The measures that are appropriate to promote public safety will vary between premises
- and the matters listed above may not apply in all cases. As set out in Chapter 8 (8.38-
- 8.46), applicants should consider when making their application which steps it is appropriate to take to promote the public safety objective and demonstrate how they achieve that
