## Relevant Considerations: Impact

The Panel note that the impact assessment was undertaken but would request that the stage 2 assessment should be published along with the decision. The Panel further notes that the Public Sector Equality duty is met and recognises the means testing element of the charging and

the enhanced offer to all service users from the move to a digital system.

#### Consultation

With regard to consultation, the Panel note that the Coproduction Board had been approached in relation to the changes. It is noted that the change in provision is not substantial and will not result in the removal of any elements that are currently provided.

As part of the delivery of the service the Panel encourage ongoing engagement with service users and carers to deliver the digital offer.

#### **Options**

The Panel are satisfied that the alternative funding streams had been considered and are content that the means tested model offers the fairest way of funding provision.
