1. Executive Summary

1.1 The purpose of this report is to inform Members of an application for the Grant of a premises licence. Initially 4 representations and a petition opposing the application have been received, in addition, a total of 146 representations in support of the application have been received and an online petition supporting the application was created which gained over 1500 signatures in support. The application is therefore referred to this Panel for determination.

2. Information required to take a decision.

2.1 Application

2.1.1 An application for the grant of a Premises Licence for Oi Dumplings, 9 Peel Street, Marsden, Huddersfield HD7 6BR was received on 14th May 2024. A copy of this application and a plan of the premises can be seen at **Appendix A**

2.1.2 The licensable activities applied for are:

The retail sale of alcohol for consumption on the premises, every day from 10am until 11pm

2.1.3 During the consultation period, a total of 4 representations were received in respect of this application. All 4 representations are from members of the public. A petition opposing the grant of the licence has also been received. However, after the consultation period ended, one of the representations was withdrawn. In total 141 emails have also been received along with 5 letters, all from members of the public supporting the application. The applicant also set up an online petition on change.org inviting comments of support. At the end of the consultation period, there were over 1500 supporters.

2.1.4 The representations received consider the following licensing objectives would not be met should this licence be granted:

- The Prevention of Crime and Disorder
- The Prevention of Public Nuisance

A copy of the representations may be seen at **Appendix B** and correspondence supporting the application can be seen at **Appendix C**

2.1.5 Since 2007, the premises has been a food establishment. Initially as an ice cream parlour and latterly a diner. The premises has never been licensed. The Council's planning department have confirmed that there are planning restrictions on the opening hours at the premises. Currently the trading times are restricted to 08:30am to 6pm Monday to Saturday and 12 noon until 5pm on Sundays. The applicant has indicated that they will seek to have these timings amended with

planning in due course. Despite the current restrictions, there is no reason why the application cannot be determined by the panel today.

2.2 Licensing Policy

Members considering the application should take note of the Authority's Statement of Licensing Policy, which provides the following guidance on how Members should approach the application and representation(s):

1.0 – Executive Summary

1.2 In exercising its duties and responsibilities under the terms of the Licensing Act 2003, the Council will operate within the statement and procedures mentioned in this policy statement. Notwithstanding this statement, all applications will be treated on their own merits and judged accordingly.

The council will have regard to any relevant guidance issued by the Secretary of State in exercising its powers under the Act.

2.4 The Licensing Authority will carry out its functions under the Licensing Act 2003 with a view to promoting the four licensing objectives contained in the Act and each has equal weight.

- The Prevention of Crime and Disorder
- The Prevention of Public Nuisance

2.13 The Licensing Authority recognises that each licence application must be considered on its own individual merits in the context of the four licensing objectives, and that unless relevant representations are received from responsible authority's or interested parties, there is no provision for a Licensing Authority to impose conditions on a licence other than those proposed within an application. Only conditions which have been volunteered by the applicant or which have been determined at a Licensing Panel hearing can be attached to a licence or certificate. If an application is lawfully made and no relevant representations are made in respect of an application, the Licensing Authority is under a duty to grant the licence on the terms sought. Only if relevant representations are made will the Council's discretion be engaged.

2.3 Secretary of State Guidance

Members also need to consider the statutory guidance issued, by the Secretary of State, under Section 182 of the Licensing Act 2003. As the representations related to 2 of the licensing objectives, member's attention is drawn to Section 2 of this guidance, which can be seen at **Appendix D**.

3. **Implications for the Council**

3.1 **Working with People**

Residents of Kirklees need to be confident that under the Licensing Act 2003 licence holders under the Licensing Act 2003 are in a position to uphold the four licensing objectives. The committee is required to take appropriate and necessary action against

licence holders where they fall short of their duties under the Licensing Act 2003. This will support both the licensing objectives and support the corporate outcomes of citizens in Kirklees living in cohesive communities, feeling safe and protected from harm.

3.2 Working with Partners

The Council's licensing team work closely with partnering agencies, named 'Responsible Authorities' under the Licensing Act 2003. Responsible authorities include Planning, West Yorkshire Police, Trading Standards, Environmental Health, Fire Service, and Safeguarding Children team.

3.3 Place Based Working

Working closely with Responsible Authorities the Licensing Authority can address issues within the districts that make up Kirklees.

3.4 Climate Change and Air Quality

There are no climate change or air quality implications in this report.

3.5 Improving outcomes for children

A key objective of the Licensing Act is the protection of children from harm and any decision made by the Council, in its capacity as the Licensing Authority, will have regard to this objective.

3.6 Financial Implications

There are no financial implications in relation to this report.

3.7 Legal Implications

In determining the application Members should have regard to the Authority's licensing policy statement and the Secretary of States Guidance. The applicant or any other person who made relevant representations in relation to the application have a right of appeal to the Magistrates Court.

3.8 Other (eg Risk, Integrated Impact Assessment or Human Resources)

Under the provisions of the Licensing Act 2003 there is no requirement for an IIA, while licence conditions should not duplicate other statutory provisions, members should be mindful of requirements and responsibilities placed on them by other legislation, which may include:

- Regulators' Code under the Legislative and Regulatory Reform Act 2006

4 Consultation

4.1 Consultation has taken place in accordance with the requirements set out in the Licensing Act 2003. 4 Representations have been received as detailed above. No representations were received from the responsible authorities. 1 email from a ward Councillor was received that supported the application.

5 Engagement

5.1 Engagement is not a requirement as set out in the Licensing Act 2003.

6 Options

6.1 Options considered

Members of the Panel are requested to determine the application.

6.2 Reasons for recommended option

7.3 In arriving at a decision Members must have regard to the relevant provisions of the statutory guidance and the licensing policy statement and reasons must be given for any departure.

Cafe Oi, formerly Mario's Diner, operates as a brunch cafe from morning until afternoon and transitions into a restaurant in the evening. The service of alcohol is strictly limited to patrons consuming it alongside meals, reflecting the family-friendly ethos of the diner. The ground floor includes a main dining and bar area. The bar is equipped with two beer pumps and ample storage, supporting a vibrant dining space that features full-height windows, creating a bright and welcoming atmosphere. Additional facilities on this level include a fully equipped kitchen, storage areas, and a toilet. Access and egress are facilitated through a street entrance and a back entrance, which also serves as an emergency escape route. The first floor includes additional dining space where alcohol will also be served. This level also hosts an office and storage space, and features a low-level roof area. Both floors are designed without raised floors or lifts, ensuring accessibility for all patrons. The ceiling height across both floors is maintained at 3 meters, enhancing the open feel of the diner. Comprehensive safety measures, including clearly marked escape routes and emergency exits, are integral to the design, ensuring a safe environment for patrons.

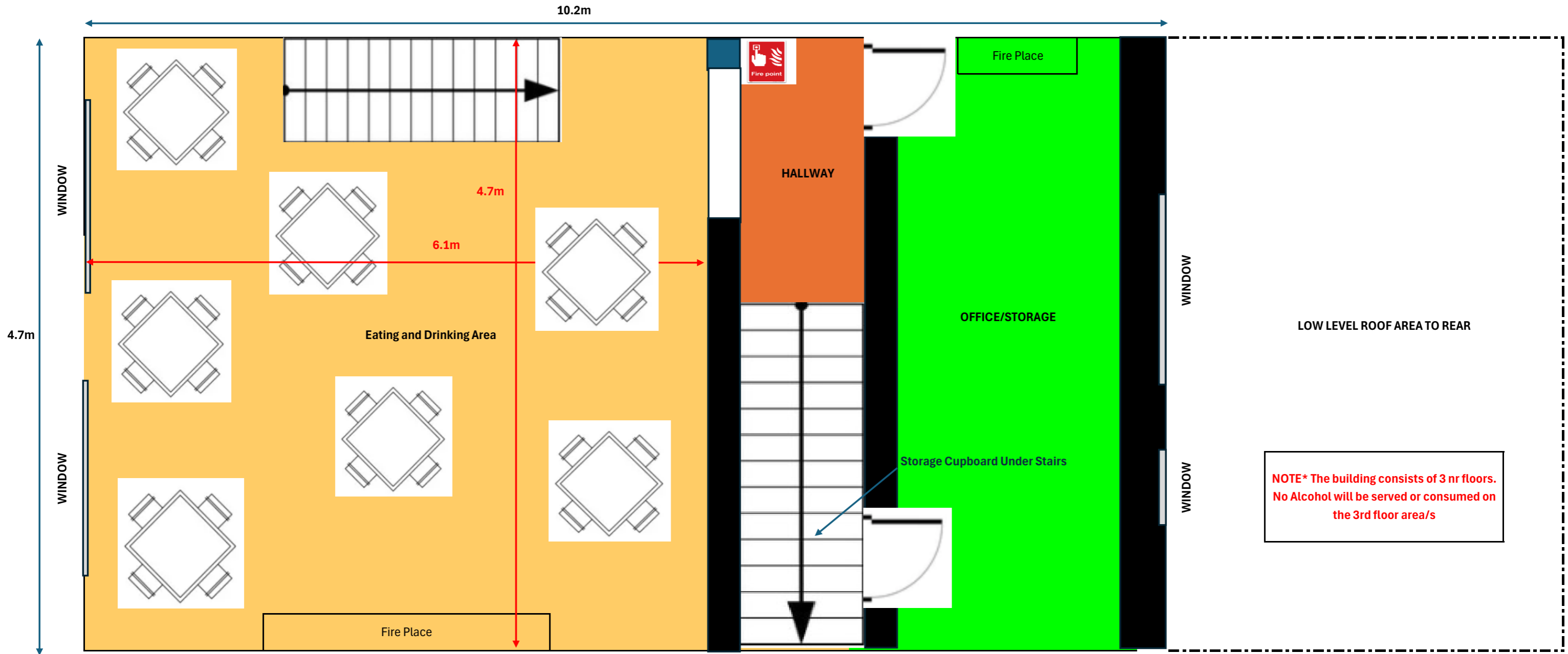

I object to the License on the following grounds.

- 1) Granting the alcohol license will create more noise than the current use as a café. The use of alcohol makes people more liable to make noise as they become intoxicated. This will significantly effect my way of life through excessive noise disturbance. When planning permission was granted for the change of use to a café a condition for restriction of opening hours to 6pm was imposed which is at odds with the applicants request for 11pm
- 2) [REDACTED]. During summer no doubt these will be left open for ventilation increasing direct sound transmission. [REDACTED]
- 3) Any chairs and tables on the pavement will make the situation considerably worse causing additional noise disturbance and smokers fumes coming in through my windows.
- 4) There are many alcohol Licences already in what is a small village centre and as a community we have suffered from the Ale Trail . I enclose a map showing the other close licensed premises. Adding to this will cause further community wide disturbance and loss of amenity. The river head tap is the main source of noise and disturbance in the village and the proposals close vicinity will further add to noise pollution and contribute to potential unrest.

In conclusion [REDACTED] many of the other commercial premises on Peel street have residential accommodation above. An additional Alcohol License will cause an increase in public nuisance and add to the social disorder associated with a concentration of bars in the area causing loss of amenity to the existing residents. Marsden is a small place and the Ale trail already leads to considerable problems in public disorder. Another licence will only exasperate this. We enclose a petition of objection to the granting of the alcohol licence from local people we have canvased.

It should also be noted that local long established pubs and clubs find it economically difficult too sustain business already and a further dilution of trade will cause hardship.

I also believe there are planning issues which are relevant to the licensing application. I enclose a letter I have forward to the Authority which address these

To Whom it May Concern

RE: Application for an alcohol licence for Oi Cafe, 9 Peel Street, Marsden HD7 6BR.

I am writing to oppose the application for this alcohol licence. Nobody has approached me asking me to do so. I was made aware of the issue due to an appeal on Facebook, by the owners of Oi Cafe, in favour of their business. This was a direct personal appeal and many people have signed, wishing to support the owners, but I wonder if they are aware of the longer-term consequences.

I have prior experience of this issue. Before I moved to Marsden I lived in a community that came to be dominated by alcohol retailing. Businesses which started as cafes were given a licence for 'quiet drinks' or drinks with a meal. Management or ownership changed over time, but the alcohol licence remained. A few years later we had yet another bar. Over time the bars got bigger and catered more towards loud and excessive drinking. The business model proved too persuasive to resist, even for owners who set out to run quiet cafes. In Marsden we recently had a pub extension and the interior has been styled more sensationally.

While alcohol licences are good for the business model of alcohol retailers, they have negative effects on the standards of public life. These effects come to displace the quiet cafe atmosphere which all residents could enjoy.

Business owners invariably advance arguments suggesting that their particular alcohol license will be a blessing for the community. We hear about 'lively atmosphere' and 'people enjoying themselves' etc. While we all want to see civilized cafes thriving there are no effective controls to keep a business within such limits. If there were effective controls, legal or planning, which could protect a civilized

cafe atmosphere I would have no need to write this objection. As evidenced by the state of our town centres there are no such controls in this country. The density of alcohol licences in an area is the greatest predictor of a charged and volatile atmosphere.

To give an idea of how bad this gets, I once sat in a meeting where community members met with representatives of the alcohol industry. We raised the problem of public urination and vomiting and they shrugged. Our streets had been transformed for their profit, yet they felt no responsibility and there remains nothing to hold them to account. There exist no effective constraints - planning, legal or otherwise - which can be used to keep UK drinking patterns to those we admire on the continent. In this country, once alcohol gets in, there is nothing to prevent alcohol taking over. And once an area has become a known destination for an evening of drinking there are no measures that can reverse the damage.

Every town centre in the UK is now dominated by the effects of drinking. Marsden is vulnerable because of the Ale Trail which creates a particular atmosphere in our village. Groups of people come to Marsden as part of a pub crawl. There is shouting in the street and vomit in residents' gardens. I know of residents who will not go to the village centre on a weekend evening because they no longer feel at ease. No quiet cafe will be visited by them because they stay at home. The 'quiet cafe' will find its customers are those who are passing - those who have come to be part of the charged atmosphere. Their demographic is anything but diverse. Such customers create business opportunities resulting in more applications to sell alcohol. The atmosphere becomes more raucous. And so it ratchets up. Town centres have got to the point where there are police and ambulances on hand and pubs have bouncers because of frequent trouble. What is already happening in the real world is far from what was written on the original planning applications.

The problem with each individual licence is the cumulative effect towards decline. Because of the Ale Trail and other factors Marsden is already on this trajectory. There is already a 'new normal' where residents who don't enjoy a rowdy evening feel unwelcome. Each successful application increases the 'pull' of the area, which increases the market, which encourages other applications. Businesses thinking of setting up as cafes are aware of the opportunities and profits that alcohol presents. Each licence results in slimmer grounds for objection to the next because what was once a diverse community has become an entertainment zone.

Thankfully there is still a diverse pattern of land use in Marsden village centre. There are homes in the centre of the village where people are able to bring up children and live normal lives. I assume they are alarmed by every new alcohol license and wonder how long a normal life will be possible. The current diversity of land use needs cherishing and protecting, using whatever legal and planning measures have any leverage.

In future please do not allow any alcohol licences or any extensions of alcohol retailing establishments in Marsden. The license application stage is the only chance we get of gatekeeping the process and safeguarding what we have.

By reimagining the space at 9 Peel Street and its usage, the new owners can contribute to the post-Covid economic trend of making Marsden an even more attractive destination for visitors and locals alike, reinvigorating the community's sense of pride and ownership, and fostering a stronger sense of community. This clearly aligns with the role and function of 'districts' as set out in the Kirklees Local Plan Strategy (Policy LP13): *"Be the local focus for basic financial services, food and drink, entertainment, leisure and tourist facilities, and health services"*.

The Kirklees Local Plan Strategy (2019) identifies the need for centres to:

- "...be appropriate in scale, help to retain an existing centre's market share, and enhance the experience of those visiting the centre..."

and further that,

- "... provide a mix of uses to serve the local community, businesses and visitors to the district. The uses shall complement each another whilst retaining a strong retail core. Centres in Kirklees shall aim to provide a range of uses to support the daytime and evening economy"

The new ownership of this property at the heart of Marsden village centre presents the opportunity to continue the trend of revitalising the area's character, injecting fresh energy and ideas into the mix of existing shops, cafes, and services. Plans include food service, cookery classes, and a co-working space, all offerings which comparable businesses in the village also offer (e.g.: Peel Street Social, Sass). This business is primarily a café and social space, as opposed to a public house or bar (of which Marsden has several, largely operating without incident), and the provision of alcohol is intended to be complimentary to food served.

Both Peel Street Social and Sass have extended licenses for the sale of alcohol with no detrimental impact on the community. Both businesses are juvenile, a fresh approach

to the hub of Marsden village, and they have proved enormously popular not only with the community in the village, but with others travelling from surrounding towns and villages to bolster the Marsden economy. Importantly, I am unaware of any negative impact on the four licensing objectives: the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm. Should the decision be taken not to grant extended opening and / or an alcohol license to the new owners at this address, I believe that it would significantly limit the business model and offering to the village. I am also aware that there are other businesses on the high street that have alcohol licences and are open later, therefore struggle to see how granting such licences to Oi would negatively impact residents on the high street.

The more thriving businesses there are in a town/village centre, the more footfall the village will receive which in turn benefits the local community. People living outside of the area (such as myself) are more likely to visit Marsden when there are multiple cafes/restaurants etc to visit than if there were only 1 or 2 options.

In the current economy, it would be such a shame to deny a small business the opportunity to grow within the community that they first found their feet, simply due to the unreasonable objections of the few.

I hope that the right decision will be made.

The business model at cafe Oi I'm sure does not reflect to be in anyway promoting binge drinking or anti-social behaviour and from what I know does not serve drinks till particularly late in retrospect to other business nearby. As a predominantly food-based business operating with quite a niche market I fear that their longevity in the village may be compromised if they are not granted an alcohol licence and you will be faced with yet another empty property on the high street. Many of my old customers would often attend Bistro 11 for a quiet glass of wine to enjoy as part of a good quality meal away from the hustle and bustle of the noisier larger establishments. I would also point out that my former workplace was based on a quiet residential street with neighbours on most sides and received 0 noise or licensing problems in contrast to the position of Oi Cafe surrounded by other bars pubs and restaurants. I believe the recent opposition made about the alcohol licence has been done out of spite rather than what's best for the local economy. I am aware they have plans to employ local people at the site and this would provide much needed employment in the area. I would also like to point out that the Marsden grown business they have created has also brought in lots of people to the area from all over the UK due to their good reputation, reviews, and large online presence. Appendix D

Relevant Sections of Secretary of State Guidance – Under Section 182 of Licensing Act 2003

Crime and disorder

2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).

2.2 In the exercise of their functions, licensing authorities should seek to co-operate with the Security Industry Authority (“SIA”) as far as possible and consider adding relevant conditions to licences where appropriate. The SIA also plays an important role in preventing crime and disorder by ensuring that door supervisors are properly licensed and, in partnership with police and other agencies, that security companies are not being used as fronts for serious and organised criminal activity. This may include making specific enquiries or visiting premises through intelligence led operations in conjunction with the police, local authorities and other partner agencies. Similarly, the provision of requirements for door supervision may be appropriate to ensure that people who are drunk, drug dealers or people carrying firearms do not enter the premises and ensuring that the police are kept informed.

2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in licensed premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.

2.4 The inclusion of radio links and ring-round phone systems should be considered an appropriate condition for public houses, bars and nightclubs operating in city and town centre leisure areas with a high density of licensed premises. These systems allow managers of licensed premises to communicate instantly with the police and facilitate a rapid response to any disorder which may be endangering the customers and staff on the premises.

2.5 Conditions relating to the management competency of designated premises supervisors should not normally be attached to premises licences. It will normally be the responsibility of the premises licence holder as an employer, and not the licensing authority, to ensure that the managers appointed at the premises are competent and appropriately trained. The designated premises supervisor is the key person who will usually be responsible for the day to day management of the premises by the premises licence holder, including the prevention of disorder. A condition of this kind may only be justified as appropriate in rare circumstances where it can be demonstrated that, in the circumstances associated with particular

premises, poor management competency could give rise to issues of crime and disorder and public safety.

2.6 The prevention of crime includes the prevention of immigration crime including the prevention of illegal working in licensed premises. Licensing authorities should work with Home Office Immigration Enforcement, as well as the police, in respect of these matters. Licence conditions that are considered appropriate for the prevention of illegal working in licensed premises might include requiring a premises licence holder to undertake right to work checks on all staff employed at the licensed premises or requiring that a copy of any document checked as part of a right to work check are retained at the licensed premises.

Public safety

2.7 Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act. This concerns the safety of people using the relevant premises rather than public health which is addressed in other legislation. Physical safety includes the prevention of accidents and injuries and other immediate harms that can result from alcohol consumption such as unconsciousness or alcohol poisoning. Conditions relating to public safety may also promote the crime and disorder objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene.

2.8 A number of matters should be considered in relation to public safety. These may include:

- Fire safety;*
- Ensuring appropriate access for emergency services such as ambulances;*
- Good communication with local authorities and emergency services, for example communications networks with the police and signing up for local incident alerts (see paragraph 2.4 above);*
- Ensuring the presence of trained first aiders on the premises and appropriate first aid kits;*
- Ensuring the safety of people when leaving the premises (for example, through the provision of information on late-night transportation);*
- Ensuring appropriate and frequent waste disposal, particularly of glass bottles;*
- Ensuring appropriate limits on the maximum capacity of the premises (see paragraphs 2.12-2.13, and Chapter 10; and*
- Considering the use of CCTV in and around the premises (as noted in paragraph 2.3 above, this may also assist with promoting the crime and disorder objective).*

2.9 The measures that are appropriate to promote public safety will vary between premises and the matters listed above may not apply in all cases. As set out in Chapter 8 (8.38-8.46), applicants should consider when making their application which steps it is appropriate to take to promote the public safety objective and demonstrate how they achieve that.

2.10 Licence holders should make provision to ensure that premises users safely leave their premises. Measures that may assist include:

- Providing information on the premises of local taxi companies who can provide safe transportation home; and
- Ensuring adequate lighting outside the premises, particularly on paths leading to and from the premises and in car parks.

2.11 Where there is a requirement in other legislation for premises open to the public or for employers to possess certificates attesting to the safety or satisfactory nature of certain equipment or fixtures on the premises, it would be inappropriate for a licensing condition to require possession of such a certificate. However, it would be permissible to require as a condition of a licence or certificate, if appropriate, checks on this equipment to be conducted at specified intervals and for evidence of these checks to be retained by the premises licence holder or club provided this does not duplicate or gold-plate a requirement in other legislation. Similarly, it would be permissible for licensing authorities, if they receive relevant representations from responsible authorities or any other persons, to attach conditions which require equipment of particular standards to be maintained on the premises. Responsible authorities – such as health and safety authorities – should therefore make their expectations clear in this respect to enable prospective licence holders or clubs to prepare effective operating schedules and club operating schedules.

2.12 “Safe capacities” should only be imposed where appropriate for the promotion of public safety or the prevention of disorder on the relevant premises. For example, if a capacity has been imposed through other legislation, it would be inappropriate to reproduce it in a premises licence. Indeed, it would also be wrong to lay down conditions which conflict with other legal requirements. However, if no safe capacity has been imposed through other legislation, a responsible authority may consider it appropriate for a new capacity to be attached to the premises which would apply at any material time when the licensable activities are taking place and make representations to that effect. For example, in certain circumstances, capacity limits may be appropriate in preventing disorder, as overcrowded venues can increase the risks of crowds becoming frustrated and hostile.

2.13 The permitted capacity is a limit on the number of persons who may be on the premises at any time, following a recommendation by the relevant fire and rescue authority under the Regulatory Reform (Fire Safety) Order 2005. For any application for a premises licence or club premises certificate for premises without an existing permitted capacity where the applicant wishes to take advantage of the special provisions set out in section 177 of the 2003 Act¹, the applicant should conduct their own risk assessment as to the appropriate capacity of the premises. They should send their recommendation to the fire and rescue authority which will consider it and decide what the “permitted capacity” of those premises should be.

2.14 Public safety may include the safety of performers appearing at any premises, but does not extend to the prevention of injury from participation in a boxing or wrestling entertainment.

Public nuisance

2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance.

2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.

2.17 Conditions relating to noise nuisance will usually concern steps appropriate to control the levels of noise emanating from premises. This might be achieved by a simple measure such as ensuring that doors and windows are kept closed after a particular time, or persons are not permitted in garden areas of the premises after a certain time. More sophisticated measures like the installation of acoustic curtains or rubber speaker mounts to mitigate sound escape from the premises may be appropriate. However, conditions in relation to live or recorded music may not be enforceable in circumstances where the entertainment activity itself is not licensable (see chapter 16). Any conditions appropriate to promote the prevention of public nuisance should be tailored to the type, nature and characteristics of the specific premises and its licensable activities. Licensing authorities should avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are expensive to purchase and install and are likely to be a considerable burden for smaller venues.

2.18 As with all conditions, those relating to noise nuisance may not be appropriate in certain circumstances where provisions in other legislation adequately protect those living in the area of the premises. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be appropriate.

2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the morning.

2.20 Measures to control light pollution will also require careful thought. Bright lighting outside premises which is considered appropriate to prevent crime and disorder may itself give rise to light pollution for some neighbours. Applicants, licensing authorities and responsible authorities will need to balance these issues.

2.21 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in anti-social behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.
