- Licensing Act 2003 Application for the Grant of Premises Licence for Stop and Shop, 293B and 293C Old Wakefield Road, Moldgreen, Huddersfield, HD5 8AG

The Panel considered a report which outlined an application for the Grant of a Premises Licence Stop and Shop, 293B and 293C Old Wakefield Road, Huddersfield, HD5 8AG.

The Licensing Officer advised the Panel that on 12th December 2024, the Licensing Department received an application for the grant of a premises licence for Stop and Shop. In response to the application four representations had been received. One from Environmental Health, one from a Ward Councillor, one from the Headteacher of a local primary school, and one from a local resident.

The submitted representations indicated that the licensing objectives in respect of the prevention of The Prevention of Crime and Disorder, Public Safety, The Prevention of Public Nuisance and The Protection of Children from Harm would not be achieved if the licence was granted.

The licensable activities applied for were as follows:

- Sale of Alcohol (Off the Premises)
- Sunday Thursday 8:00-02:00
- Friday Saturday 8:00-04:00

The agent proposed a reduction in the hours:

- Sunday Thursday 08:00-23:00
- Friday Saturday 08:00-00:00

The proposed reduction of hours was rejected by three of the four objectors as they felt that it would not alleviate their concerns relating to the licensing objectives.

The Panel invited the representative of the applicant to outline the application. The Panel was informed that the premises would be a general convenience store, which would sell a range of goods and alcohol. The applicant had entered into a 10-year lease at the property and experience of operating a similar successful business in Wakefield. The representative explained that the premises had previously been a takeaway with an alcohol licence, and no representations has been received from West Yorkshire Police.

The Panel invited representations from those who had objected to the application. One objector explained that their concerns of a late-night off-licence was due to its proximity to the local primary school. The proposal raised significant concerns regarding increased traffic, littering, and the potential for antisocial behaviour in an area frequented by young children and families. The Environmental Health Officer explained that whilst they did not object to the overall application, the concern was the proposed operating hours due to the close proximity of residential properties, as this could cause a potential noise nuisance outside the premises late at night.

Having considered all the information presented both verbally and in writing, the Panel determined as follows:

RESOLVED - That the application be approved with the following conditions.

• That the sale of alcohol (off the premises) be Sunday-Saturday 8:00-23:00.

• That litter be collected throughout the day and disposed of correctly, along with keeping a log of collections to be produced on request from responsible authorities.

1. Executive Summary

1.1 The purpose of the report is to inform members of an application for the review of a premises licence, which has been referred to this panel for determination.

2. Information required to take a decision

2.1 Application

2.1.1 On 8th January 2025 West Yorkshire Police made an application for the review of the premises licence PR(A)0399 Ten Fourteen Bar, under Section 51 of the Licensing Act 2003.

The applicant believes that the following Licensing Objectives are not being met.

- Prevention of Crime and Disorder
- Public Safety
- Prevention of Public Nuisance

2.1.2 Over the last 18 months West Yorkshire Police have stated they have received a number of reported incidents at or outside of Ten Fourteen Bar ranging from road traffic incidents, fights including individuals and large groups, serious assaults, and a section 18 wounding. All calls and incidents occurred between midnight and 3am.

2.1.3 West Yorkshire Police have provided two exhibits, **Exhibit KJS.1** which is CCTV footage and **Exhibit KJS. 2** which is an Action Plan agreed with the Designated Premises Supervisor & Licensee of Ten Fourteen Bar.

2.1.4 A local resident has made a statement to West Yorkshire Police and has provided a timeline of incidents at and outside of Ten Fourteen Bar, which includes CCTV footage. **Exhibits GW 1 – 15.**

2.1.5 Exhibits **GW 1-15** and **KJS. 1** will be shown at the hearing in private session. Under exemption clause's 2 and 7. By virtue of Paragraph(s) 1 of Part 1 of Schedule 12A of the Local Government Act 1972 and by virtue of Regulation 21 (1) (A) of the Local Authorities (Executive Arrangements) (Access to information) (England) Regulations 2000.

2.1.6 Exhibit **KJS. 2** is attached to the review report. The report, statement and exhibit can be found at **Appendix A.**

2.1.7 There has been one (1) representation submitted by Planning Services as a responsible authority following being served with the review application, this

representation provides details of the planning permission relating to the premises, whereby they provide the details of the planning conditions that relate to the public nuisance licensing objective, the representation provides no comments regarding the grounds for the application for the review. The representation can be found at **Appendix B.**

2.1.8 There have been five (5) representations submitted in support of Ten Fourteen Bar, these are three (3) from local businesses, one (1) from an employee of Ten Fourteen Bar and one (1) from a local Councillor, they can be found at **Appendix C**.

2.1.9 There have been two (2) representations submitted in support of West Yorkshire Police's review application, these are one (1) from a local resident and one (1) from a local Councillor, they can be found at **Appendix D**.

2.1.10 A copy of the Premises Licence PR(A)0399 can be found at Appendix E.

2.1.11 During the 28-day consultation period the Licensing Authority were notified that the first blue notice placed inside the premises facing the road had been removed. Following this another notice was placed on the outside of the window of the premises, and an additional notice was also placed on the lamp post outside the main door of the premises. Following this it was reported that the notice on the window had been moved and the notice placed on the lamp post was rotated which made it difficult for members of the public to read them. Licensing Officers returned a second time to ensure that the notices were visible, and an email was sent to the licence holder informing him that the Licensing Service were aware of his actions and requested that he do not touch the notices going forward.

2.2 Licensing Policy

Members considering the application must take note of the Authority's Statement of Licensing Policy, which provides the following guidance on how members should approach the application and representation(s).

Executive Summary

In exercising its duties and responsibilities under the terms of the Licensing Act 2003, the Council will operate within the statements and procedures mentioned in this policy statement. Notwithstanding this statement, all applications will be treated on their merits and judged accordingly.

The council will have regard to any relevant guidance issued by the Secretary of State in exercising its powers under the Act.

Purpose

The Licensing Authority recognises the importance of its ability to review premises licences. The proceedings set out in the 203 Act for reviewing premises licence represent a key protection concerning problems associated with crime and disorder, public safety, public nuisance, and the protection of children from harm. Partnership working is important to achieve the promotion of the licensing objectives and responsible authorities are encouraged to give licensees early warning of any concerns identified at a premise.

For cases which are being considered as a result of a review or potential enforcement action, the Council will take into account all relevant circumstances, but will view the following matters particularly seriously:

- Failure to promptly respond to a warning properly given by a responsible authority
- Failure to engage with the responsible authorities in an effective manner
- Previous convictions for licensing offences
- Previous failure to comply with licence conditions

In cases where the crime prevention objective is being undermined through the premises being used for criminal activities, such as the supply of drugs and money laundering, it is expected that revocation of the licence, even in the first instance, will be seriously considered.

Licensing Objectives

- 1. Public Safety
- 2. Prevention of Crime and Disorder
- 3. Prevention of Public Nuisance
- 4. Protection of Children from Harm

2.3 <u>Secretary of State Guidance</u>

Members also need to consider the statutory guidance issued, by the Secretary of State, under Section 182 of the Licensing Act 2003. As the representations relate to 3 of the licensing objectives. Member's attention is drawn to this guidance, the relevant parts may be found at **Appendix F.**

3. Implications for the Council

3.1 Council Plan

The Licensing Service and its Statement of Licensing Policy balance the objective of improving the local economy, improving health and wellbeing and tackling health inequalities and cultural development against noise, nuisance, safeguarding and crime and disorder.

3.2 **Financial Implications**

There are no financial implications in relation to this report.

3.3 Legal Implications

In determining the application Members should have regard to the Authority's licensing policy statement and the Secretary of State Guidance. The applicant or any other person who made relevant representations in relation to the application have the right of appeal to the Magistrates Court.

3.4 Climate Change and Air Quality

There are no climate change or air quality implications contained in this report.

- b) Exclude a licensable activity from the scope of the licence;
- c) Remove the designated premises supervisor;
- d) Suspend the licence for a period not exceeding three months;

- e) Revoke the licence.
- 7.2 Findings on any issues of fact should be on the balance of probability.

7.3 In arriving at a decision Members must have regard to the relevant provisions of the statutory guidance and the licensing policy statement and provide reasons for their decision.

This review has been called due to the breach of the following Licensing Objectives:

The prevention of crime and disorder Public safety The protection of people from harm

The ground floor and basement of Ten Fourteen is trading as a nightclub on a Saturday and Sunday morning.

In the past 18 months - Two males have been seriously injured in two road traffic collisions in the vicinity of Ten Fourteen in the early hours of the morning. In both cases the injured person had been inside Ten Fourteen prior to being involved in the road traffic collision outside.

The first road traffic collision was on the 24/6/23 and is covered in the statement and CCTV of

The second road traffic collision was in fact a Section 18 Assault. This occurred on Dunford Road on 07/12/24 where two customers of Ten Fourteen became involved in disorder outside. At the end of the altercation one of the males throws a street cone at the vehicle the other male has just got into. This vehicle then mounted the pavement and drove at the male, knocking him off his feet, causing a serious injury. CCTV footage of this incident can be produced as Exhibit KJS.1.

Ten Fourteen is on an Action Plan. This was put in place in 17/07/24 to problem solve noise and disorder occurring on Dunford Road between 1am and 3am on a Friday and Saturday morning. A local resident who has provided a statement first reported noise and disorder to Kirklees Licensing in February 2024, the statement of disorder he and his family have had to endure.

Under the current licence this venue can sell alcohol until 02:00hrs on a Saturday and Sunday Ten Fourteen is attracting high numbers of customers between 12 and 2am and can be open until 5am on New Years Day.

The Action Plan for the venue has not stopped the complaints or disorder. If the alcohol licence terminated at 11pm with the condition for the venue to be closed at midnight West Yorkshire Police believe the disorder and noise complaints would cease.

Customers before entering or after leaving standing and or walking in Dunford Road, often in drink between midnight and 3am are not only putting themselves in danger, usually when intoxicated, but also the drivers of the vehicles that are using Dunford Road.

The CCTV footage provide because shows the panel exactly what is taking place after midnight in Holmfirth. No person wants this behaviour outside there home address weekend after weekend. The venue cannot manage the drunken behaviour of their customers. If the panel does not reduce the alcohol licence to a more reasonable hour then further serious injuries are inevitable.

I am the above named person. I have lived in the vicinity of the licenced premises called Ten Fourteen, 10-14 Dunford Road, Holmfirth, HD9 2DP since May 2022.

When we moved in my wife and I expected to hear some noise from the licenced premises near to our home and accepted this as a trade-off for living so close to Holmfirth Town centre. I did enquire about any noise issues with the previous owner of my property, but they did not divulge anything. We did move into the address just as the UK was getting back to normal after Covid. I realised now that Ten Fourteen would not have been trading at full capacity in the two years prior to me moving in.

My wife and I were happy to hear the vibrant nighttime economy trading into the evening and did not think the noise would affect us or our teenage daughters. What we did not realise was the extend of noise, anti-social behaviour and disorder we would have to endure after midnight on a weekend because of Ten Fourteen having a late alcohol licence.

On moving in we soon realised that from midnight until at least 2.30am (often later) every Saturday and Sunday morning we would have to listen to shouting, screaming, laughing, fighting and car engines revving. We tried to live with this noise but after time it really started to affect the quality of life for me and my family. Every weekend we were having broken sleep and if we ever looked out of the window to see what the noise was, we would often have to witness aggressive anti-social behaviour or even worse fights. Our daughters are 16 so have had to endure broken night's sleep throughout there GCSE's and my wife is a Associate Ambulance Practitioner and often has to go to work for 6am on hardly any sleep.

The first serious incident occurred a year after we moved in. The date was the 24/06/23 it was after 2am. My wife and I had been kept awake by the noise of customers entering and leaving Ten Fourteen. My wife decided to go to Ten Fourteen to speak to the manager to ask them to do something about it. Whilst she was inside speaking to staff, she told me that a door supervisor came into the venue to say a male had just been knocked over by a car on Dunford Road. My wife went outside and administered first aid to this male who had serious injuries and had to be taken to hospital. My CCTV captured the accident. It shows a male in drink walking down the middle of Dunford Road, a vehicle turning into Dunford Road at speed from the direction of Holmfirth. The vehicle knocks down the male who is wearing dark clothing. The male that was knocked down was the son of the landlady of and I was told he had just left Ten Fourteen prior to the accident.

There are no traffic calming measures on Dunford Road and since living in the vicinity I have come to realise that the 30mph speed limit is not always adhered to. This is especially concerning to me when most Saturday and Sunday morning customers of Ten Fourteen can be seen stood or walking in the road in drink.

Feeling helpless about the situation I attended a Community Council Meeting at the beginning of 2024. This was after a very disturbed Christmas. At this meeting I was advised to inform the local authorities about my concerns. I emailed Kirklees Council Licensing and Noise and Pollution Team.

As a result of this email t contacted me and asked me to keep her updated with any disorderly behaviour and excessive noise occurring directly outside Ten Fourteen

Below are details of incidents I have sent to in e-mail form. The date of my first email to throughout 2024. It is text taken from the e-mails I have sent to throughout 2024. I took no pleasure in sending these e-mails and you will see that at one point for my own mental health I had to stop e-mailing and even put my house on the market.

I do not want to see Ten Fourteen close; it is a good business in a vibrant economic community. They cannot control the behaviour of their customers after midnight, many of whom are intoxicated. The location of the venue on a busy road in a residential area is not suitable for a late-night venue. I have sleepless nights worrying about what serious incident is going to happen next and I live in fear that a fatal incident will happen. For the safety of all involved the alcohol licence needs to be changed.

Saturday 27/01/24 - At 2:22am the noise level starts to increase. At 2:23am, a large fight breaks out in the middle of Dunford Road, and the ensuing commotion continues for another six minutes. However, people have not left the area until at least 3am. CCTV footage Exhibit GW.2

Sunday 28/01/24 - The noise picks up around 2:30am (not that it isn't noisy beforehand). A fight breaks out in front of the Shoulder of Mutton pub at this time. A scuffle breaks out in the middle of Dunford Road at 2:46am. It is around 2:52am before the noise has finally calmed down. CCTV footage **Exhibit GW.3**

Saturday 03/02/24 - Particularly around 2:22am. About 20 people congregated outside the Shoulder of Mutton beer garden being loud.

Sunday 04/02/24 - It is particularly loud around 2:35am onwards, with people not leaving until nearly 3am.

Saturday 10/2/24 – Particularly loud between 2:10am and 2:30am. Someone is shouting very loudly at 2:16am

Saturday 17/02/24 - Clear anti-social behaviour outside Ten Fourteen, spilling into the Shoulder of Mutton beer garden area. This goes on from around 2am to 2:45am. Particularly around 2:22am to 2:37am, where a fight breaks out. CCTV footage of fight Exhibit GW.4

Saturday 24/02/24 - People congregating around the outside of Ten Fourteen, being very loud. Especially from around 2:28am and particularly loud at 2:38am. It's almost 3am before everyone leaves

Sunday 25/02/24 - At 1:49am there is a ridiculous amount of screaming and shouting. At 2:27am, someone start screaming and shouting, threatening to kill someone. At 2:34am people start singing. General excessive noise continues to 3am. CCTV footage **Exhibit GW.5**

I sent a further e-mail on the 4th March 2024 documenting the below: In this e-mail I tok that I was putting my house up for sale due to the noise, trouble and issues.

Saturday 02/03/24 - It is quiet from 2am to 2:14am. At 2:14am a small group of people leave Ten Fourteen and hang around the skip at the Shoulder of Mutton. Another group joins them. Gradually more people gather outside, and the noise starts picking up.

Saturday 02/03/24 - By 2:17am there are people loitering in the middle of Dunford Road. The shouting starts increasing. By 2:27am people have moved away from Ten Fourteen, but congregate further down Dunford Road.

Saturday 02/03/24 - At 2:25:30am there is nearly a very serious car/pedestrian collision. This is clearly due to loitering and bad driving. This is noteworthy as I have seen this play out before where the pedestrian was hit and seriously injured. CCTV footage **Exhibit GW.6**

Sunday 03/03/24 - At 2:01:45am people are screaming and shouting at the top of their voices. At 2:05am someone is sounding their car horn. The noise from people leaving Ten Fourteen at this time is generally loud. At 2:08:40am there is more loud jeering. It remains generally loud. At 2:13am someone is shouting and singing. All the while there are pockets of people loitering outside the front of Ten Fourteen. Between 2:21am and 2:25am there is more screaming and shouting. By 2:30am it has quietened down, but you can still hear someone shouting.

At no time on either day do I see any door staff from Ten Fourteen attempt to move people on. This is especially the case on Sunday morning when people are loitering outside the front of the building and around the door.

I was asked by , via email on the 11th March 2024 if things were any better outside Ten Fourteen. I sent the below information.

Saturday 09/03.24 - 02:08:50am - 2:12am - A woman is engaged in an argument. She is screaming, shouting and swearing at the top of her voice. It lasts for around 4-5 minutes. 2:17am - 2:40am - More screaming and shouting. The noise is generally loud. People are loitering more during this time. The loitering can be better seen on the South Lane camera. 2:38am - People are congregating in the middle of the road at the bottom of Dunford Road. It is about 2:55am before the area is clear.

Sunday – 10/03/24 2:14am - The general noise picks up. 2:16am - More shouting and swearing. 2:23am - More shouting and swearing, and an increase in the number of people loitering. 2:33am - 2:37am - More shouting and swearing, and people clearly loitering outside the front of Ten Fourteen. It is around 2:40am by time the area is clear.

Saturday 16/03/24 – 2:02am Someone is shouting and swearing, threatening someone else. There are people loitering at the side of the Shoulder of Mutton pub. 2:13am - There are people hanging around outside Ten Fourteen, in clear view of any staff. 2:15am - The noise, shouting and screaming picks up. There are now crowds of people outside the Shoulder of Mutton and down to the bottom of Dunford Road. This loitering goes on until around 2:45am.

Sunday 17/03/24 Two men in high visibility clothing are at the door of Ten Fourteen. These are clearly the door staff that were promised as a result of your meeting. The difference between the two nights is considerable. At 2:27am a crowd gathers, and the noise picks up, but this is soon dealt with by the door staff.

Saturday 23/03/24 - Called 999 at 1:39am. Approximately 30 people in the street - Dunford Road/Victoria Street. Appeared to be two groups chasing, shouting and screaming. One male cornered and attacked at the bottom of South Lane. All dispersed within 10 minutes, One group got into cabs. One group appeared to go back into Ten Fourteen. CCTV footage Exhibit GW.7

Email sent 30/3/24 - I was woken up at 12:45am by the noise outside, and this did quieten down somewhat after a short period, but there was a constant disruption all through the night.

From around 2:15am onwards, the sheer volume and number of people loitering in the street is nothing short of ridiculous, and at 2:21am a commotion that appeared to me to be a fight breaking out at the front of the Shoulder of Mutton pub was enough for me and it was at about this time that I called the police. I called them because I believed I was witnessing a fight breaking out, and I wasn't prepared to watch it escalate into something more sinister. I'm glad I did as the police needed to call an ambulance for someone as soon as they arrived on scene. CCTV footage **Exhibit GW.8**

Email sent 08/04/34

On Saturday 6th, at about 2:06am there is a group of people leaving Ten Fourteen who loiter there and inevitably this comes with noise and shouting. More people leave the building and hang around and this goes on until around 2:25am.

There are two Street Marshalls this time, but they don't appear to be having much luck moving people on. The Street Marshalls both leave by car at 2:32am once everyone else has left.

On Sunday 7th, Ten Fourteen appears to be mostly empty at 2am. As people leave there is some noise around 2:20am, but not much, and everyone has left the area by around 2:34am. There were no Street Marshalls this evening.

Saturday 20/4/24 2:02am - 2:06am - There is a group of people shouting and screaming ridiculously loudly. This woke me up. It can be best seen on the South Lane camera.

From 2:07am to 2:12am - There is a crowd of people building and the inevitable shouting starts. The Street Marshalls moves them on, but then people just gather outside the bottom of Dunford Road, and so the noise doesn't stop.

Saturday 04/05/24.2:15am to 2:50 am - As people leave Ten Fourteen they crowd around the front of the pub and are then moved down the road and congregate outside or ______) At times there are about 50 people there. All the while, people are shouting and screaming. It nas mostly cleared by 2:30am, but there is a group of people hanging about outside the front of the Shoulder of Mutton pub, making noise until about 2:50am.

Sunday 05/05/25 2am to 2:33am - There is a crowd of people gathered outside the front of Ten Fourteen, again - around 50 people. They are loud, screaming and shouting, and there is no attempt to move them on.

Bank Holiday Monday 06/05/34 2:13am to 2:18am - There is a small instance of people shouting loudly, but they soon move themselves along.

Saturday 11/05/24 2:02am - Two men can be seen opening the doors to a black car on Dunford Road. The bass from the music playing from the car is so powerful that it is shaking the windows of our house. We've had issues like this in the past. I understand that this isn't Ten Fourteen's problem, but it's all part of the draw of their late licence.

2:10am - The noise picks up as people start crowing outside of Ten Fourteen. There is then a steady stream of people leaving Ten Fourteen and loitering either outside the building, or by the Shoulder of Mutton parking spaces. At around 2:20am, the noise increases again. I didn't see any attempts to move people on until about 2:28am. Even then, they only move them a little further down Dunford Road. From about 2:26am, people began to crowd in the middle of the road (at the Bottom of Dunford Road). It quietens around 2:45am.

Sunday 12/05/24. At 2:11am there is some loud singing going on outside. At 2:20am there is more screaming and shouting. This is very loud and goes on until around 2:30am At 2:27am there are two door staff walking about briefly, but they don't appear to do anything, and then head back to Ten Fourteen, and the screaming and shouting carries on.

Sunday 19/05/24 At 2:07am a handful of people exit Ten Fourteen and hang around outside making a lot of noise. At 2:20am the number of people leaving Ten Fourteen and loitering increases considerably, as does the noise. This continues until around 2:27am when Ten Fourteen staff move people along, but around 10 to 15 people hang about outside and some noise continues until about 2:35am. As usual, it's been too long before any attempts are made to move people along.

Saturday 18/05/24. On and off from 2am onwards, there are people grouping outside Ten Fourteen and near the back of the Shoulder of Mutton. Especially from 2:15am onwards, it starts getting loud. The noise is unacceptable, and no one is attempting to move people along. At

2:24am there are some door staff that appear to move people along, but by this time people have already been loitering for far too long. Once again, people just continue to join an even larger crowd further down Dunford Road. Also at 2:24am, a group of people emerge from the rear door of the Shoulder of Mutton for a cigarette, then leave the area. The crowd of people at the bottom of Dunford Road starts to decrease at around 2:35am, but as late as 2:45am there are still people making too much noise.

Sunday 19/05/24 At 2:07am a handful of people exit Ten Fourteen and hang around outside making a lot of noise. At 2:20am the number of people leaving Ten Fourteen and loitering increases considerably, as does the noise. This continues until around 2:27am when Ten Fourteen staff move people along, but around 10 to 15 people hang about outside and some noise continues until about 2:35am. As usual, it's been too long before any attempts are made to move people along.

Saturday 25/5/24 From 2am to about 2:30am it is noisy, and at times extremely so. At 2:10am the police attend Ten Fourteen and at 2:14am there is a mass exodus of people leaving the building. This results in the usual rise in noise, screaming and shouting. People congregate outside Ten Fourteen and near the rear of the Shoulder of Mutton and the crowd grows to around 50 people, maybe more. CCTV footage **Exhibit GW.9**

People move down to the bottom of Dunford Road and start crowding in the middle of the road. Cars are having to manoeuvre around people on the road. The crowd also spills into the main road (Town Gate). At 2:23am a member of Ten Fourteen security makes an attempt to move a couple of the 50 or so people along, to little effect. At 2:25am the police move people along and clear the area next to Ten Fourteen. It is nearly 3am by the time the area at the bottom of Dunford Road is clear.

Sunday 26/05/24 It is relatively quiet until 2:16am, then a few more people leave and the noise increases. At 2:23am someone is screaming very loudly. People continue leaving Ten Fourteen and the anti-social noise continues until around 2:37am. Someone else starts screaming very loudly at this point. At 2:30am people started to loiter all around the front of Ten Fourteen and down the bottom of Dunford Road. It is not until around 2:37am that a couple of door staff appear to try and move the rest of the crowd away from Ten Fourteen. However, people remain outside the front of the Shoulder of Mutton until around 2:50am.

Bank Holiday Monday 27/05/24 From 2am people leave Ten Fourteen, and immediately leave the area. However, by 2:15am people have begun to loiter outside Ten Fourteen, which inevitably increases the noise. This goes on until around 2:25am, at which point the area has cleared. I don't see any door staff in the recording.

Break in recording of incidents for my welfare and to concentrate on the sale of the house.

24/10/24 - Unfortunately, things at Ten Fourteen haven't improved. We've tried to make some kind of peace with it and just 'get on with it', but Friday night/Saturday morning (18th/19th October) was particularly bad. The reason for this is that people leaving Ten Fourteen have now started going into the Shoulder of Mutton beer garden for shelter and using it like a taxi rank. demonstrate (from 2:30am), in which you can also see in the top left people urinating. There's no Street Marshalls in place and the bouncers don't seem interested in anything other than moving people out of the Ten Fourteen premises.

On Saturday 16th November at around 2:10am there was a disturbance on Dunford Road. Camera footage from my CCTV clearly shows aggressive behaviour, unacceptable noise and the potential for harm and injury as people spill out all over the road. CCTV footage Exhibit GW.10

The worst of the weekend though was at 1:58am and 2:20am on Sunday 17th November.

At 1:58am, in the video Dunford Road Cam - Sun 17th, you can clearly see a couple of fights at the same time, which the bouncers try to break up. CCTV footage **Exhibit GW.11**

At around 2:26am there was another disturbance with multiple fights and anti-social behaviour. There are two videos to evidence this: Dunford Road Cam Cam - Sat 17th Nov - 2-20am and South Lane Cam - Sat 17th Nov - 2-20am. CCTV footage **Exhibit GW.12**

The South Lane footage also demonstrates how people spill into the road. The police arrived because I called them. You can't see all of the disruption because people are in the road by the wall which separates Dunford Road and South Lane.

Since I last emailed you has taken over at the Shoulder of Mutton and done an incredible job of turning things around. As my new neighbour, the disruption that she has to endure from these disturbances is even worse than that I have to put up with, as the noise will be even worse, and people jump the fence into her beer garden to urinate.

I have contacted all of you in the past, and quite frankly I am now at the end of my tether with the unreasonable behaviour that my family and I have to tolerate from patrons of Ten Fourteen. So I'd like to ask, do you think I'm being unreasonable in my complaints over the last 18 months? Is anyone addressed at the top of this email going to put an end to this behaviour? Are you waiting for someone to get killed before any action is taken, because it will happen at this rate. I'd also like someone to tell me if I'm wasting my time trying to achieve anything, because if you do, I'll stop.

I've said it before and I'll say it again - there is only one solution here, and that is to change Ten Fourteen's licence to 12am. I am correct in saying that it is unreasonable for any pub in a residential area to have a licence beyond midnight. This has a detrimental effect on our lives. We can't sleep, our children have to witness it out of their bedroom windows, and it has a negative impact on our mental health.

Saturday 23/11/24

At 2am there is a group of men at the bottom of Dunford Road (see the South Lane footage) who are screaming very loudly. At 2:11am a man and woman are having an argument. She is very loud, screaming at him for a few minutes as they walk down Dunford Road. The bouncer immediately moved them as far down the road as he could. She can be heard screaming for about 4 minutes.

At 2:13am more people leave Ten Fourteen and the noise picks up as people begin to congregate outside of the pub. The Street Marshalls appear to arrive at around 2:19am and this is the first time I've seen them. At 2:25am someone is blasting their car horn. There is further noise as people continue to leave for the next 20 minutes or so. 2:33am is the first time that I see a Street Marshall try to move people on. People then congregate at the bottom of Dunford Road, all over the road as usual. It is about 2:40am by the time the area is clear.

Sunday 24/11/24

Compared to the previous day it is relatively quiet, most likely helped by the awful weather. There is some shouting at around 2:21am and then again at 2:28am where it is considerably louder, and enough to be deemed anti-social noise.

Email sent 8/12/24 This weekend was horrendous in terms of fighting and anti-social behaviour.

Saturday 07/12/24 At around 1am a fight broke out outside Ten Fourteen. A large number of people were involved in this and the police were called. My wife went outside to film this with her phone. My wife also commented to me that neither the bouncers nor the Street Marshalls did anything to try and break this up. During this fight, someone kicks a car as it drives off and knocks themselves over doing so. CCTV footage **Exhibit GW.13**

At 2:18am the inevitable screaming and shouting starts as people leave Ten Fourteen. This happens again at 2:25am and continues until the area clears at around 2:40am.

Sunday 08/12/24 In the file Dunford Road - Sun 8th Dec - 00-20am to 00-23am, at 12:20:33am, a fight breaks out in Ten Fourteen and spills out of the front door, along with associated noise you'd expect from this. CCTV footage **Exhibit GW.14**

At 2:05am there is shouting and screaming as people leave Ten Fourteen. This continues and increases in volume, especially around 2:20am. 2:27am/2:28am the screaming is at fever pitch, and yet again, another fight breaks out. CCTV footage **Exhibit GW.15**

This action plan has been established and agreed with the premises licence holder and DPS as a voluntary means of introducing enhanced measures at the premises to achieve the promotion of the licensing objectives. The licensing objectives being:

If Street Marshalls are deployed in Holmfirth, the extra member of door staff does not need to be employed. Ten Fourteen management to liaise with Industry Security to ensure there is cover in place. Bank Holiday staffing will be at the discretion of the of Ten Fourteen management, who will risk assess it based on events at the venue and in Holmfirth.
- 3. Body cameras to be worn by 2 SIA door staff on a Friday and Saturday evening.

- A strict search policy to be put in place on a Friday and Saturday evening, metal detector wands to be used on persons between 9pm and 1:30am on a Friday, Saturday evening.
- 5. A Managers briefing to be given every Friday and Saturday to the SIA door team and a record of this kept. This Action Plan to be covered in this briefing. Street Marshalls will also be spoken to by the duty manager to ensure that they are aware of their role, which is reducing noise and anti-social behaviour on Dunford Road by.
- 6. A soft close policy will be adopted so music to be lowered at 2am and full lights to be turned on in the bar areas. There is to be a trial period of 3 months whereby the premises do not have to have all customers out of the building by 2:30am, although this must not pass 2:50am
- Signs to be placed in the venue, these will cover last entry time, smoking to the rear of the venue in the smoking area and asking customers to leave quietly.
- 8. Customers to be encouraged to smoke in smoking area at the rear of the venue.

She seeks permission for a small external drinking area to the lower ground floor and second floor areas these are both accessible by existing staircases and there fore, unfortunately, not available to wheelchair uses, the inclusion of and mechanical lift would require massive structural changes and would make the project unviable for the business, however the floor plans show ample circulation space and the design shall have clear and distinct colour and surface differences for partially sighted customers. My clients will maintain this policy throughout their tenure of the premises.

The area would offer an additional service to the local customers particularly with the change in legislation due in next year regarding smoking, the position is to the rear away from the public and residents gaze. The buildings to the surrounding area are commercially occupied and therefore operate business hours.

Holmfirth is no exception and Dunford Rd near the bottom at the junction is a central meeting hub as you have The Nook, The Shoulder Of Mutton, Lou & Joe's Burger Co, Tap House Bar & Bistro, Barhemian , Bengal Spice, Da Vincis Pizza along with 1014 Bar Restaurant.

As a security provider to most of the venues in Holmfirth one of our job's is supplying Kirklees council with street marshalling on the streets of centre of Holmfirth and with the taxi rank being at the bottom of Dunford Road this is where a que forms coming up Dunford Road as to where people stand having alcohol fuelled conversations sometimes resulting in loud noise and altercations.

The Shoulder of Mutton also has a large open beer garden which is next door to 1014 contributing to loud levels of noise, even when The Shoulder of Mutton is shut people still gather outside till early hours of the morning. 1014 from our observations is not solely responsible for Holmfirth's nighttime economy, so many people walk home using Dunford Road and Cinder Hill's Road. This will not change as there are numerous venues open late in Holmfirth contributing to people on the streets late at night. We have found intoxicated people late at night becoming very abusive toward street marshals when being ushered down Dunford Road towards the centre regularly saying to my staff they have no right to move them as it is public space.

When we have had a Police presence in Holmfirth past midnight it has had a great improvement on antisocial behaviour resulting for example Mad Friday 20-12-2024 in general the worst night of the year to which most of my Staff dread, the Police presence had a hug impact resulting in a trouble-free night. 0 incidents at 1014 with Police presence also the rest of the venues we provide security in also ran trouble free making Holmfirth a great evening out at this Festive time of the year.

Dear Sirs,

I am writing regarding the complaint about the 10 14 Bar on Dunford Road, Holmfirth.

I speak as the next door neighbor of the 10 14 bar. My family moved our photography business into these premises back in 1927 and we still run the photographic studio here. We have seen a great deal over the passed (almost) 100 years. When I was born in the 1960's my parents lived in a flat above the shop and we lived and worked here before moving out to a new home in the early 1980's. But the business has remained on Dunford Road.

I can remember the 10 14 bar when it was 70's. I also remember when, in the mid 1970's converted it into The Summer Wine Bar. Their plan was to run a Spanish/European style bar serving Sangria, and for it to have a sunny holiday kind of atmosphere. I remember their dismay when the bar filled up with heavy drinkers who weren't in the least bit interested in jugs of fruit topped Sangria. and he struggeled to keep the place trouble free. The premises have been a bar or a pub ever since, and have changed hands many times.

As neighbors of the (said) bar, we have seen many new people take over, try to give the bar a new image and to stamp their own personality on the place. My impression is that all have struggeled to move away from heavy drinkers who like a good fight after having had a skin full on a Saturday night. It seams to me that ________nd the team at 10 14 are the first people who made a determined and successful effort to smarten things up and they immediatly upgraded the property and removed the shabby run down impression that the area once had. The bottom of Dunford Rd was given a bit of glamerous sparkle. Their investment in the property improved the whole area and they constantly maintain their property and keep it looking good.

To the best of my knowleg and the 10 14 team are the first bar who have put security in place who patrol the door every weekend. I can not state loud enough how grateful we are to them for such a measure. The difference it has made to our lives is immesurable.

(I am aware that immediatly after opening there were problems, and I can't deny we were initially worried. A few years down the line though, and I can hardly believe how problems we struggled with for over 40 years have dissapeared, and the 10 14 team are valued and trusted neighbors).

A good example is the following,.....

Throughout the 1980's 90's and early 2000's there were regular drunken fights on a Friday and Saturday night at the bottom end of Dunford Rd. We knew that we had to get into work early on a Saturday morning and be prepared to clean up piles of vomit and broken glass, not only outside our own premises but all the way down Dunford Rd and passed The Shoulder of Mutton.

If either myself or my parents didn't go out with buckets of hot soapy water then the vomit and the broken glass would stay there untill it had either washed away with rain or the street cleaner had been around. The pubs and bars never took responsibility for it, apparently it was never anything to do with them!

But unfortunatly we were trying to run a high quality portrait studio and we couldn't tollerate our customers having to walk their children up Dunford Rd for their portraits whilst avoiding piles of vomit and a lot of smashed glass. So we had to clean it up.

And if we occasionally didn't deal with it no one else did.

I think we put up with this revolting situation for over 30 years.

Recently, There have been very rare occasions (from memory, maybe 4 times over a year long period) when there has been vomit in our doorway, but when the 10 14 cleaning staff come in on a morning before we've tackled it, they will always deal with it immediatly. Without being asked to do so they clean it up before starting on their own cleaning, as good neighbours would.

Vomit and broken glass was only one of the problems we used to have regarding unacceptable drunken behavour. Our large plate-glass display window regulaly got in the way of a drunken fight. It got broken so often, and was such a large expense that at one time our insurers stopped covering it. This caused us a great deal of anxiety because we could never afford such a large needless expense. It was always the family holiday or something else significant that had to be sacrifised to pay for it.

We once had two years on the trot that our display window was smashed on either Christmas Eve or New Years Eve. My dad then (for a long number of years) felt compelled to spend both his Christmas and New Years Eve on the premises. He sat in the doorway keeping his eye on 'revellers' and the 'fun and games' outside on the pavement. Determined not to allow such needless vandalism to happen to us again he sacrifised his Christmases and kept our window safe. Not at all the festive happy time that you would wish for. I could weep now, thinking about how sad it was for mum and dad and how these troubles spoilt their lives.

It feels like a luxury to us now, knowing that we can lock the door on a weekend and go home without worrying about expensive drunken damage. I can't say how much I appreciate 10 14's security staff keeping law and order outside their premises, and this has proved to protect our premises too.

Another issue we used to have....for a long number of years we couldn't find a way to stop blokes who were drinking in the bar, from coming outside to pee in our doorway. Dad even went in there once to check that they did have a functional toilet room and yes they did have. But the side of our building and our number 18 doorway was the piss hole of choice.

So, along with washing away all the vomit and broken glass from the pavement, all the way down to the bottom of Dunford Road, we also had to thoroughly wash and disinfect our own doorway. We decided to try and sort the situation out by turning what was a rarely used doorway into a small display window. We applied to Kirklees planning for 'Change of use' from a public urinal to a display window! This proved to have limited success with the urine situation but we were happy with the new window.

By far the worst thing that ever happened was one Friday night in the run up to Christmas when dad was working late to get his Christmas orders finished. Dad walked into the reception area to find a drunken man peeing up against our glass entrance door. Dad challenged him to stop but the man burst inside and procedded to beat dad around the head and left him almost sensless.

When I got into work on the Saturday morning I found dad in a terrible state. He was in shock, He was bleeding, his face was now swollen up like a big balloon and he was black and blue. I called for the police who came immediatly.

Before taking dad to casualty to get him checked over and cuts on his face and head sewn up, the police interviewed him and we took photos, but nothing was ever found out about it. No one admitted to having seen or heard anything.

I really can't imagine such a dreadful incident happening today. 10 14's security would have stopped that man from peeing over our door long before he lost control of himself and started beating up my dear dad.

This incident almost cost us our business as we seriously questioned "what the hell are we doing here". But our love of Holmfirth and a sense that we didn't really know where else we could go kept us from moving away. And for better or worse we are still here.

Remembering all the awful incidents and the revolting state that Dunford Road used to be in saddens me greatly. How I wish my dad lived to enjoy this safer time. Things are very different now and it feels like a long time since we were constantly washing down the street and living in fear of our window being smashed. It is amazing how quickly you come to accept a new situation as being normal, but it actually hasn't been long at all. I think maybe only 6 years? Yet up until now I've lived with those troubles all my working life.

It is such a luxury to lock up and go home on a Friday and Saturday and not feel worried about mindless drunken damage. It is an absolute luxury not to having to start and end each week by washing vomit off of Dunford Rd.

I do not take for granted that 10 14 pay for security men working on their doors on a weekend and that we benefit from their efforts. I know for a fact that the incident when my dad got beaten up would NEVER have happened today with those men keeping a careful eye on things. Never would such a dreadful incident happen today with no one admitting to knowing anything about it. I am very grateful.

There is no longer broken glass all the way down the pavement into Holmfirth like there was before 10 14 opened. Our door step no longer smells of urine. Those security men would never allow people to come out of the bar to relieve themselves over our property.

If ever our burgular alarm goes c hones and texts to let us know.

and his team are good helpful neighbors who keep their property looking smart and well cared for. Which makes things better for us too.

They are extreamly helpful and active members of the Holmfirth business community who readily give their time and resourses to what ever needs doing in the town.

What ever the problem might be that you are concerned about, I would dread going back to how things used to be. I would be saddened to see 10 14 loose their late licence because I know how valuable that late night business is for the bar. I also feel far safer, than we used to do, and I think that in many ways Holmfirth is a safer, nicer place too.

I hope that what ever issues you have will be worked through rather than simply taking away the bar's late licence.

At no point have I ever felt like an outsider at Ten Fourteen. Instead, I have always been treated fairly, based on my work and contribution, rather than anything else.

I have worked hard over my time here to pay back the trust and support I have received not just by fulfilling my role but by being a committed and dedicated part of the team. Ten Fourteen is more than just a bar or latenight venue; it is a place of stability, inclusivity, and genuine opportunity. It provides jobs, fosters a welcoming community, and sets an example of what true fairness and equality in the workplace should look like.

Re: Support for Late Night Licensed Nightclub Application

I am writing to express my well-considered support for the continuum of the current licensing conditions for the Ten Fourteen Venue on Dunford Road, Holmfirth.

I fully recognize the importance of balancing the vibrancy and success of our local nightlife with the need to ensure public safety and uphold community standards. I believe that the venue is committed to addressing key issues such as crime prevention, public safety, nuisance reduction, and the protection of children.

In 1997 I was sworn in as a Constable with the West Yorkshire Police and was stationed at Holmfirth Police Station.

At this time the town had a reputation for large scale disorder with much of the late night being unregulated and with significant drug abuse and misuse.

On weekends 2 marked police cars would monitor the town centre, (EA9 and EA14 Units), often backup would be called from Lockwood Police Station (EA8). This was because of a lack of effective licensing and regulation.

As a result of one disorder, I was badly assaulted on duty, with head injuries comprising of concussion and extensive tooth damage.

On the 4th December 2024, I made a personal visit to Ten Fourteen and held a meeting with the Manager, Deputy Manager, Bar Manager and Security Manager. Having been a victim of crime and former Police Officer I was interested to ask what safety measures were in place. (A post of this visit can be seen on Facebook 'Cllr Damian Brook').

Prevention of Crime and Disorder

The management team of demonstrated a thorough understanding of the need to prevent crime and disorder through their comprehensive security measures.

These include employing fully trained and licensed security personnel, implementing a strict IDchecking system, 'Wanding' otherwise known as metal detecting for knives and sharps, a zero tolerance for drug misuse and utilizing CCTV surveillance throughout the venue.

Staff and the venue hosted outside-training conducted by 'purple Dog Training', this training covered a wide range of High-Risk scenarios and first aid responding including (BLS) Basic Life Support and Trauma management.

Ten Fourteen is also part of the local Pub Watch network and supports national initiatives such as 'Ask Angela' and 'Ask Clive'.

Additionally, the venue has committed to working closely with local police to address any emerging issues and promote a safe, enjoyable environment for all patrons.

Public Safety

The safety of patrons is a priority for Ten Fourteen interior design incorporates clear signage, effective crowd management strategies, and accessibility measures to ensure that everyone can move safely within the premises. Additionally, the venue has planned for well-maintained emergency exits and fire safety protocols that meet or exceed all legal requirements. Furthermore, the late-night release of customers is carefully managed and considered to minimize congestion, groups gathering and allow staff to oversee patrons' safe departure to Taxi's.

Prevention of Public Nuisance

Ten Fourteen is committed to minimizing any potential disturbances to the surrounding area. Premises noise levels are carefully controlled through soundproofing measures and noise monitoring, with the louder music venue in the basement '1014 Basement Bar'.

The venue implements both last entry time and slow-release policy to ensure that customers leave in an orderly manner and find adequate transport options for patrons to return home safely.

The staggered dispersal strategies would be assisted further by better regulation of Taxi's within the centre of Holmfirth. I have made a request to ' ' the architects for the proposed 1.4 million pounds investment into Towngate, asking that the bus terminus is

repurposed for Taxi's after bus services end, to better support the nighttime economy in the centre of Holmfirth which would also in turn minimise groups contributing to public nuisance.

Taxi issues have been reported by residents, a central Taxi rank would service all the licensed premises, and the Towngate Development could accommodate this with little or no extra cost advocating better regulation and enforcement. This would add significantly to road safety by moving late night revellers/pedestrians to the covered bus stands on the planned precinct/bus gate.

Protection of Children from Harm

Protecting children from harm is of utmost importance. The venue has stringent age verification procedures in place and will strictly prohibit entry to anyone under the legal age for alcohol consumption. Staff are trained in identifying potential risks and taking appropriate action to ensure that underage individuals are not permitted to enter or remain on the premises.

In conclusion, I believe that Ten Fourteen is a positive addition to our community, Holmfirth has always had a vibrant late-night community, and this should be a safe, controlled, and enjoyable environment for adults to socialize and unwind. The venue is committed to improving and adapting necessary safeguards, the venue has shown its ongoing commitment to addressing key concerns such as crime, safety, nuisance, and the protection of children.

I respectfully request that the Licensing Committee work with the Managers of Ten Fourteen as a late-night venue promote, support and encourage the safe management of Holmfirth's latenight economy.

I would also urge West Yorkshire Police to consider adding appropriate resources, in support of Holmfirth's licensed premises. Our nighttime economy has grown significantly as more and more revellers travel from Huddersfield and surrounding towns.

I am writing to express my strong support for the review of the premise licence for Ten Fourteen Bar.

My wife and I have lived on South Lane for eight years, and over the past 18 months, the disruption caused by this establishment has become intolerable. The levels of noise and antisocial behaviour as patrons leave the bar in the early hours-particularly between 2am and 3am-are deeply distressing. Despite living in a house set back from the road and having recently installed new triple-glazed windows, we are still unable to block out the disturbances that occur on a weekly basis.

Beyond the noise, there is an increasing sense of unease and intimidation in the area. Large groups often congregate around Dunford Road, creating an unpleasant and sometimes volatile atmosphere. The disturbances reported by our neighbour at seriousness of the issue. As a direct result, we now avoid being out late in our own neighbourhood, ensuring we return home by 10pm to steer clear of the escalating problems outside Ten Fourteen.

The situation has become so unbearable that we have seriously considered moving house, despite having no previous desire to leave the area. It is completely unacceptable that residents should feel driven out of their homes due to the impact of one business operating such late hours. This is a residential area, and it is entirely unreasonable for local residents to have their quality of life so severely disrupted.

I strongly urge the licensing committee to reduce Ten Fourteen's licensing hours to a more appropriate and respectful time in line with the nature of this community.

I would like to take the opportunity to register my support for the submission to reduce Ten Fourteen's alcohol licence to 11pm, and the request that all customers leave the premises by 12.00. This submission is being brought by the Police, and I support their request. I have arrived at this conclusion due to residents bringing forward their concerns, and also video footage that I have seen.

The Ten Fourteen bar is close to the centre of Holmfirth, however with Holmfirth not being a large town, it is also in a residential area (Dunford Road/South Lane). The night time economy in Holmfirth is thriving and there are lots of bars in the town. To the best of my knowledge however Ten Fourteen is the only bar that is serving drinks until 2am and it seems to be the place to go to carry on drinking when all the other bars have closed. I have several concerns but primarily I'm concerned about Public Safety. I have seen footage of groups of young people in the middle of Dunford road with cars having to swerve to avoid hitting them. There is also resident's evidence and video footage of fights taking place outside Ten Fourteen.

There are also the issues of Public Nuisance and Disorder. Residents have complained to me about antisocial behaviour, with disturbances due to people screaming and shouting as they make their way from Ten Fourteen. These disturbances are taking place around 2am - 3am. A lot of the people leaving the bar at 2am are also affected by alcohol which is exacerbating the situation. Some of the residents have told me that they feel scared to come home late at night at the weekend in case there is anti-social behaviour.

In conclusion I think that having an 11pm alcohol licence at Ten Fourteen will be positive for the local community and it will contribute to public safety.

 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

Appendix F

<u>Relevant Sections of Secretary of State Guidance – Under Section 182 of</u> <u>Licensing Act 2003</u>

Crime and disorder

2.1 Licensing authorities should look to the police as the main source of advice on crime and disorder. They should also seek to involve the local Community Safety Partnership (CSP).

2.2 In the exercise of their functions, licensing authorities should seek to co-operate with the Security Industry Authority ("SIA") as far as possible and consider adding relevant conditions to licences where appropriate. The SIA also plays an important role in preventing crime and disorder by ensuring that door supervisors are properly licensed and, in partnership with police and other agencies, that security companies are not being used as fronts for serious and organised criminal activity. This may include making specific enquiries or visiting premises through intelligence led operations in conjunction with the police, local authorities and other partner agencies. Similarly, the provision of requirements for door supervision may be appropriate to ensure that people who are drunk, drug dealers or people carrying firearms do not enter the premises and ensuring that the police are kept informed.

2.3 Conditions should be targeted on deterrence and preventing crime and disorder including the prevention of illegal working in licensed premises (see paragraph 10.10). For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television (CCTV) cameras both inside and immediately outside the premises can actively deter disorder, nuisance, anti-social behaviour and crime generally. Some licence holders may wish to have cameras on their premises for the prevention of crime directed against the business itself, its staff, or its customers. But any condition may require a broader approach, and it may be appropriate to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.

2.4 The inclusion of radio links and ring-round phone systems should be considered an appropriate condition for public houses, bars and nightclubs operating in city and town centre leisure areas with a high density of licensed premises. These systems allow managers of licensed premises to communicate instantly with the police and facilitate a rapid response to any disorder which may be endangering the customers and staff on the premises.

2.5 Conditions relating to the management competency of designated premises supervisors should not normally be attached to premises licences. It will normally be the responsibility of the premises licence holder as an employer, and not the licensing authority, to ensure that the managers appointed at the premises are competent and appropriately trained. The designated premises supervisor is the key person who will usually be responsible for the day to day management of the premises by the premises licence holder, including the prevention of disorder. A condition of this kind may only be justified as appropriate in rare circumstances where it can be demonstrated that, in the circumstances associated with particular premises, poor management competency could give rise to issues of crime and disorder and public safety.

2.6 The prevention of crime includes the prevention of immigration crime including the prevention of illegal working in licensed premises. Licensing authorities should work with Home Office Immigration Enforcement, as well as the police, in respect of these matters. Licence conditions that are considered appropriate for the prevention of illegal working in licensed premises might include requiring a premises licence holder to undertake right to work checks on all staff employed at the licensed premises or requiring that a copy of any document checked as part of a right to work check are retained at the licensed premises.

Public safety

2.7 Licence holders have a responsibility to ensure the safety of those using their premises, as a part of their duties under the 2003 Act. This concerns the safety of people using the relevant premises rather than public health which is addressed in other legislation. Physical safety includes the prevention of accidents and injuries and other immediate harms that can result from alcohol consumption such as unconsciousness or alcohol poisoning. Conditions relating to public safety may also promote the crime and disorder objective as noted above. There will of course be occasions when a public safety condition could incidentally benefit a person's health more generally, but it should not be the purpose of the condition as this would be outside the licensing authority's powers (be ultra vires) under the 2003 Act. Conditions should not be imposed on a premises licence or club premises certificate which relate to cleanliness or hygiene.

2.8 A number of matters should be considered in relation to public safety. These may include:

Fire safety;

Ensuring appropriate access for emergency services such as ambulances;

• Good communication with local authorities and emergency services, for example communications networks with the police and signing up for local incident alerts (see paragraph 2.4 above);

• Ensuring the presence of trained first aiders on the premises and appropriate first aid kits;

• Ensuring the safety of people when leaving the premises (for example, through the provision of information on late-night transportation);

Ensuring appropriate and frequent waste disposal, particularly of glass bottles;
Ensuring appropriate limits on the maximum capacity of the premises (see paragraphs 2.12-2.13, and Chapter 10; and

• Considering the use of CCTV in and around the premises (as noted in paragraph 2.3 above, this may also assist with promoting the crime and disorder objective).

2.9 The measures that are appropriate to promote public safety will vary between premises and the matters listed above may not apply in all cases. As set out in Chapter 8 (8.38-8.46), applicants should consider when making their application which steps it is appropriate to take to promote the public safety objective and demonstrate how they achieve that.

Public nuisance

2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance.

2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.

2.17 Conditions relating to noise nuisance will usually concern steps appropriate to control the levels of noise emanating from premises. This might be achieved by a simple measure such as ensuring that doors and windows are kept closed after a particular time, or persons are not permitted in garden areas of the premises after a certain time. More sophisticated measures like the installation of acoustic curtains or rubber speaker mounts to mitigate sound escape from the premises may be appropriate. However, conditions in relation to live or recorded music may not be enforceable in circumstances where the entertainment activity itself is not licensable (see chapter 16). Any conditions appropriate to promote the prevention of public nuisance should be tailored to the type, nature and characteristics of the specific premises and its licensable activities. Licensing authorities should avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are expensive to purchase and install and are likely to be a considerable burden for smaller venues.

2.18 As with all conditions, those relating to noise nuisance may not be appropriate in certain circumstances where provisions in other legislation adequately protect those living in the area of the premises. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be appropriate.

2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the morning.

2.20 Measures to control light pollution will also require careful thought. Bright lighting outside premises which is considered appropriate to prevent crime and

disorder may itself give rise to light pollution for some neighbours. Applicants, licensing authorities and responsible authorities will need to balance these issues.

2.21 Beyond the immediate area surrounding the premises, these are matters for the personal responsibility of individuals under the law. An individual who engages in anti-social behaviour is accountable in their own right. However, it would be perfectly reasonable for a licensing authority to impose a condition, following relevant representations, that requires the licence holder or club to place signs at the exits from the building encouraging patrons to be quiet until they leave the area, or that, if they wish to smoke, to do so at designated places on the premises instead of outside, and to respect the rights of people living nearby to a peaceful night.
