"I have recently had an issue with a Denby Dale Ward Resident who was advised that their Landrover Defender 90 was restricted to 12 visits per year to Bromley Farm Tip. This is a short wheel based landrover with a much lower load carrying capacity than a long wheel base defender 110. I am aware of these being permitted unrestricted access to the site.

When I raised this with the officers I was advised:

"There are many different types of Land Rover Defenders. The Council uses the DVLA website to help distinguish if the vehicle is a 'goods' vehicle (Category N1). In general terms, if there are clear windows which can be opened and seats with seat belts, it is likely to be classed as being registered for a car permit. If the back of the vehicle does not have windows (or if they are blacked out and cannot be opened) and there is a bench in the back which doesn't have seat belts then this is a classed at a 'goods' vehicle by the DVLA and hence is classed as being registered for a large vehicle in the Council's HWRC permit system and is only allowed to visit the HWRC 12 times a year. "

Is it correct that in assessing whether a vehicle is a "large vehicle" for the purposes of access to Refuse sites the size of the vehicle is not the defining criteria?"
