#### **ANNEX 1 - MANDATORY CONDITIONS**

No supply of alcohol may be made under the premises licence:

(a) at a time when there is no Designated Premises Supervisor (DPS) in respect of the premises, or

(b) at a time when the DPS does not hold a personal licence or his/her personal licence is suspended

Every sale/supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

#### ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

The times the premises licence authorises the sale by retail of alcohol do not prohibit:

(a) during the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;(b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;(c) the sale of alcohol to a trader or club for the purposes of the trade or club;(d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

Alcohol shall not be sold in an open container or be consumed in the licensed premises.
