1. Introduction

- 1.1. My name is Mrs Pauline Goldsbrough. My address is 44 Sunny Heys, Meltham, Holmfirth HD9 5PD
 - 1.2. I am retired.
 - 1.3. I have prepared this proof of evidence in support of the Objectors to the Order. I do not personally know the Objectors but have known of the Bradley family since being very young.
 - 1.4. I intend to attend the public inquiry into whether the Order should be confirmed, which I understand from the Objectors is due to commence on 29 January 2019.
 - 1.5. The facts and matters set out in this Proof of Evidence are within my own knowledge unless otherwise stated, and I believe them to be true. Where I refer to information supplied by others, the source of the information is identified. Any facts and matters derived from other sources are true to the best of my knowledge and belief.

1.6. Where I refer to documents within this Proof of Evidence, these are to documents taken from the Objectors' document list. Unless stated otherwise, a reference to a page number within this Proof of Evidence is to the corresponding page of the Objectors' document list (e.g. **OBJ/1**).

2. Evidence

- 2.1. I have not used the Order Route very often, maybe about 5 or 6 times (but always with permission from a member of the Bradley family). I would only have used the Order Route if I was late for an appointment.
- 2.2. I would always ask permission from a member of the family if they were in the yard, if not I would knock on the door.
- 2.3. I have occasionally seen walkers using the Order Route but I do not know if they would have asked for permission to do so.
- 2.4. I do not remember any dates that such persons would have been using the order route.
- 2.5. In my times of using the Order Route I encountered a metal pole across the track at Point D on the Plan at OBJ/1, but I never found it necessary to turn back unless the cows were in the yard because I am not over keen on cows.
- 2.6. I have never been asked by the Bradley family or anyone who worked for them not to use the Order Route; I was always granted permission to go through. I may have been asked to wait while they secured the cows, but they never refused.
- 2.7. I lived at Delves Cottage from the age of 1 year old. I was always told by my dad that we had to ask for permission to use the Order Route, not just me but also my dad my brother and my sister, and my sister would tell you the same if she were still alive.

I believe that the facts stated in this Proof of Evidence are true.
