"Our Prime Minister has stated that the world is at 1 minute to midnight, yet the final agreed statement from COP26 shows that the world is not on target to reduce emissions sufficiently to avoid potential global climate disasters.

Does the Cabinet now agree that as governments can no longer be relied upon to find solutions to the Climate Emergency, the time has come for the Council to stand up and take a major lead on Climate Change rather than tinkering at the edges?

If so, could they suggest bold innovative moves that could set an example to the rest of the country and give hope to our young people that a safer future is possible?"

"Please can you tell me why the Council will not provide a litter bin in Lepton at Green Balk Lane by the church?"

"We heard last week that the expansion works at King James's School are behind schedule due to delays in supply of building materials. Please can you tell me when you now anticipate the works to be completed?"

Question by Councillor Munro to the Cabinet Member for Culture and Greener Kirklees (Councillor Simpson)

"I was notified recently that £153m of funding has been made available through the cultural investment fund for museums and galleries. Please can you tell me if the Council has applied for a share of this funding to upgrade Tolson Museum buildings and its facilities?"

Cabinet received the following oral questions;

Question from Councillor Bolt;

"With respect to involvement in planning, did Councillor McBride think that that extended to the Leader of the Council and then Deputy Leader of the Council when he said in an email trail to people of Cleckheaton that the Leader and (former) Deputy Leader, Councillor McBride, asked for publicity for a sensitive planning issue to be withheld until after the elections. Is that interfering with the planning process?"

Question from Councillor Sheard;

"I went around Oakwell Hall this morning speaking to the team that work there and run the park. The one thing that came up was about the environment and how the park was going to become environmentally friendly. I'd like to ask Cabinet how they plan to support Oakwell Hall and the team there because they've stated that due to a lack of funding they are unable to put the environmental plan into action. Can the Cabinet commit to allocating sufficient funding to the park and will they give sufficient support to help the team?"

Question from Councillor Marchington;

"The agenda for vesterday's Cabinet meeting was over 8cm, that was made available to us eight days ago and its exceptionally difficult to read and digest all of the information we might want to do. There's a particular interest for those of us in South Kirklees about the Huddersfield Gateway. In light of other comments we've had about the move towards the Committee system, about making information available to all of us as soon as possible. It is exceptionally difficult for us to read the papers and we've had a number of call ins in the past and requests for the information to be made available to enable us to comment on and affect and shape the decision making of this Council. The request is, as Leader of the Council, can you ensure that relevant members of this Council and ideally all members of this Council, get access to the same information that Cabinet Members are privy to and that Members of this Council be briefed in the same way that Cabinet Members are to enable us to either scrutinise or comment on key decisions of this Council? I reference back to Cabinet yesterday, a big chunk of that was the Cooper Bridge call-in, widely recognised cross party as being an excellent piece of scrutiny, but it would have been much better if the scrutiny could have taken place before the decision had to be referred back to Cabinet and it would have been a better use of time if that input could have been made beforehand. Can we have relevant information at the same time as Cabinet Members get it?"
