Ward Work

I am particularly pleased and proud of the improvements to the bungalows on Brighton Street and the refurbishment of the Community Centre. This has taken 3 years to achieve but the bungalows now have a better layout and the boilers have been replaced, the flat roofs are no longer, each now having a pitched roof with insulation and all the bungalows now have proper ramped access to allow residents with mobility problems, wheelchairs or electric scooters to be able to get in and out of their homes in a safe manner. The last part of the works is due to start soon; that is the relaying of the footpaths which are uneven and in a poor state. Hopefully this should be the first winter where residents of the bungalows will not be troubled with leaking roofs!

I have continued to deal with cases for local residents and groups of residents, covering a wide range of issues, including planning issues, public rights of way, benefits, domestic violence, grants and funding, housing repairs, road safety, education, crime and anti-social behaviour, neighbour disputes etc. I receive referrals from people when they see me, out and about in Heckmondwike, from standing at a market stall, by telephone, email, referral from Mike Wood MP, other Councillors, various organisations, Council officers etc.

I have represented the views of residents at 2 Planning Sub-Committees.

I have supported several local groups in getting funding for events and developments.

I was pleased to attend several events to celebrate the Queen's Jubilee in the ward and attended the re-opening of the Brighton Street Community Centre and am really pleased with the increasing number of events, meetings and celebrations now taking place in the centre, which I try to support and attend.

I have held meetings with groups of residents who were concerned about local issues.

For the last part of the year I have done much less casework because of family health issues. During 2012/13 I have dealt with 147 cases for local residents.
