Throughout that time the council has been out to her on a number of occasions to deal with a number of faults with her bungalow, including mould. She now has a 2 year old child, mould is still growing, plug sockets hang out of the walls and she has to use her bathroom to get cold water because her kitchen tap does not work. She has given up on report issues like this to the council because nothing is getting done.

On the back of the tragic death of a 2 year old in Rochdale as a result of mould. What is the Cabinet doing to prevent another case like it taking place in Kirklees and ensuring people in this position are provided with suitable accommodation that they deserve?"
