TITLE OF PAPER: Kirklees Health and Care Partnership Health and Care Plan

# 1. Purpose of paper

The Kirklees Health and Care Plan outlines the collective action the Kirklees Health and Care Partnership will take over the next five years. The plan supports delivery of the Kirklees Health and Wellbeing Strategy, with specific reference to the connected care and support priority.

## 2. Background

The refreshed Kirklees Health and Wellbeing Strategy identifies three priorities

- Healthy Places
- Mental Wellbeing
- Connected Care and Support

A decision was taken to develop a Health and Care Plan which will outline how the Kirklees Place Based Partnership will deliver on these priorities, focussing primarily on Connected Care and Support but recognising the cross over with Mental Wellbeing and Healthy Places.

The West Yorkshire Health and Care Partnership have also refreshed the Integrated Care Strategy and are in the process of developing a Joint Forward Plan to outline how the strategy will be delivered. The Health and Care Plan will support delivery of the West Yorkshire Integrated Care Strategy alongside the Joint Forward Plan. To ensure alignment and that there is the opportunity to influence its development, the timescales for the Health and Care Plan have been run in parallel with those of the Joint Forward Plan.

A group was established to lead on the development of the plan, with representatives from across the Partnership. The principles adopted by the Group were that the process will be inclusive and will build upon the work already in progress.

The strategic priorities within the Health and Care Plan bring partners together to connect care under a number of strategic themes, which span the life course, (starting well, living well and ageing well). Mental wellbeing and palliative and end of life care will be considered as a golden thread within each of the themes.

The Plan also identifies 4 priority actions, which have been considered through a number of lenses, where they are applicable;

- 1. Improving access
- 2. Holistic approach to out of hospital care
- 3. Crisis response
- 4. Workforce

The Health and Care Plan is intended to be a 'live' document. Some areas of the plan are still under discussion and we are yet to agree the changes we will make as a Partnership. For these areas the narrative be updated in future revisions, as it is developed. For year one of the Plan, this applies to the following areas:

- Starting well
- Living well

The Kirklees Health and Care Plan was signed off by the ICB Committee on the 10th May 2023.

The version of the plan included in the papers is intended for use by the Partnership. We are in the process of developing additional versions which are accessible and public facing (plain English). We will also create a summary slide deck which will be shared with Partners for use in presentations.
