

## Councillors' Allowances

### Basic Allowance

The amount allocated per annum to each elected councillor for ward duties is £16,211

### Special Responsibility Allowances (SRAs)

A special responsibility allowance (SRA) is paid to some councillors:

- Cabinet members, including the leader and deputy leader of the council
- Chairs and lead members of overview and scrutiny committees and panels
- Group leaders and group business managers
- Chairs of certain committees

Councillors may hold more than one role that qualifies, but are only eligible to receive one special responsibility allowance.
