#### 1. Executive Summary

1.1 This report is to provide members of the Licensing and Safety Committee with an update on the activities undertaken by the Council's licensing services between the period of 1<sup>st</sup> October 2023 to 31<sup>st</sup> March 2024.

## 2. Information required to take a decision

## **Hackney Carriage and Private Hire Licensing**

2.1 The overriding aim of the licensing service, when carrying out its functions relating to the licensing of hackney carriage and private hire drivers, vehicle proprietors and operators is the safety of the travelling public and others who use (or can be affected by) hackney carriage and private hire services.

## **Current Licence Numbers**

2.2 The number of current hackney carriage and private hire licenses in forces as of 21<sup>st</sup> October 2024 are set out in the table below: -





#### **Restricted Licences**

- 2.10 On Wednesday 17<sup>th</sup> April 2024, the Head of Public Protection and the Chair of the Licensing and Safety Committee, considered a report under delegated authority in relation to a new process/procedure to issue a licence to drivers which is restricted to carrying out school contract work, but will not be permitted to carry out normal / everyday hackney carriage or private hire work.
- 2.11 It was recommended that the Head of Public Protection and the Chair of the Licensing and Safety committee, in line with delegated authority from the Licensing and Safety Committee to make minor amendments to Licensing Policy, to relax aspects of the new driver application requirements, and agree amended conditions to reflect the restrictions on the licence to carry out school transport contract work only.
- 2.12 The decision taken by the Head of Public Protection and the Chair of the Licensing and Safety Committee was to agree the proposed new licence type and amendments to policy / process.
- 2.13 The introduction of a restricted licence is to work with local and national companies who want to undertake school contracts only or want to expand into this area of work. It should be noted that any requirements related to safeguarding have not been relaxed.

- 2.18 In the period between 1<sup>st</sup> October 2023 and 31<sup>st</sup> March 2024, the service received a total of 2,934 applications. In the previous 6-month period between 1<sup>st</sup> April 2023 and 30<sup>th</sup> September 2023 the service received a total of 3,057 applications.

#### Alcohol Toolkit

- 2.19 In 2016, Public Health England developed and piloted an Analytical Software Package (ASP) to aid public health teams in their role as a responsible authority, with support from the Home Office and the Department of Health, versions of this ASP are used by local authorities in Cornwall, Wigan, Leeds, and Somerset. Public health colleagues in Kirklees have reviewed this ASP and other local authority variants and, with the support of the Licensing service, have developed a toolkit specifically tailored for Kirklees.
- 2.20 The Kirklees toolkit is designed as a straightforward one-stop resource with links to various data sources to provide supportive evidence linked to alcohol related harm, and the results from the tool can be used as part of representations to licensing applications and will assist members with decision making at hearings.
- 2.21 The toolkit is now available on the Council's website and training will be offered to members in due course.

## Business and Planning Act 2020 as amended by the Levelling Up and Regeneration Act 2023

- 2.22 On Tuesday 2<sup>nd</sup> April 2024, all Local Authorities in England received a letter from the Department for Levelling Up, Housing and Communities. This was to inform licensing authorities that on 31<sup>st</sup> March 2024 the pavement licensing provisions laid out in the Levelling up and Regeneration Act 2023 had commenced. This is a permanent replacement for both the temporary provisions introduced by the Business and Planning Act 2020 and the former provisions under the Highways Act 1980.
- 2.23 In order to comply with the requirements decisions were required to be taken regarding the conditions which would be attached to the licences. These decisions were taken under delegated authority by the Strategic Director for Corporate Strategy, Commissioning and Public Health. The reason this was not brought to members of the Licensing and Safety Committee for a decision was due to the timing of the introduction of the new law which came into effect without prior notice and the need for the decisions to be taken without delay.
- 2.24 The agreed conditions can be seen at **Appendix 1.**

## West Yorkshire Joint Services – Trading Standards

2.25 The licensing team and the co-located licensing police officers work closely with Trading Standards. Visits to premises are conducted when intelligence has been gathered by Trading Standards.

- 2.26 While not every premises that is visited is licenced, it is important to note that trading standards work in partnership with the licensing service and the police and where required enforcement action is taken.
- 2.27 On 10<sup>th</sup> October 2023, four premises in South Kirklees were visited:
  - Premises 1 Nothing was found
  - Premises 2 The search of the premises found182 x 20 packets of cigarettes, 20 x 50g pouches of hand rolling tobacco and 88 oversized vapes.
  - Premises 3 The search of the premises found 178 x 20 packets of cigarettes, 24 x 50g pouches of hand rolling tobacco and 95 oversized vapes.
  - Premises 4 The search of the premises found 211 x 20 packets of cigarettes, 42 x 50g pouches of hand rolling tobacco and 38 oversized vapes.
- 2.28 On 23<sup>rd</sup> October 2023, three premises in North Kirklees were visited:
  - Premises 1 The search of the premises found 55 x 20 packets of cigarettes, 4 x 50g pouches of hand rolling tobacco and 50 oversized vapes.
  - Premises 2 Nothing was found.
  - Premises 3 Nothing was found.
- 2.29 On 6<sup>th</sup> February 2024, four premises in North Kirklees were visited:
  - Premises 1 The search of the premises found 65 x 20 packets of cigarettes, 7 x 50g pouches of hand rolling tobacco, 130 oversized vapes and 30 pouches of shisha tobacco.
  - Premises 2 The search of the premises found 240 x 20 packets of cigarettes, 52 x 50g pouches of hand rolling tobacco, 129 oversized vapes and 11 pouches of shisha tobacco.
  - Premises 3 The search of the premises found 2,449 packets of tobacco,155 x 50g pouches of hand rolling tobacco and 2 oversized vapes.
  - Premises 4 The search of the premises found 235 x 20 packets of cigarettes and 22 x 50g pouches of hand rolling tobacco.

#### The Licensing Service Enforcement Activity

- 2.30 Licensing Officers undertake proactive enforcement activity outside normal working hours. This can vary from, licensed vehicle checks, licensed operator base checks, licensed driver checks, premises licence compliance checks, gambling licence compliance checks and so on.
- 2.31 Between 1<sup>st</sup> October 2023 and 31<sup>st</sup> March 2024 officers carried out 17 proactive enforcement operations including evenings/weekends which is an average of 3 per month. The following table provides a brief overview of the enforcement activities undertaken in the 6-month period.

## Pavement Café Licence Conditions

# Business and Planning Act 2020 as amended by S229 of & Schedule 22 to the Levelling Up and Regeneration Act 2023

- 1. Outside drinking to be restricted to the area covered by the pavement licence.
- 2. Tables, chairs and other furniture covered by this licence must be removed from the highway, and securely stored, outside of the times stated on the licence. Securely stored means off the highway and away from any area accessible by the public.
- 3. Sufficient management controls and monitoring should be in place for the collection of glasses, bottles, plates etc. at regular intervals, removal of discarded food wrappers etc. to prevent litter from blowing onto the adjacent highway, including regular sweeping of the area throughout the trading day.
- 4. At the end of each trading period following the removal of the tables, chairs and other furniture covered by this licence, you must ensure the area covered by this licence, and the area in the immediate vicinity (i.e. to the side and/or front) are clear of any waste/debris.
- 5. Any spillages onto the Highway must be cleaned immediately, the tables and chairs to be kept tidy, at all times.
- 6. The premises shall be responsible for the cost of making good any damage to the highway caused by street furniture or usage area.
- 7. Music must <u>not</u> be played outside the premises at any time. Additionally, windows and doors should not be kept open to facilitate the passage of sound to customers using the external tables and chairs.
- 8. Sufficient controls should be in place to manage any incidents of disorder.
- 9. Clear routes of access along the highway must be maintained, taking into account the needs of disabled people, and the recommended minimum footways widths and distances required for access by mobility impaired and visually impaired people as set out in section 3 of the <u>Inclusive Mobility</u>. A <u>Guide to Best Practice on Access to Pedestrian and Transport Infrastructure (publishing.service.gov.uk)</u> guidance.
- 10. During the hours of operation, the pavement café area authorised by this licence must remain enclosed with adequate openings to permit access. The function of this enclosure is to demarcate and contain the café but also to give a clear warning particularly to people with visual impairments.
- 11. Reasonable provisions need to be made for seating where smoking is not permitted. This means that where businesses provide for smokers, they are also required to provide an option for customers to sit in a non-smoking area.
  - There should be clear 'smoking' and non-smoking' areas, with 'no-smoking' signage displayed in your designated 'smoke-free' zones in accordance with the smoke-free (signs Regulations) 2012.

- No ash trays or similar receptacles to be provided or permitted to be left on furniture where smoke-free seating is identified.
- You should provide a minimum 2m distance between non-smoking and smoking areas, wherever possible.
- 12. You must temporarily remove your tables, chairs and any other furniture authorised by this licence upon the request of a statutory undertaker (i.e. utility / communications companies) to allow them to access their equipment / services, or an authorised officer of the Council or West Yorkshire Police. Where possible you will be given prior notice of this.
- 13. You are required to carry out a health and safety risk assessment to take reasonable steps to mitigate the risks identified. This risk assessment shall be made available to authorised officers of the Council or West Yorkshire Police upon request.
- 14. Advertisement boards and furniture that is not removable are not permitted by this pavement café licence.
- 15. You must complete a site security plan which is available inspection at any time by authorised officers of the Council, West Yorkshire Police Officers, and Counter Terrorism Officers (working with, for or on behalf of the Police).
- 16. All management and staff employed are required to undertake the online ACT Awareness Training and evidence of completion of this by management and staff should be kept with the site security plan and be available for inspection by authorised officers of the Council, West Yorkshire Police Officers, and Counter Terrorism Officers (working with, for or on behalf of the Police).
