**1. Purpose of report**

1.1 To provide members of the Calderdale and Kirklees Joint Health Scrutiny Committee with the context to the discussions with Calderdale and Greater Huddersfield Clinical Commissioning Groups (CCGs) who will provide an update on the proposals for the future provision of hospital services in Calderdale and Greater Huddersfield.

**2. Key Points**

2.1 In September 2015 Calderdale and Greater Huddersfield CCGs Governing bodies met in parallel to discuss progress to the proposals being developed to hospital changes and to consider their readiness for consultation.

- 2.2 Both Governing bodies agreed that as Calderdale and Greater Huddersfield Clinical Commissioning Groups were unable to set out the proposed future model of care, the financial implications and the preferred location of services they were not ready to proceed to consultation.
- 2.3 Since this meeting further work has been undertaken to address the outstanding issues and this has included the publication of the Pre-Consultation Business Case (PCBC) (a copy is attached to this report).
- 2.4 The PCBC outlines the case for transforming health services in Calderdale and Greater Huddersfield and describes the clinical quality and financial drivers for change and the nature of the challenging choices that are presented to commissioners.
- 2.5 On the 20 January 2016 Calderdale and Greater Huddersfield CCGs Governing Bodies met and agreed that the outstanding work identified in September 2015 had been undertaken; that the CCGs were confident that there was sufficient evidence to satisfy the requirements of the NHS England assurance process; and that CCGs were ready to proceed to consultation.
- 2.6 In light of this decision senior representatives from Calderdale and Greater Huddersfield CCGs will be in attendance to:
- Provide an update on the proposals;
  - Outline any work that is still required to be undertaken prior to consultation;
  - Present the PCBC; and
  - Provide an indication of the timeline for the consultation process.
