1. Summary

- 1.1 At the meeting held in July 2018 members of the Health and Adult Social Care Scrutiny Panel considered a new issue put forward by a member of the public requesting a review of the provision of support in Kirklees for children with Foetal Alcohol Syndrome.
- 1.2 The Panel agreed that an initial investigation into this matter should be undertaken by the Lead Member.
- 1.3 In August 2018 the Lead Member met with the Chief Officer of Greater Huddersfield Clinical Commissioning Group (CCG) and North Kirklees CCG who agreed to arrange a short brief on the position locally.
- 1.4 In September 2018 the Panel received information from the CCGs which included details of a planned study to determine the incidence of FAS in the UK and Ireland and a document "Our Forgotten Children The Urgency of Aligning Policy with Guidance on the Effects of Antenatal Exposure to Alcohol which was produced following a roundtable discussion in Parliament with Foetal Alcohol Spectrum Disorders Stakeholders
- 1.5 Following further discussions with CCGs it was agreed that the scope of discussion be widened to include: the work of Learning disability services; Child and Adolescent Mental Health Services (CAMHS) Kirklees Special Educational Needs or Disabilities (SEND) provision; and a focus on prevention.
- 1.6 Representatives from Greater Huddersfield CCG, North Kirklees CCG, Kirklees Council and the lead investigator of the UK and Ireland study of FAS will be in attendance to help inform the discussions.
- 1.7 Further information is attached including: A briefing report prepared by Greater Huddersfield CCG, North Kirklees CCG and Kirklees Council; details of the UK and Ireland FAS study; and the document Our Forgotten Children.
