Despite lobbying from the local MP, the local authority, and the school, this little boy was not able to finish his school term before the family were evicted, and they were left here with little food, no money or phone credit, and no support system.

What is the Cabinet member's view on this practice, and is she aware of any other instances where this has happened in Kirklees?"
