1. **Summary**
 - 1.1 Community services in Kirklees is focused on providing Care closer to home (CCTH) and is designed to deliver integrated, community-based healthcare services which support people to stay healthy and live independently for longer.
 - 1.2 CCTH aims to deliver more care in the community, either in patients' homes or close to where they live and work. A key aim of CCTH is to reduce the need for some people to have a stay in hospital and for those who do need hospital care to provide more support locally so they can return to their home as quickly as possible.
 - 1.3 CCTH is currently delivered by Locala on a 5 year contract with CCGs having an option to extend for up to two years. The initial five year term expires 30 September 2020. To prepare for a decision on the contract CCGs have undertaken a review of performance and have also listened to views on the future model for CCTH.
 - 1.4 Representatives from Greater Huddersfield and North Kirklees CCGs will be in attendance to present an update on the review and to outline the decisions made by the CCG Governing Body – Committees in Common.
